SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Renames Office of Emergency Management as Oregon Department of Emergency Management. Establishes department as independent state agency. [*Vests in department emergency authority regarding public health emergencies, emergency quarantines and conflagrations. Transfers rulemaking authority regarding nuclear emergencies from State Department of Energy to Oregon Department of Emergency Management.*] Directs department to carry out certain functions related to regional and statewide emergency **response and preparedness**.

Transfers Oregon Emergency Response System from Department of State Police to Oregon Department of Emergency Management, **operative July 1, 2025**.

Renames office of State Fire Marshal as Department of the State Fire Marshal and establishes department as independent state agency, **operative July 1, 2023**. [*Transfers search and rescue functions from Office of Emergency Management to department. Requires State Fire Marshal to establish guidelines for wildfire buffer zones that produce defensible spaces around lands in forestland-urban interface.*]

Transfers Oregon Homeland Security Council to Office of Governor [*and renames as Oregon Homeland Security Commission*]. Adds members to and modifies duties of commission.

Establishes Emergency Preparedness Advisory Council to [*advise and make policy recommendations to Oregon Homeland Security Commission regarding federal emergency support functions*] **facilitate policy recommendations related to catastrophic disaster. Sunsets council on January 2, 2030**.

Establishes Local Government Emergency Management Advisory Council to provide advice and recommendations to Oregon Department of Emergency Management regarding department's emergency preparedness and response functions. **Sunsets council on January 2, 2030**.

Establishes task force to make recommendations as to whether State Fire Marshal should be made independent state agency or housed within existing state agency, operative immediately. Directs task force to report recommendations by February 1, 2022.

Becomes operative on July 1, [2023] **2022, except as specified.**

Declares emergency, effective on passage.

5 **RENAMING AND REORGANIZATION OF**
6 **THE OFFICE OF EMERGENCY MANAGEMENT**
7

8 **SECTION 1.** (1) **The amendments to ORS 401.052, 401.054, 401.062, 401.072, 401.076, 401.082,**
9 **401.088 and 401.092 by sections 2 to 9 of this 2021 Act are intended to change the name of the**
10 **“Office of Emergency Management” to the “Oregon Department of Emergency**
11 **Management” and to establish that entity as a state agency independent from the Oregon**
12 **Military Department.**

13 (2) **For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel**
14 **may substitute for words designating the “Office of Emergency Management,” wherever they**
15 **occur in statutory law, other words designating the “Oregon Department of Emergency**
16 **Management.”**

17 **SECTION 2.** ORS 401.052 is amended to read:

18 401.052. (1) The [*Office*] **Oregon Department** of Emergency Management is established [*in the*
19 *Oregon Military Department*].

20 (2) The [*office*] **department** shall be responsible for:

21 (a) Coordinating and facilitating private sector and governmental efforts to prevent, prepare for,
22 respond to and recover from emergencies; and

23 (b) Coordinating exercises and training, planning, preparedness, response, mitigation and recov-
24 ery activities with state and local emergency services agencies and organizations.

25 (3) The [*office*] **department** shall prepare a statewide emergency management plan and update
26 the plan from time to time as necessary.

27 **SECTION 3.** ORS 401.054 is amended to read:

28 401.054. (1) Each of the following agencies, entities and officials shall designate an individual to
29 act as a liaison with the [*Office*] **Oregon Department** of Emergency Management:

30 (a) The Department of Consumer and Business Services;

31 (b) The Department of Corrections;

18 (2) Each agency, entity and official required to designate a liaison under this section shall des-
19 ignate an individual who has authority during an emergency to allocate resources and assets of the
20 agency, entity or official.

21 (3) Each individual designated as a liaison under subsection (1) of this section shall assist in the
22 coordination of the functions of the agency, entity or official that designated the individual that
23 relate to emergency preparedness and response with similar functions of the [Office] **Oregon De-**
24 **partment** of Emergency Management.

25 **SECTION 4.** ORS 401.062 is amended to read:

26 401.062. (1) The [Office] **Oregon Department** of Emergency Management is under the super-
27 vision and control of a director, who is responsible for the performance of the duties, functions and
28 powers of the [office] **department**.

29 (2) [The Adjutant General, with the approval of] The Governor[,] shall appoint the Director of the
30 [Office] **Oregon Department** of Emergency Management, who holds office at the pleasure of the
31 [Adjutant General.] **Governor. The appointment of the director is subject to confirmation by**
32 **the Senate in the manner prescribed by ORS 171.562 and 171.565.**

33 (3) The director shall be paid a salary as provided by law or, if not so provided, as prescribed
34 by [the Adjutant General, with the approval of] the Governor.

35 (4) For purposes of administration, subject to the approval of the [Adjutant General] **Governor,**
36 the director may organize and reorganize the [office] **department** as the director considers neces-
37 sary to properly conduct the work of the [office] **department**.

38 (5) The director may divide the functions of the [office] **department** into administrative divi-
39 sions. Subject to the approval of the [Adjutant General] **Governor,** the director may appoint an in-
40 dividual to administer each division. The administrator of each division serves at the pleasure of the
41 director and is not subject to the provisions of ORS chapter 240. Each individual appointed under
42 this subsection must be well qualified by technical training and experience in the functions to be
43 performed by the individual.

44 **SECTION 5.** ORS 401.072 is amended to read:

45 401.072. (1) The Director of the [Office] **Oregon Department** of Emergency Management may,

1 by written order filed with the Secretary of State, appoint a deputy director. The deputy director
2 serves at the pleasure of the director, has authority to act for the director in the absence of the
3 director and is subject to the control of the director at all times.

4 (2) Subject to any applicable provisions of ORS chapter 240, the director shall appoint all sub-
5 ordinate officers and employees of the [*Office of Emergency Management*] **department**, prescribe
6 their duties and fix their compensation.

7 **SECTION 6.** ORS 401.076 is amended to read:

8 401.076. In accordance with applicable provisions of ORS chapter 183, the Director of the
9 [*Office*] **Oregon Department** of Emergency Management may adopt rules necessary for the admin-

12 **SECTION 7.** ORS 401.092 is amended to read:

13 401.092. (1) The Director of the [*Office*] **Oregon Department** of Emergency Management is re-
14 sponsible for coordinating and facilitating exercises and training, emergency planning, preparedness,
15 response, mitigation and recovery activities with the state and local emergency services agencies
16 and organizations, and shall[, *with the approval of the Adjutant General or as directed by the Gover-*
17 *nor*]:

18 (a) Make rules that are necessary and proper for the administration and implementation of this
19 chapter;

20 (b) Coordinate the activities of all public and private organizations specifically related to pro-
21 viding emergency services within this state;

44 Governor's authorized representative for the purpose of initiating the fire management assistance
45 declaration process with the Federal Emergency Management Agency and administering Federal

2 **SECTION 8.** ORS 401.082 is amended to read:

3 401.082. (1) To aid and advise the Director of the [Office] **Oregon Department** of Emergency
4 Management in the performance of the functions of the [Office] **Oregon Department** of Emergency
5 Management, the director may establish such advisory and technical committees as the director
6 considers necessary. The committees may be continuing or temporary. The director shall determine
7 the representation, membership, terms and organization of the committees and shall appoint their
8 members. The director is an ex officio member of each committee.

9 (2) Members of the committees are not entitled to compensation, but in the discretion of the
10 director may be reimbursed from funds available to the [office] **department** for actual and necessary
11 travel and other expenses incurred by them in the performance of their official duties in the manner
12 and amount provided in ORS 292.495.

13 **SECTION 9.** ORS 401.088 is amended to read:

14 401.088. The Director of the [Office] **Oregon Department** of Emergency Management may enter
15 into interagency agreements with other state agencies that the director determines are necessary

20 **SECTION 10.** (1) **The unexpended balances of amounts authorized to be expended by the**
21 **Oregon Military Department for purposes of the Office of Emergency Management for the**
22 **biennium beginning July 1, 2021, from revenues dedicated, continuously appropriated, appro-**
23 **priated or otherwise made available to the department, are transferred to and are available**
24 **for expenditure by the Oregon Department of Emergency Management for the biennium be-**
25 **ginning July 1, 2021.**

26 (2) **The expenditure classifications, if any, established by Acts authorizing or limiting**
27 **expenditures by the Office of Emergency Management remain applicable to expenditures by**
28 **the Oregon Department of Emergency Management under this section.**

32 **SECTION 11.** **The amendments to ORS 401.052, 401.054, 401.062, 401.072, 401.076, 401.082,**

34 **prosecution involving or with respect to any duties, functions and powers of the Office of**
35 **Emergency Management begun before and pending as of the operative date specified in sec-**
36 **tion 155 of this 2021 Act, except that the Oregon Department of Emergency Management is**
37 **substituted for the Office of Emergency Management in any such action, proceeding or**
38 **prosecution.**

42 **SECTION 12.** (1) **Nothing in the amendments to ORS 401.052, 401.054, 401.062, 401.072,**
43 **401.076, 401.082, 401.088 and 401.092 by sections 2 to 9 of this 2021 Act relieves a person of a**
44 **liability, duty or obligation accruing under or with respect to the duties, functions and pow-**
45 **ers conferred by those statutes prior to the operative date specified in section 155 of this 2021**

1 **Act. The Oregon Department of Emergency Management may undertake the collection or**
2 **enforcement of any such liability, duty or obligation.**

3 **(2) The rights and obligations of the Office of Emergency Management legally incurred**
4 **under contracts, leases and business transactions executed, entered into or begun before the**
5 **operative date specified in section 155 of this 2021 Act are transferred to the Oregon De-**
6 **partment of Emergency Management. For the purpose of succession to these rights and ob-**
7 **ligations, the Oregon Department of Emergency Management is a continuation of the Office**
8 **of Emergency Management and not a new authority.**

12 **SECTION 13. The rules of the Office of Emergency Management in effect on the opera-**
13 **tive date specified in section 155 of this 2021 Act continue in effect until superseded or re-**
14 **pealed by rules of the Oregon Department of Emergency Management. References in rules**
15 **of the Office of Emergency Management to the Office of Emergency Management or an of-**
16 **ficer or employee of the Office of Emergency Management are considered to be references**
17 **to the Oregon Department of Emergency Management or an officer or employee of the**
18 **Oregon Department of Emergency Management.**

19 **SECTION 14. Whenever, in any statutory law or resolution of the Legislative Assembly**
20 **or in any rule, document, record or proceeding authorized by the Legislative Assembly, ref-**

28 **SECTION 15. The Director of the Office of Emergency Management on the operative date**
29 **specified in section 155 of this 2021 Act shall serve as the initial Director of the Oregon De-**
30 **partment of Emergency Management at the pleasure of the Governor and without the need**
31 **for confirmation by the Senate.**

37 **401.094. (1)(a) The Department of State Police shall maintain a system for the notification and**
38 **interagency coordination of state resources in response to emergencies involving multijurisdictional**
39 **cooperation between the various levels of government and private business entities.**

40 **(b) The department shall provide the [Office] Oregon Department of Emergency Management**
41 **with a service level agreement that describes the continued daily operations and maintenance of the**
42 **system, the services and supplies needed to maintain the system 24 hours a day, every day of the**
43 **year, and the policies and procedures that support the overall notification system.**

44 **(2) The notification system shall be managed by the [Office] Oregon Department of Emergency**
45 **Management as a continuously available communications network and a component of the state's**

1 emergency operations center.

2 (3) The notification system shall be the primary point of contact by which any public agency
3 provides the state notification of an emergency or disaster, or requests access to state and federal

17 *[(b) The department shall provide the Oregon Department of Emergency Management with a service

20 and procedures that support the overall notification system.]*

38 476.590. The State Fire Marshal, **in consultation with the Director of the Oregon Depart-
39 ment of Emergency Management**, shall prepare plans for the effective carrying out of the pro-
40 visions of ORS 476.520 to 476.610 and provide advice and counsel to the Governor for the most
41 practical utilization under ORS 476.520 to 476.610 of the fire-fighting resources of this state.

44 **(Emergency Preparedness Functions)**
45

1 the risk of serious bodily injury or death resulting from rapidly moving landslides:

2 (a) The State Department of Geology and Mineral Industries shall:

3 (A) Identify and map further review areas selected in cooperation with local governments and
4 in coordination with the State Forestry Department, and provide technical assistance to local gov-
5 ernments to facilitate the use and application of this information pursuant to subsection (1)(b) of this
6 section; and

7 (B) Provide public education regarding landslide hazards.

8 (b) The State Forestry Department shall regulate forest operations to reduce the risk of serious
9 bodily injury or death from rapidly moving landslides directly related to forest operations, and assist
10 local governments in the siting review of permanent dwellings on and adjacent to forestlands in
11 further review areas pursuant to subsection (1)(b) of this section.

12 (c) The Land Conservation and Development Commission may take steps under its existing au-
13 thority to assist local governments to appropriately apply the requirements of subsection (1)(c) of
14 this section.

15 (d) The Department of Transportation shall provide warnings to motorists during periods deter-
16 mined to be of highest risk of rapidly moving landslides along areas on state highways with a history
17 of being most vulnerable to rapidly moving landslides.

18 (e) The [Office] **Oregon Department** of Emergency Management shall coordinate state re-
19 sources for rapid and effective response to landslide-related emergencies.

20 (5) Notwithstanding any other provision of law, any state or local agency adopting rules related
21 to the risk of serious bodily injury or death from rapidly moving landslides shall do so only in con-
22 formance with the policies and provisions of ORS 195.250 to 195.260.

23 (6) No state or local agency may adopt or enact any rule or ordinance for the purpose of re-
24 ducing risk of serious bodily injury or death from rapidly moving landslides that limits the use of
25 land that is in addition to land identified as a further review area by the State Department of
26 Geology and Mineral Industries or the State Forestry Department pursuant to subsection (4) of this
27 section.

28 (7) Except as provided in ORS 527.710 or in Oregon's ocean and coastal land use planning goals,
29 no state agency may adopt criteria regulating activities for the purpose of reducing risk of serious
30 bodily injury or death from rapidly moving landslides on lands subject to the provisions of ORS
31 195.250 to 195.260 that are more restrictive than the criteria adopted by a local government pursu-
32 ant to subsection (1)(c) of this section.

8 tended to change the name of the office of the State Fire Marshal to the Department of the
9 State Fire Marshal and establish that entity as a state agency independent from the De-
10 partment of State Police.

11 (2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel
12 may substitute for words designating the “office of the State Fire Marshal,” wherever they
13 occur in statutory law, other words designating the “Department of the State Fire
14 Marshal.”

15 **SECTION 90.** ORS 476.020 is amended to read:

16 476.020. (1) The [*office of*] **Department of the** State Fire Marshal is established. [*in the De-*
17 *partment of State Police. The State Fire Marshal shall be appointed by and be administratively re-*
18 *sponsible to the Superintendent of State Police, and shall serve at the pleasure of the superintendent.*
19 *The State Fire Marshal shall retain all current authority of the office and shall be responsible for the*

- 3 (E) Automobile physical damage, eight percent.
- 4 (F) Aircraft physical damage, eight percent.

5 (2) If an insurer ceases to do business or collect premiums on direct domestic risks, it thereupon
6 shall make a report to the director of its premiums subject to taxation as provided in subsection (1)
7 of this section and collected or due as of the date when it ceased to do business or collect premiums
8 on direct domestic risks, and not theretofore reported, and shall forthwith pay to the director the
9 tax thereon.

10 (3) If the director, during the period in which the director under ORS 731.836 may collect taxes
11 owing under this section, finds the amount of such taxes paid by an insurer to have been incorrect,
12 the director shall charge or credit the insurer with the difference between the correct amount of tax
13 and the amount actually paid.

14 **SECTION 145.** ORS 735.470 is amended to read:

15 735.470. (1)(a) The surplus lines licensee shall pay the Director of the Department of Consumer
16 and Business Services a surplus lines premium tax equal to two percent of the gross amount of
17 premiums received on Oregon home state risks as shown in the report required by ORS 735.465.

18 (b) Notwithstanding ORS 731.820, the surplus lines licensee shall also pay to the director a tax
19 equal to 0.3 percent of the premium or fees charged by the insurer or the insurer's insurance pro-
20 ducer and other intermediaries for the insurance, for the purpose of maintaining the [office] **De-**
21 **partment** of the State Fire Marshal and paying the expenses incident thereto.

22 (c) The taxes shall be collected by the surplus lines licensee as specified by the director, in ad-
23 dition to the gross amount of premiums charged by the insurer or the insurer's insurance producer
24 and other intermediaries for the insurance. The taxes on any portion of the premium unearned at
25 termination of insurance having been credited by the state to the licensee shall be returned to the
26 policyholder directly by the surplus lines licensee or through the producing insurance producer, if
27 any. The surplus lines licensee is prohibited from absorbing the taxes, and from rebating for any
28 reason, any part of the taxes.

29 (2) The surplus lines taxes are due quarterly on the 45th day following the calendar quarter in
30 which the premium is collected. The taxes shall be paid to and reported on forms prescribed by the
31 director or upon the director's order paid to and reported on forms prescribed by the Surplus Line
32 Association of Oregon.

33 (3) Notwithstanding subsection (2) of this section, if a surplus lines license is terminated or
34 nonrenewed for any reason, the taxes described in this section are due on the 30th day after the
35 termination or nonrenewal.

1 401.109. (1) The Oregon Homeland Security Council is [*created*] **established** within the Office
2 of [*Emergency Management*] **the Governor. The mission of the council is to assess risks to the**
3 **safety and security of the State of Oregon with special emphasis on matters related to do-**
4 **estic terrorism and other major threats to the people of Oregon, including to critical**
5 **infrastructure, and to make formal recommendations to the Governor with respect to**

12 *401.165.*]

13 [(b) *Advise state agencies with responsibility for security matters on the future direction of the*
14 *office's planning, preparedness, response and recovery activities.*]

15 **(2) The council may:**

16 **(a) Recommend strategies to the Governor for the effective coordination of information**
17 **gathering and dissemination on subjects associated with the mission.**

18 **(b) Request and receive briefings from state agencies or other entities for development**
19 **of reports and recommendations for the Governor on subjects associated with the mission.**

20 **(c) Facilitate interagency collaboration, cooperation and coordination on operational is-**
21 **sues associated with the mission.**

22 **(d) Recommend policies to the Emergency Preparedness Advisory Council on subjects**
23 **associated with the mission.**

24 [(2)] **(3) The membership of the council consists of:**

25 **(a) Four members from the Legislative Assembly appointed as follows:**

26 **(A) Two members from the Senate appointed by the President of the Senate; and**

27 **(B) Two members from the House of Representatives appointed by the Speaker of the House of**
28 **Representatives;**

29 **(b) The Governor;**

30 **(c) The Adjutant General;**

31 **(d) The Superintendent of State Police;**

32 **(e) The Director of the [*Office*] **Oregon Department** of Emergency Management; [*and*]**

33 **(f) A representative of the Department of Justice appointed by the Attorney General[.];**

34 **(g) The State Resilience Officer;**

35 **(h) The State Fire Marshal;**

36 **(i) The Director of the Department of Public Safety Standards and Training;**

37 **(j) The Director of the Oregon Health Authority;**

38 **(k) The Director of Transportation;**

39 **(L) The State Forester;**

40 **(m) The Director of the Department of Corrections;**

41 **(n) The Superintendent of State Police;**

42 **(o) One member appointed by the Governor to act as a senior policy advisor for emer-**
43 **gency operations;**

44 **(p) A representative of the Oregon TITAN Fusion Center with the ability to organize and**
45 **explain mission critical information, appointed by the Attorney General; and**

1 **SECTION 151.** (1) The Emergency Preparedness Advisory Council is established within
2 the Office of the Governor. The mission of the council is to facilitate policy recommendations
3 for catastrophic disaster preparedness, mitigation and response and recovery planning, pro-
4 cedures and protocols with special emphasis on outreach to representatives of designated
5 state and federal emergency support functions.

6 (2) The council consists of:

7 (a) One member appointed by the Adjutant General to represent the Oregon Military
8 Department;

9 (b) One member appointed by the Director of the Oregon Department of Emergency

20 ment of Transportation;

21 (h) One member appointed by the Attorney General to represent the Department of
22 Justice;

23 (i) One member appointed by the State Forester to represent the State Forestry De-
24 partment;

25 (j) Seven members appointed by the Governor as follows:

26 (A) One member to represent counties;

27 (B) One member to represent cities;

28 (C) One member with experience in emergency preparedness to represent regional or-
29 ganizations;

30 (D) One member with experience in emergency preparedness to represent local organ-
31 izations;

32 (E) One member representing the private sector;

33 (F) One member representing the nonprofit community with a designated emergency
34 support function responsibility; and

35 (G) One member to represent Indian tribes in Oregon; and

36 (k) Additional members appointed by the Governor as the Governor may deem necessary.

37 (3)(a) The council may research international and national best practices and make
38 formal recommendations to the State Resilience Officer or the Governor as needed, with
39 special emphasis given to connecting statewide policy recommendations with state and fed-
40 eral emergency support function capabilities.

41 (b) The council shall advise and make policy recommendations to the Oregon Homeland
42 Security Council regarding federal emergency support functions.

43 (4) A majority of the members of the Emergency Preparedness Advisory Council consti-
44 tutes a quorum for the transaction of business.

45 (5) Official action by the council requires the approval of a majority of the members of

1 **the council.**

2 **(6) The council shall elect one of its members to serve as chairperson.**

3 **(7) If there is a vacancy for any cause, the appointing authority shall make an appoint-**

5 **(8) The council shall meet at least once quarterly at the place specified by the call of the**

35 **(3) The council shall provide advice and recommendations to the Oregon Department of**
36 **Emergency Management regarding its emergency preparedness and response functions.**

37 **(4) A majority of the members of the council constitutes a quorum for the transaction**
38 **of business.**

39 **(5) Official action by the council requires the approval of a majority of the members of**
40 **the council.**

41 **(6) The council shall elect one of its members to serve as chairperson.**

42 **(7) If there is a vacancy for any cause, the Governor shall make an appointment to be-**
43 **come immediately effective.**

44 **(8) The council shall meet at times and places specified by the call of the chairperson or**
45 **of a majority of the members of the council.**

1 (9) The council may adopt rules necessary for the operation of the council.

2 (10) The department shall provide staff support to the council.

3 (11) Members of the council are not entitled to compensation or reimbursement for ex-
4 penses and serve as volunteers on the council.

5 (12) All agencies of state government, as defined in ORS 174.111, are directed to assist
6 the council in the performance of the duties of the council and, to the extent permitted by
7 laws relating to confidentiality, to furnish information and advice the members of the council
8 consider necessary to perform their duties.

9 SECTION 152a. Section 152 of this 2021 Act is repealed on January 2, 2030.

11 **TASK FORCE ON IMPLEMENTATION**

33 (10) The office of the State Fire Marshal shall provide staff support to the task force.

34 (11) Members of the task force are not entitled to compensation or reimbursement for
35 expenses and serve as volunteers on the task force.

36 (12) All agencies of state government, as defined in ORS 174.111, are directed to assist
37 the task force in the performance of the duties of the task force and, to the extent permitted
38 by laws relating to confidentiality, to furnish information and advice the members of the task
39 force consider necessary to perform their duties.

40 SECTION 152c. Section 152b of this 2021 Act is repealed on January 2, 2023.
