1 On page 1 of the printed bill, delete lines 3 through 5 and insert “677.135, 677.137, 677.139,
2 677.141, 677.495, 677.510, 677.511, 677.515, 677.518, 688.510 and 743A.044 and section 45, chapter 12,
3 Oregon Laws 2020 (first special session); and declaring an emergency.”.

4 Delete lines 7 through 28 and delete pages 2 through 11 and insert:

“PHYSICIAN ASSISTANT PRACTICE

8 “**SECTION 1.** ORS 677.511 is amended to read:

9 “677.511. (1)(a) A [*supervising physician or supervising physician organization*] **physician as-**
10 **stant** may [*apply to*] **register with** the Oregon Medical Board for authority [*for a physician as-*
11 *stant*] to dispense **prescription** drugs [*specified by the supervising physician or supervising*
12 *physician organization*].

13 “(b) Notwithstanding paragraph (a) of this subsection, and except as permitted under ORS
14 677.515 (4), a physician assistant may not dispense controlled substances classified in Schedule I or
15 II under the federal Controlled Substances Act, 21 U.S.C. 811 and 812, as modified under ORS
16 475.035.

17 “[*(2) The board shall adopt rules establishing standards and qualifications for physician assistants*
18 *with dispensing authority. The rules must require:*]

19 “[*(a) A physician assistant seeking dispensing authority to complete a drug dispensing training*
20 *program; and*]

21 “[*(b) The supervising physician or supervising physician organization that applies for dispensing*
22 *authority for a physician assistant to:*]

23 “[*(A) Provide the board with a plan for drug delivery and control;*]

24 “[*(B) Submit an annual report to the board on the physician assistant’s use of dispensing author-*
25 *ity;*]

26 “[*(C) Submit to the board a list of the drugs or classes of drugs that the supervising physician or*
27 *supervising physician organization proposes to authorize the physician assistant to dispense; and*]

28 “[*(D) Submit to the board documentation showing that the supervising physician or supervising*
29 *physician organization has registered the facility from which the physician assistant will dispense*
30 *drugs as a drug outlet with the State Board of Pharmacy under ORS 689.305.*]

31 “[*(3) The Oregon Medical Board and the State Board of Pharmacy shall jointly develop a drug*
32 *dispensing training program for physician assistants and adopt that program by rule.*]

33 “[*(4) A supervising physician or supervising physician organization that supervises a physician*
34 *assistant with dispensing authority shall comply with rules adopted by the State Board of Pharmacy*
35 *relating to registration, acquisition, storage, integrity, security, access, dispensing and disposal of*”

1 *drugs, record keeping and consultation with pharmacists.]*

2 *“(5) A physician assistant who dispenses a controlled substance classified in Schedule III or IV*
3 *under the federal Controlled Substances Act, 21 U.S.C. 811 and 812, as modified under ORS 475.035,*
4 *shall report the dispensing of the controlled substance to the Oregon Health Authority in a manner*
5 *consistent with the requirements for reporting by pharmacies as provided in ORS 431A.855 to*
6 *431A.900.]*

7 *“(6) Drugs dispensed by a physician assistant with dispensing authority under this section must*
8 *be personally dispensed by the physician assistant.]*

9 **“(2) An registration under this section must include any information required by the**
10 **board by rule.**

11 **“(3) Prescription drugs dispensed by a physician assistant must be personally dispensed**
12 **by the physician assistant, except that nonjudgmental dispensing functions may be delegated**
13 **to staff assistants when the accuracy and completeness of the prescription is verified by the**
14 **physician assistant.**

15 **“(4) The physician assistant shall maintain records of the receipt and distribution of**
16 **prescription drugs. The records must be readily accessible for inspection by the board upon**
17 **request of the board.**

18 **“(5) The physician assistant shall ensure that a prescription drug dispensed by the phy-**
19 **sician assistant is labeled in compliance with the requirements of ORS 677.089 (3).**

20 **“(6) The board has disciplinary authority regarding a physician assistant who has pre-**
21 **scription drug dispensing authority.**

22 **“SECTION 2.** ORS 677.515 is amended to read:

23 **“677.515. (1) A physician assistant [licensed under ORS 677.512] may provide any medical ser-**
24 **vice, including prescribing and administering controlled substances in Schedules II through V under**
25 **the federal Controlled Substances Act:**

26 *“(a) That is delegated by the physician assistant’s supervising physician or supervising physician*
27 *organization;]*

28 *“(b) (a) That is within the scope of practice of the physician assistant; and*

29 *“(c) That is within the scope of practice of the supervising physician or supervising physician or-*
30 *ganization;]*

31 *“(d) That is provided under the supervision of the supervising physician or supervising physician*
32 *organization;]*

33 *“(e) That is generally described in and in compliance with the practice agreement; and]*

34 *“(f) (b) For which the physician assistant has obtained informed consent as provided in ORS*
35 *677.097, if informed consent is required.*

36 **“(2) This chapter does not prohibit a student enrolled in a program for educating physician as-**
37 **stants approved by the Oregon Medical Board from rendering medical services if the services are**
38 **rendered in the course of the program.**

39 **“(3) The degree of [independent] autonomous judgment that a physician assistant may exercise**
40 **shall be determined [by the supervising physician, or supervising physician organization, and the**
41 **physician assistant in accordance with the practice agreement] at the physician assistant’s primary**
42 **location of practice by the community standards of care and the physician assistant’s edu-**
43 **cation, training and experience.**

44 **“(4) [A supervising physician, upon the approval of the board and in accordance with the rules**
45 **established by the board, may delegate to the physician assistant the authority to administer and pre-**

1 scribe medications pursuant to this section and ORS 677.535.] The board may not limit the privilege
2 of administering, dispensing and prescribing **prescription drugs** to population groups federally
3 designated as underserved, or to geographic areas of the state that are federally designated health
4 professional shortage areas, federally designated medically underserved areas or areas designated
5 as medically disadvantaged and in need of primary health care providers by the Director of the
6 Oregon Health Authority or the Office of Rural Health. All prescriptions written pursuant to this
7 subsection must bear the name, office address and telephone number of the [*supervising physician*]
8 **physician assistant who writes the prescription.**

9 “(5) This chapter does not require or prohibit a physician assistant from practicing in a hospital
10 licensed pursuant to ORS 441.015 to 441.087.

11 “(6) Prescriptions for medications prescribed by a physician assistant in accordance with this
12 section and ORS 475.005, 677.010, 677.500, 677.510 and 677.535 and dispensed by a licensed
13 pharmacist may be filled by the pharmacist according to the terms of the prescription, and the filling
14 of such a prescription does not constitute evidence of negligence on the part of the pharmacist if
15 the prescription was dispensed within the reasonable and prudent practice of pharmacy.

16 “**SECTION 3.** ORS 677.135 is amended to read:

17 “677.135. As used in ORS 677.135 to 677.141, ‘the practice of medicine across state lines’ means:

18 “(1) The rendering directly to a person of a written or otherwise documented medical opinion
19 concerning the diagnosis or treatment of that person located within this state for the purpose of
20 patient care by a physician **or physician assistant** located outside this state as a result of the
21 transmission of individual patient data by electronic or other means from within this state to that
22 physician [*or*], the physician’s agent **or a physician assistant**; or

23 “(2) The rendering of medical treatment directly to a person located within this state by a
24 physician **or a physician assistant** located outside this state as a result of the outward trans-
25 mission of individual patient data by electronic or other means from within this state to that phy-
26 sician [*or*], the physician’s agent **or a physician assistant.**

27 “**SECTION 4.** ORS 677.137 is amended to read:

28 “677.137. (1) A person may not engage in the practice of medicine across state lines, claim
29 qualification to engage in the practice of medicine across state lines or use any title, word or ab-
30 breviation to indicate or to induce another to believe that the person is licensed to engage in the
31 practice of medicine across state lines unless the person is licensed in accordance with ORS 677.139.

32 “(2) ORS 677.135 to 677.141 do not apply to a physician **or physician assistant** engaging in the
33 practice of medicine across state lines in an emergency, as defined by rule of the Oregon Medical
34 Board.

35 “(3) ORS 677.135 to 677.141 do not apply to a licensed physician **or physician assistant** located
36 outside this state who:

37 “(a) Consults with another physician **or physician assistant** licensed to practice medicine in
38 this state; and

39 “(b) Does not undertake the primary responsibility for diagnosing or rendering treatment to a
40 patient within this state.

41 “(4) ORS 677.135 to 677.141 do not apply to a licensed physician **or physician assistant** located
42 outside this state who has an established physician-patient relationship with a person who is in
43 Oregon temporarily and who requires the direct medical treatment by that physician **or physician**
44 **assistant.**

45 “**SECTION 5.** ORS 677.139 is amended to read:

1 “677.139. (1) Upon application, the Oregon Medical Board may issue to an out-of-state physician
2 **or physician assistant** a license for the practice of medicine across state lines if the physician **or**
3 **physician assistant** holds a full, unrestricted license to practice medicine in any other state of the
4 United States, has not been the recipient of a professional sanction by any other state of the United
5 States and otherwise meets the standards for Oregon licensure under this chapter.

6 “(2) In the event that an out-of-state physician **or physician assistant** has been the recipient
7 of a professional sanction by any other state of the United States, the board may issue a license for
8 the practice of medicine across state lines if the board finds that the sanction does not indicate that
9 the physician **or physician assistant** is a potential threat to the public interest, health, welfare and
10 safety.

11 “(3) A physician **or physician assistant** shall [*make the application*] **apply** on a form provided
12 by the board, accompanied by nonrefundable fees for the application and the license in amounts
13 determined by rule of the board. The board shall adopt necessary and proper rules to govern the
14 renewal of licenses issued under this section.

15 “(4) A license for the practice of medicine across state lines is not a limited license for purposes
16 of ORS 677.132.

17 “(5) A license for the practice of medicine across state lines does not permit a physician **or**
18 **physician assistant** to practice medicine in this state except when engaging in the practice of
19 medicine across state lines.

20 “**SECTION 6.** ORS 677.141 is amended to read:

21 “677.141. (1) A physician **or physician assistant** issued a license under ORS 677.139:

22 “(a) Is subject to all the provisions of this chapter and to all the rules of the Oregon Medical
23 Board[. *A physician issued a license under ORS 677.139*]; **and**

24 “(b) Has the same duties and responsibilities and is subject to the same penalties and sanctions
25 as any other physician **or physician assistant** licensed under this chapter.

26 “(2) A physician **or physician assistant** issued a license under ORS 677.139 may not:

27 “(a) Act as a dispensing physician as defined in ORS 677.010;

28 “(b) Administer controlled substances for the treatment of intractable pain to a person located
29 within this state;

30 “(c) Provide written documentation for purposes of ORS 475B.797;

31 “(d) Employ a physician assistant as defined in ORS 677.495 to treat a person located within this
32 state; or

33 “(e) Assert a lien for services under ORS 87.555.

34 “(3) A physician **or physician assistant** licensed under ORS 677.139 shall comply with all pa-
35 tient confidentiality requirements of this state, except as those requirements are expressly prohib-
36 ited by the law of any other state of the United States where a person’s medical records are
37 maintained.

38 “**SECTION 7.** ORS 441.064 is amended to read:

39 “441.064. (1) As used in this section:

40 “(a) ‘Nurse practitioner’ has the meaning given that term in ORS 678.010;

41 “(b) ‘Physician’ has the meaning given that term in ORS 677.010; and

42 “(c) ‘Physician assistant’ has the meaning given that term in ORS 677.495.

43 “(2) The rules of any hospital in this state may grant privileges to nurse practitioners and phy-
44 sician assistants for purposes of patient care.

45 “(3) Rules must be in writing and may include, but need not be limited to:

1 “(a) Limitations on the scope of privileges;

2 “(b) Monitoring and supervision of nurse practitioners and physician assistants in the hospital

3 by physicians who are members of the medical staff;

4 “(c) A requirement that a nurse practitioner or physician assistant co-admit patients with a

5 physician who is a member of the medical staff; and

6 “(d) Qualifications of nurse practitioners and physician assistants to be eligible for privileges

7 including but not limited to requirements of prior clinical and hospital experience.

8 “(4) The rules may:

9 “(a) Regulate the credentialing and conduct of nurse practitioners and physician assistants while

10 using the facilities of the hospital;

11 “(b) Prescribe the procedures for suspension or termination of a nurse practitioner’s or physi-

12 cian assistant’s privileges; **and**

13 “(c) Allow the hospital to refuse privileges to a nurse practitioner **or physician assistant**, but

14 only on the same basis that the hospital refuses privileges to other medical providers.[]; *and*]

15 “[(d) *Allow the hospital to refuse privileges to a physician assistant based on the refusal of privi-*

16 *leges to the physician assistant’s supervising physician.*]

17 “(5) Notwithstanding subsection (3) of this section, rules adopted by a hospital that grant privi-

18 leges to licensed registered nurses who are licensed by the Oregon State Board of Nursing as nurse

19 practitioners specializing in nurse midwifery must:

20 “(a) Include admitting privileges;

21 “(b) Be consistent with the privileges of the other medical staff; and

22 “(c) Permit the nurse practitioner specializing in nurse midwifery to exercise the voting rights

23 of the other members of the medical staff.

24 “(6) Rules described in this section are subject to hospital and medical staff bylaws and rules

25 governing credentialing and staff privileges.

26 “**SECTION 8.** ORS 688.510 is amended to read:

27 “688.510. (1) As used in this section:

28 “(a) ‘Fluoroscopy’ means a technique for generating X-ray images and for presenting the X-ray

29 images simultaneously and continuously as a visible image.

30 “(b) ‘Physician assistant’ means a physician assistant licensed under ORS 677.505 to 677.525.

31 “[(c) *‘Supervising physician’ means a physician licensed under ORS chapter 677 who has entered*

32 *into a practice agreement with a physician assistant as described in ORS 677.510.*]

33 “[(d)] (c) ‘To practice fluoroscopy’ means to initiate the generation of X-rays and to acquire

34 visible images for the purpose of medical diagnosis.

35 “(2) Except as provided in subsection [(7)] (5) of this section, a physician assistant may not

36 practice fluoroscopy on a person unless the physician assistant:

37 “(a) Holds an active certificate issued by the Board of Medical Imaging under this section; **and**

38 “(b) Operates fluoroscopic X-ray equipment in compliance with [*this section and*] rules adopted

39 by the board under this section[]; *and*].

40 “[(c) *Fluoroscopy is among the medical duties delegated to the physician assistant pursuant to a*

41 *practice agreement described in ORS 677.510.*]

42 “(3) The board shall issue a certificate to practice fluoroscopy to a physician assistant who:

43 “(a) Completes a fluoroscopy education program approved by the board;

44 “(b) Submits an examination application to the board in a form and manner prescribed by the

45 board;

1 “(c) Pays an examination fee established by the board by rule;
2 “(d) Passes an examination on fluoroscopy approved by the board;
3 “(e) Submits a certificate application to the board in a form and manner prescribed by the board;
4 “(f) Pays a certificate application fee established by the board by rule; and
5 “(g) Meets the standards of ethical and professional conduct established by a credentialing or-
6 ganization or professional society related to the practice of medical imaging.

7 “(4) The board shall renew the certificate to practice fluoroscopy of a physician assistant who:
8 “(a) Submits a renewal application to the board in a form and manner prescribed by the board;
9 “(b) Pays a renewal fee established by the board by rule; and
10 “(c) Completes continuing education requirements approved by the board.

11 “[5] *A supervising physician may delegate fluoroscopy procedures only to a physician assistant*
12 *who holds a certificate issued pursuant to this section.*]

13 “[6](a) *A physician assistant who holds a certificate issued pursuant to this section may practice*
14 *fluoroscopy only as authorized by this section.*]

15 “[b] *A physician assistant may practice fluoroscopy only if:*]

16 “[A] *The supervising physician with whom the physician assistant has entered into a practice*
17 *agreement is in the room where the fluoroscopic procedure is taking place at the time that the procedure*
18 *is taking place; or]*

19 “[B] *The supervising physician with whom the physician assistant has entered into a practice*
20 *agreement is in the building where the fluoroscopic procedure is taking place at the time that the pro-*
21 *cedure is taking place and a medical imaging licensee who specializes in the medical imaging modality*
22 *of radiography is in the room where the procedure is taking place at the time that the procedure is*
23 *taking place.*]

24 “[c] *The board may adopt by rule an exception to the requirements of paragraph (b) of this sub-*
25 *section if the board determines that the exception does not create a risk of harm to the public health*
26 *and safety.*]

27 “[7] (5) A physician assistant may practice fluoroscopy before being issued a certificate under
28 this section for the purpose of completing a fluoroscopy training program. A physician assistant
29 must be supervised, as determined by the board by rule, when practicing fluoroscopy under this
30 subsection.

31 “[8] (6) Subject to the provisions of ORS chapter 183, the board may refuse to issue or renew
32 a certificate under this section or may suspend or revoke a certificate under this section if the ap-
33 plicant or certificate holder violates a provision of this section or any rule adopted by the board
34 under this section.

35 “**SECTION 9. (1) The amendments to ORS 441.064, 677.135, 677.137, 677.139, 677.141,**
36 **677.511, 677.515 and 688.510 by sections 1 to 8 of this 2021 Act become operative on January**
37 **15, 2022.**

38 “(2) **The Board of Medical Imaging and the Oregon Medical Board may take any action**
39 **before the operative date specified in subsection (1) of this section that is necessary to enable**
40 **the boards to exercise, on and after the operative date specified in subsection (1) of this**
41 **section, all of the duties, functions and powers conferred on the boards by the amendments**
42 **to ORS 441.064, 677.135, 677.137, 677.139, 677.141, 677.511, 677.515 and 688.510 by sections 1 to**
43 **8 of this 2021 Act.**

“COLLABORATION AGREEMENTS

1 “**SECTION 10.** ORS 677.495 is amended to read:

2 “677.495. As used in ORS 677.495 to 677.535, unless the context requires otherwise:

3 “(1) ‘**Collaboration**’ means, as indicated by the patient’s condition, community standards
4 of care and a physician assistant’s education, training and experience:

5 “(a) Consultation between the physician assistant and a physician or podiatric physician;
6 or

7 “(b) Referral by the physician assistant to a physician or podiatric physician.

8 “(2) ‘**Collaboration agreement**’ means a written agreement that describes the manner in
9 which the physician assistant collaborates with physicians or podiatric physicians, that does
10 not assign supervisory responsibility to, or represent acceptance of legal responsibility by, a
11 physician or podiatric physician for the care provided by the physician assistant and that is
12 signed by the physician assistant and the physician, podiatric physician or physician
13 assistant’s employer.

14 “(3) ‘**Employer**’ means:

15 “(a) An entity that is organized to deliver health care services in this state in accordance
16 with ORS 58.375 or 58.376 and that employs a physician or podiatric physician; or

17 “(b) A physician or podiatric physician who employs a physician assistant.

18 “(4) ‘**Physician**’ means a physician licensed under ORS 677.100 to 677.228.

19 “[(1)] (5) ‘**Physician assistant**’ means a person who is licensed in accordance with ORS 677.505
20 to 677.525.

21 “(6) ‘**Podiatric physician**’ means a podiatric physician and surgeon licensed under ORS
22 677.805 to 677.840.

23 “[(2)] ‘*Practice agreement*’ means a written agreement between a physician assistant and a super-
24 vising physician or supervising physician organization that describes the manner in which the services
25 of the physician assistant will be used.]

26 “[(3)] ‘*Supervising physician*’ means a physician licensed under ORS 677.100 to 677.228, or a
27 podiatric physician and surgeon licensed under ORS 677.805 to 677.840, who supervises a physician
28 assistant.]

29 “[(4)] ‘*Supervising physician organization*’ means a group of supervising physicians that collectively
30 supervises a physician assistant.]

31 “[(5)] ‘*Supervision*’ means the acts of overseeing and accepting responsibility for the medical ser-
32 vices provided by a physician assistant in accordance with a practice agreement, including regular and
33 routine oversight and chart review.]

34 “**SECTION 11.** ORS 677.510 is amended to read:

35 “677.510. [(1)] A person licensed to practice medicine under this chapter may not use the services
36 of a physician assistant without the prior approval of the Oregon Medical Board.]

37 “[(2)] A supervising physician or a supervising physician organization may apply to the board to
38 use the services of a physician assistant. The application must:]

39 “[(a)] If the applicant is not a supervising physician organization, state the name and contact in-
40 formation of the supervising physician;]

41 “[(b)] If the applicant is a supervising physician organization:]

42 “[(A)] State the names and contact information of all supervising physicians; and]

43 “[(B)] State the name of the primary supervising physician required by subsection (5) of this
44 section;]

45 “[(c)] Generally describe the medical services provided by each supervising physician;]

1 “(d) Contain a statement acknowledging that each supervising physician has reviewed statutes and
2 rules relating to the practice of physician assistants and the role of a supervising physician; and]

3 “(e) Provide such other information in such a form as the board may require.]

4 “(3) The board shall approve or reject an application within seven working days after the board
5 receives the application, unless the board is conducting an investigation of the supervising physician
6 or of any of the supervising physicians in a supervising physician organization applying to use the
7 services of a physician assistant.]

8 “(4) A supervising physician organization shall provide the board with a list of the supervising
9 physicians in the supervising physician organization. The supervising physician organization shall
10 continually update the list and notify the board of any changes.]

11 “(5) A supervising physician organization shall designate a primary supervising physician and
12 notify the board in the manner prescribed by the board.]

13 “(6)(a) A physician assistant may not practice medicine until the physician assistant enters into a
14 practice agreement with a supervising physician or supervising physician organization whose applica-
15 tion has been approved under subsection (3) of this section. The practice agreement must:]

16 “(A) Include the name, contact information and license number of the physician assistant and each
17 supervising physician.]

18 “(B) Describe the degree and methods of supervision that the supervising physician or supervising
19 physician organization will use. The degree of supervision, whether general, direct or personal, must
20 be based on the level of competency of the physician assistant as judged by the supervising
21 physician.]

22 “(C) Generally describe the medical duties delegated to the physician assistant.]

23 “(D) Describe the services or procedures common to the practice or specialty that the physician
24 assistant is not permitted to perform.]

25 “(E) Describe the prescriptive and medication administration privileges that the physician assistant
26 will exercise.]

27 “(F) Provide the list of settings and licensed facilities in which the physician assistant will provide
28 services.]

29 “(G) State that the physician assistant and each supervising physician is in full compliance with
30 the laws and regulations governing the practice of medicine by physician assistants, supervising phy-
31 sicians and supervising physician organizations and acknowledge that violation of laws or regulations
32 governing the practice of medicine may subject the physician assistant and supervising physician or
33 supervising physician organization to discipline.]

34 “(H) Be signed by the supervising physician or the primary supervising physician of the super-
35 vising physician organization and by the physician assistant.]

36 “(I) Be updated at least every two years.]

37 “(b) The supervising physician or supervising physician organization shall provide the board with
38 a copy of the practice agreement within 10 days after the physician assistant begins practice with the
39 supervising physician or supervising physician organization. The supervising physician or supervising
40 physician organization shall keep a copy of the practice agreement at the practice location and make
41 a copy of the practice agreement available to the board on request. The practice agreement is not sub-
42 ject to board approval, but the board may request a meeting with a supervising physician or supervis-
43 ing physician organization and a physician assistant to discuss a practice agreement.]

44 “(7) A physician assistant’s supervising physician shall ensure that the physician assistant is
45 competent to perform all duties delegated to the physician assistant. The supervising physician or

1 *supervising physician organization and the physician assistant are responsible for ensuring the com-*
2 *petent practice of the physician assistant.]*

3 *“(8) A supervising physician or the agent of a supervising physician must be competent to perform*
4 *the duties delegated to the physician assistant by the supervising physician or by a supervising physi-*
5 *cian organization.]*

6 *“(9) The board may not require that a supervising physician be physically present at all times*
7 *when the physician assistant is providing services, but may require that:]*

8 *“(a) The physician assistant have access to personal or telephone communication with a supervis-*
9 *ing physician when the physician assistant is providing services; and]*

10 *“(b) The proximity of a supervising physician and the methods and means of supervision be ap-*
11 *propriate to the practice setting and the patient conditions treated in the practice setting.]*

12 *“(10)(a) A supervising physician organization may supervise any number of physician assistants.*
13 *The board may not adopt rules limiting the number of physician assistants that a supervising physician*
14 *organization may supervise.]*

15 *“(b) A physician assistant who is supervised by a supervising physician organization may be*
16 *supervised by any of the supervising physicians in the supervising physician organization.]*

17 *“(11) If a physician assistant is not supervised by a supervising physician organization, the phy-*
18 *sician assistant may be supervised by no more than four supervising physicians, unless the board ap-*

20 *assistant to be supervised by more than four supervising physicians.]*

21 *“(12) A supervising physician who is not acting as part of a supervising physician organization*
22 *may supervise four physician assistants, unless the board approves a request from the supervising*
23 *physician or from a physician assistant for the supervising physician to supervise more than four*
24 *physician assistants.]*

25 *“(13) A supervising physician who is not acting as part of a supervising physician organization*
26 *may designate a physician to serve as the agent of the supervising physician for a predetermined period*
27 *of time.]*

28 *“(14) A physician assistant may render services in any setting included in the practice*
29 *agreement.]*

30 *“(15) A physician assistant for whom an application under this section has been approved by the*
31 *board on or after January 2, 2006, shall submit to the board, within 24 months after the approval,*

33 *“(a) A pain management education program approved by the board and developed in conjunction*

36 **“(1) A physician assistant is responsible for the care provided by the physician assistant.**

37 **“(2) A physician assistant shall engage in collaboration to the degree determined at the**
38 **physician assistant’s primary location of practice. The determination may include decisions**
39 **made by a physician, podiatric physician or employer with whom the physician assistant has**
40 **entered into a collaboration agreement, or the group or hospital service and the credentialing**
41 **and privileging systems of the physician assistant’s primary location of practice.**

42 **“(3)(a) A physician assistant may not provide care unless the physician assistant has**
43 **entered into a collaboration agreement signed by a physician, podiatric physician or em-**
44 **ployer. The collaboration agreement must include:**

45 **“(A) The physician assistant’s name, license number and primary location of practice;**

1 “(B) A general description of the physician assistant’s process for collaboration with

4 rience, a plan for the minimum number of hours per month during which the physician as-
5 sistant will collaborate, both in person and through technology, with a specified physician

9 “(b) The physician assistant, or physician, podiatric physician or employer with whom the
10 physician assistant has entered into the collaboration agreement, is responsible for tracking

13 mary location of practice and made available to the Oregon Medical Board upon request.

41 pharmacist may be filled by the pharmacist according to the terms of the prescription, and the filling
42 of such a prescription does not constitute evidence of negligence on the part of the pharmacist if
43 the prescription was dispensed within the reasonable and prudent practice of pharmacy.
