## House Bill 3092

Sponsored by COMMITTEE ON WATER (at the request of Representative Ken Helm)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires Water Resources Department to establish grant program for purpose of sharing cost of remediating reductions in amount of ground water available for domestic personal use in Greater Harney Valley Groundwater Area of Concern due to overallocation of ground water for agricultural use.

Establishes in State Treasury, separate and distinct from General Fund, Domestic Well Remediation Fund to provide funds for grant program.

Appropriates moneys from General Fund to Water Resources Department for deposit into Domestic Well Remediation Fund.

Takes effect on 91st day following adjournment sine die.

A BILL FOR AN ACT

2 Relating to ground water levels; and prescribing an effective date.

**3 Be It Enacted by the People of the State of Oregon:** 

4 <u>SECTION 1.</u> (1) The Water Resources Department shall establish by rule a grant program 5 for the purpose of sharing the cost of remediating reductions in the amount of ground water

6 available for domestic personal use in the Greater Harney Valley Groundwater Area of Con-

7 cern due to overallocation of ground water for agricultural use.

8 (2) In administering the program, the department:

9 (a) Shall develop a process for applying for a grant and criteria for selecting a grantee.

10 (b) Shall award grants for:

11 (A) Up to \$10,000 per grantee to provide for the replacement or repair of a domestic 12 personal use well affected by declining ground water levels within the Greater Harney Valley

13 Groundwater Area of Concern; and

14 (B) Up to 75 percent of the cost of replacing or repairing the well.

(c) Shall, for purposes of the program, adopt by rule a definition for the term "Greater
Harney Valley Groundwater Area of Concern" or maintain in rule a definition for the term
that the department adopted before the effective date of this 2021 Act.

(d) May require a grantee to report to the department on the use of the grant funds.

(3) The department shall review the grant program on a biennial basis to assess to what extent the outcome described in subsection (1) of this section is being achieved. The department shall modify the process for awarding grants as necessary to better achieve the out-

22 come described in subsection (1) of this section.

23 <u>SECTION 2.</u> (1) There is established in the State Treasury, separate and distinct from the 24 General Fund, the Domestic Well Remediation Fund. Interest earned by the Domestic Well 25 Remediation Fund shall be credited to the fund. All moneys in the Domestic Well Remedi-26 ation Fund are continuously appropriated to the Water Resources Department to carry out 27 the purposes described in section 1 of this 2021 Act.

1 (2) The Domestic Well Remediation Fund shall consist of all moneys credited to the fund,

2 including moneys appropriated or transferred to the fund by the Legislative Assembly.

3 <u>SECTION 3.</u> There is appropriated to the Water Resources Department, for the biennium
4 beginning July 1, 2021, out of the General Fund, the amount of \$500,000 for deposit into the

5 Domestic Well Remediation Fund established in section 2 of this 2021 Act.

6 <u>SECTION 4.</u> This 2021 Act takes effect on the 91st day after the date on which the 2021 7 regular session of the Eighty-first Legislative Assembly adjourns sine die.
