SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Makes nonsubstantive and technical changes in Oregon law. Corrects grammar and punctuation. Deletes obsolete provisions. Conforms language to existing statutes and legislative style.

12 under laws otherwise applicable to a particular transaction.

13 (2) "Automated transaction" means a transaction conducted or performed, in whole or in part,
14 by electronic means or electronic records, in which the acts or records of one or both parties are
15 not reviewed by an individual in the ordinary course in forming a contract, performing under an
16 existing contract or fulfilling an obligation required by the transaction.

17 (3) "Computer program" means a set of statements or instructions to be used directly or indi-
18 rectly in an information processing system in order to bring about a certain result.

19 (4) "Contract" means the total legal obligation resulting from the parties' agreement under ORS
20 84.001 to 84.061 and other applicable law.

21 (5) "Electronic" means relating to technology having electrical, digital, magnetic, wireless, op-
22 tical, electromagnetic or similar capabilities.

16 100.120. (1)(a) To annex additional property to the condominium under ORS 100.125 or to re-
17 classify or redesignate variable property under ORS 100.150 (1), a supplemental declaration and a
18 supplemental plat must be executed, approved and recorded by the declarant in each county in
19 which the property is located at the time of each annexation, reclassification or redesignation as
20 provided in this section.

21 (b) Withdrawable variable property may not be redesignated nonwithdrawable variable property
22 under this chapter by an amendment to the declaration, plat, supplemental declaration[,] or supple-
23 mental plat.

24 (2) The supplemental plat must comply with ORS 100.115 and the supplemental declarations

26 (a) Include a reference to recording index numbers and date of recording of the initial declara-

39 first unit in the stage to a person other than the declarant.

40 (3) If the Condominium Information Report and the Annual Report described in ORS 100.250 are
41 designated current as provided in ORS 100.255, all supplemental declarations and plats shall be ap-
42 proved, executed and recorded as provided in ORS 100.100, 100.110 and 100.115. A unit being an-
43 nexed or created by a supplemental declaration may not be conveyed until after the recording.

44 (4) To withdraw all or a portion of withdrawable variable property from a flexible condominium
45 pursuant to ORS 100.150 (1)(b), a supplemental declaration and plat must be recorded in accordance

1 with subsection (3) of this section. The supplemental plat must comply with ORS 100.115 (2) and the
2 supplemental declaration must:

3 (a) Be consistent with the provisions of the declaration or supplemental declaration drawn pur-
4 suant to ORS 100.105 (7).

5 (b) Include a metes and bounds legal description of the variable property being withdrawn.

6 (c) Include a metes and bounds legal description of the resulting boundaries of the condominium
7 after the withdrawal.

8 (d) State whether any variable property remains that may be reclassified, redesignated or with-
9 drawn from the condominium under ORS 100.150 (1) and, if property may be withdrawn, include the
10 statement required under ORS 100.105 (7)(m).

11 (e) If any withdrawable variable property is being redesignated as “nonwithdrawable variable
12 property” under ORS 100.150 (1), include the information required under ORS 100.105 (7)(L) and any
13 other information required by rule of the Real Estate Commissioner.

14 (5) Except as provided in subsection (6) of this section, as to property submitted to unit owner-
15 ship after October 4, 1977, additional units may not be added within property previously submitted
16 to unit ownership unless all unit owners consent to an amendment to the declaration, plat and any
17 floor plans recorded pursuant to ORS 100.116 in order to provide for such additional units.

18 (6) As to property submitted to unit ownership before September 27, 1987, if the declaration
19 provides that additional property may be annexed to the condominium, any subsequent stage may
20 contain variable property. The termination date may not be later than the earlier of:

21 (a) The date specified in the declaration under ORS 100.105 (2)(b); or

22 (b) Seven years from the recording of the conveyance of the first unit in the condominium to a
23 person other than the declarant.

26 105.435. (1) A receiver appointed by the court pursuant to ORS 105.420 to 105.455 may, unless
27 specifically limited by the court:

28 (a) Take possession and control of the property, including the right to enter, modify and termi-
29 nate tenancies pursuant to ORS 105.105 to [105.161] **105.168**, to charge and collect rents and to apply
30 rents to the costs incurred due to the abatement and receivership;

31 (b) Negotiate contracts and pay all expenses associated with the operation and conservation of
32 the property, including all utility, fuel, custodial, repair or insurance costs;

33 (c) Pay all accrued property taxes, penalties, assessments and other charges imposed on the
34 property by a unit of government and any charge accruing during the pendency of the receivership;

35 (d) Dispose of any or all abandoned personal property found at the structure;

36 (e) Enter into contracts and pay for the performance of any work necessary to complete the
37 abatement; and

38 (f) Under such terms and condition as a court allows, enter into financing agreements with
39 public or private lenders and encumber the property to have moneys available to correct the con-
40 ditions at the property giving rise to the abatement.

41 (2) A court may approve a charge of an administrative fee for a receiver at an hourly rate ap-
42 proved by the court or at a rate not to exceed 15 percent of the total cost of the abatement.

3 105.624. As used in ORS 105.623 to 105.649:

4 (1) “Disclaimant” means the person to whom a disclaimed interest or power would have passed
5 had the disclaimer not been made.

6 (2) “Disclaimed interest” means the interest that would have passed to the disclaimant had the
7 disclaimer not been made.

8 (3) “Disclaimer” means the refusal to accept an interest in property or a power over property.

9 (4) “Fiduciary” means a personal representative, trustee, agent acting under a power of attorney
10 or other person authorized to act as a fiduciary with respect to the property of another person.

11 (5) “Jointly held property” means property held in the name of two or more persons under an
12 arrangement pursuant to which:

13 (a) All holders have concurrent interests; and

14 (b) The last surviving holder is entitled to the whole of the property.

15 (6) “Person” means an individual, corporation, business trust, partnership, limited liability com-
16 pany, association, joint venture, government, governmental subdivision, agency, public corporation
17 or any other legal or commercial entity.

18 (7) “State” means a state of the United States, the District of Columbia, Puerto Rico, the United
19 States Virgin Islands or any territory or insular possession subject to the jurisdiction of the United

23 (a) A charitable or noncharitable express trust, including any additions made to the trust,
24 whenever and however created; and

25 (b) A trust created pursuant to a statute or judgment that requires the trust to be administered
26 in the same manner as an express trust.

28 **SECTION 13.** ORS 109.704 is amended to read:

29 109.704. As used in ORS 109.701 to 109.834:

30 (1) “Abandoned” means left without provision for reasonable and necessary care or supervision.

31 (2) “Child” means an individual who has not attained 18 years of age.

32 (3) “Child custody determination” means a judgment or other order of a court providing for the
33 legal custody, physical custody, parenting time or visitation with respect to a child. “Child custody
34 determination” includes a permanent, temporary, initial and modification order. “Child custody de-
35 termination” does not include an order relating to child support or other monetary obligation of an
36 individual.

37 (4) “Child custody proceeding” means a proceeding in which legal custody, physical custody,
38 parenting time or visitation with respect to a child is an issue. “Child custody proceeding” includes
39 a proceeding for divorce, separation, neglect, abuse, dependency, guardianship, parentage, termi-
40 nation of parental rights and protection from domestic violence in which the issue may appear.
41 “Child custody proceeding” does not include a proceeding involving juvenile delinquency, contrac-
42 tual emancipation or enforcement under ORS 109.774 to 109.827.

43 (5) “Commencement” means the filing of the first pleading in a proceeding.

44 (6) “Court” means an entity authorized under the law of a state to establish, enforce or modify
45 a child custody determination.

1 (7) "Home state" means the state in which a child lived with a parent or a person acting as a
2 parent for at least six consecutive months immediately before the commencement of a child custody
3 proceeding. In the case of a child less than six months of age, "home state" means the state in which
4 the child lived from birth with any of the persons mentioned. Any temporary absence of any of the
5 mentioned persons is part of the period.

6 (8) "Initial determination" means the first child custody determination concerning a particular
7 child.

8 (9) "Issuing court" means the court that makes a child custody determination for which
9 enforcement is sought under ORS 109.701 to 109.834.

10 (10) "Issuing state" means the state in which a child custody determination is made.

11 (11) "Modification" means a child custody determination that changes, replaces, supersedes or
12 is otherwise made after a previous determination concerning the same child, whether or not it is
13 made by the court that made the previous determination.

14 (12) "Person" means an individual, corporation, public corporation, business trust, estate, trust,
15 partnership, limited liability company, association, joint venture, government or a governmental
16 subdivision, agency or instrumentality, or any other legal or commercial entity.

17 (13) "Person acting as a parent" means a person, other than a parent, who:

18 (a) Has physical custody of the child or has had physical custody for a period of six consecutive
19 months, including any temporary absence, within one year immediately before the commencement
20 of a child custody proceeding; and

21 (b) Has been awarded legal custody by a court or claims a right to legal custody under the law
22 of this state.

23 (14) "Physical custody" means the physical care and supervision of a child.

24 (15) "State" means a state of the United States, the District of Columbia, Puerto Rico, the
25 United States Virgin Islands or any territory or insular possession subject to the jurisdiction of the
26 United States.

27 (16) "Tribe" means an Indian tribe or band, or [*Alaskan*] **Alaska** Native village, that is recog-
28 nized by federal law or formally acknowledged by a state.

29 (17) "Warrant" means an order issued by a court authorizing law enforcement officers to take
30 physical custody of a child.

31 **NOTE:** Updates terminology in (16).

32 **SECTION 14.** ORS 114.545 is amended to read:

- 6 (d) Leverage and optimize existing measures and data systems to improve systems alignment and
- 7 interagency communication; and
- 8 (e) Ensure state alignment and coordination between industry sector partnerships and initiatives

- 24 (F) Information regarding the status of career pathway programs targeted at identified key in-
- 25 dustries in this state;
- 26 (G) Recommendations related to advancing talent pipeline and career pathways development
- 27 based on the identified talent issues and trends;
- 28 (H) Recommendations regarding the alignment and consistency of data nomenclature, collection
- 29 practices and data sharing;
