House Bill 3400

Sponsored by Representative OWENS

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Authorizes Oregon Health Authority to establish multiple laboratories.

1	A BILL FOR AN ACT
2	Relating to state laboratories; creating new provisions; and amending ORS 431A.750 and 433.035.
3	Be It Enacted by the People of the State of Oregon:
4	SECTION 1. The Oregon Health Authority may establish multiple laboratories for the
5	purpose of conducting tests related to public health. Each laboratory established under this
6	section must be certified according to requirements established by the federal Centers for
7	Medicare and Medicaid Services through the Clinical Laboratory Improvement Amendments
8	program.
9	SECTION 2. ORS 431A.750 is amended to read:
10	431A.750. (1) For the better protection of the public health, $[the]$ a laboratory of the Oregon
11	Health Authority established under section 1 of this 2021 Act shall make examinations of water,
12	milk, blood, secretions, excretions, tissues or environmental samples required by any state or local
13	agency in Oregon.
14	(2) In accordance with the rules of the authority, the authority may make examinations of water,
15	milk, blood, secretions, excretions, tissues or environmental samples for any:
16	(a) Country or territory;
17	(b) Federal agency;
18	(c) Agency of another state;
19	(d) Tribal agency; or
20	(e) Health care practitioner licensed in any country, territory or state.
21	(3) The authority may adopt rules to implement this section and collect fees for tests performed
22	in [the] a state public health laboratory, subject to approval by the Oregon Department of Admin-
23	istrative Services prior to adopting a new fee or changing an existing fee.
24	(4) All moneys collected under subsection (3) of this section shall be deposited in the Public
25	Health Account to be used for expenses of the state public health [laboratory] laboratories.
26	SECTION 3. ORS 433.035 is amended to read:
27	433.035. (1)(a) The Public Health Director or a local public health administrator may require
28	testing or medical examination of any person who may have, or may have been exposed to, a
29	communicable disease identified by rule of the Oregon Health Authority to be a reportable disease,
30	a new or uncommon disease of potential public health significance, or a condition that is the basis
31	of a state of public health emergency declared by the Governor as authorized by ORS 433.441. The
32	Public Health Director or the local public health administrator must issue a written order for test-

1 ing or medical examination pursuant to this section.

2 (b) A written order must:

3 (A) Include findings stating the communicable disease that the Public Health Director or the 4 local public health administrator believes the person has and the reasons for that belief.

5 (B) State whether medical or laboratory confirmation of the disease is feasible and possible and 6 whether such confirmation would enable control measures to be taken to minimize infection of oth-7 ers with the disease.

8 (C) Include a statement that the person may refuse to submit to the testing or medical exam-9 ination and that if the testing or examination is refused, the Public Health Director or the local 10 public health administrator may seek the imposition of a public health measure, including isolation 11 or quarantine pursuant to ORS 433.121 or 433.123.

12(2) When a person is directed to submit to a test or examination under this section and the 13 person agrees to do so, the person shall submit to any testing or examination as may be necessary to establish the presence or absence of the communicable disease for which the testing or exam-14 15 ination was directed. The examination shall be carried out by the local health officer or a physician 16 licensed by the Oregon Medical Board or the Oregon Board of Naturopathic Medicine. A written report of the results of the test or examination shall be provided to the person ordering the test or 17 18 examination, and upon request, to the person tested or examined. Laboratory examinations, if any, 19 shall be carried out by [the] a laboratory of the authority established under section 1 of this 2021 20Act whenever the examinations are within the scope of the tests conducted by the laboratory. If treatment is needed, the person or the parent or guardian of the person shall be liable for the costs 2122of treatment based on the examination carried out under this section, if the person liable is able to 23pay the treatment costs. Cost of any examination performed by a physician in private practice shall be paid from public funds available to the local public health administrator, if any, or from county 2425funds available for general governmental expenses in the county that the local public health administrator serves or in the county where the person tested or examined resides if the local public 2627health administrator serves more than one county or the test or examination was ordered by the Public Health Director or local public health administrator. 28

(3) If a person has a communicable disease, a new or uncommon disease of potential public 2930 health significance, or a condition that is the basis of a state of public health emergency, the Public 31 Health Director or the local public health administrator may issue an order requiring the person to complete an appropriate prescribed course of medication or other treatment for the communicable 32disease, including directly observed therapy if appropriate, and to follow infection control provisions 33 34 for the disease. The order shall also include statements that the person may refuse the medication 35 or other treatment and that the person's failure to comply with the order issued under this subsection may result in the Public Health Director or the local public health administrator seeking the 36 37 imposition of a public health measure, including isolation or quarantine as authorized by ORS 38 433.121 and 433.123.

(4) The Public Health Director or the local public health administrator must make every effort
to obtain voluntary compliance from a person for any testing, medical examination and treatment
required under this section.

42 (5) Any action taken by the Public Health Director or the local public health administrator un-43 der this section to compel testing, medical examination or treatment of a person who has a 44 communicable disease, a new or uncommon disease of potential public health significance, or a 45 condition that is the basis of a state of public health emergency must be the least restrictive alter-
