and capital improvements.

- "(2) Expenditures of funds appropriated to the Employment Department under this section are limited by section 2 (1), (3) and (4) of this 2021 Act.
- "SECTION 5. Notwithstanding any other law limiting expenditures, the amount of \$294,964,603 is established for the biennium beginning July 1, 2021, as the maximum limit for payment of expenses from federal funds, other than those described in section 3 of this 2021 Act, collected or received by the Employment Department.
- "SECTION 6. (1) For the biennium beginning July 1, 2021, expenditures by the Employment Department for unemployment insurance claims from the Unemployment Compensation Trust Fund are not limited.
- "(2) For the biennium beginning July 1, 2021, expenditures by the Employment Department for benefits paid under the federal Trade Act and for unemployment insurance claims from federal funds are not limited.
- "SECTION 7. This 2021 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect July 1, 2021."
