In addition to and not in lieu of any other appropriation, there is appro-29priated to the Judicial Department, for the biennium beginning July 1, 2021, out of the General Fund, the amount of \$334,221 for payment of expenses of the Oregon Law Commission. 30 31 "SECTION 5. In addition to and not in lieu of any other appropriation, there is appro-32priated to the Judicial Department, for the biennium beginning July 1, 2021, out of the General Fund, the amount of \$53,934 for payment of expenses of the Council on Court 33 34 **Procedures.** 35 "SECTION 6. (1) In addition to and not in lieu of any other appropriation, there is ap1 propriated to the Judicial Department, for the biennium beginning July 1, 2021, out of the

2 General Fund, the amount of \$7,492,047 for the purpose of providing conciliation and medi-3 ation services in circuit courts.

"(2) The Chief Justice of the Supreme Court shall distribute the moneys appropriated
under this section to the counties of this state to fund conciliation and mediation services
in circuit courts. The Chief Justice shall consult with the presiding judges of the circuit
courts before making the distributions.

8 "<u>SECTION 7.</u> (1) In addition to and not in lieu of any other appropriation, there is ap-9 propriated to the Judicial Department, for the biennium beginning July 1, 2021, out of the 10 General Fund, the amount of \$7,492,047 for the purpose of operating law libraries or providing 11 law library services.

12 "(2) The Chief Justice of the Supreme Court shall distribute the moneys appropriated 13 under this section to the counties of this state based on revenues received from filing fees 14 collected during the biennium ending June 30, 2021, in civil actions commenced in the circuit 15 court for the county.

16 "<u>SECTION 8.</u> (1) In addition to and not in lieu of any other appropriation, there is ap-17 propriated to the Judicial Department, for the biennium beginning July 1, 2021, out of the 18 General Fund, the amount of \$12,784,050 for the purpose of funding the Legal Services Pro-19 gram described in ORS 9.572.

"(2) The Chief Justice of the Supreme Court shall distribute all moneys appropriated
under this section to the Oregon State Bar in eight quarterly installments of equal amount.
"<u>SECTION 9.</u> Notwithstanding any other provision of law, the General Fund appropriation
made to the Judicial Department by section 1 (2), chapter 691, Oregon Laws 2019, for the
biennium ending June 30, 2021, for operations, is decreased by \$750,000.

"<u>SECTION 10.</u> Notwithstanding any other provision of law, the General Fund appropri ation made to the Judicial Department by section 1 (6), chapter 691, Oregon Laws 2019, for
 the biennium ending June 30, 2021, for third-party debt collection, is increased by \$750,000.

"<u>SECTION 11.</u> This 2021 Act being necessary for the immediate preservation of the public
 peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect
 July 1, 2021.".
