

# House Concurrent Resolution 21

Sponsored by Representative KOTEK (Pre-session filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes deadlines for completion of legislative measures for 2021 regular session of Eighty-first Legislative Assembly.

## CONCURRENT RESOLUTION

### **Be It Resolved by the Legislative Assembly of the State of Oregon:**

(1) This resolution constitutes a rule of proceeding of the Senate and the House of Representatives of the Eighty-first Legislative Assembly.

(2) The Senate and the House of Representatives shall adhere to the following schedule and deadlines for the 2021 regular session of the Eighty-first Legislative Assembly:

(a) The Senate and the House of Representatives shall convene in regular session on January 19, 2021.

(b) Before April 5, 2021, the Senate and the House of Representatives may convene their respective floor sessions as needed, as determined for the Senate by the President of the Senate and as determined for the House of Representatives by the Speaker of the House of Representatives.

(c) Members and committees shall submit requests for drafts of measures to the Office of the Legislative Counsel on or before January 15, 2021.

(d) Members and committees shall submit drafts of measures for introduction to the Senate and House Desks no later than February 23, 2021.

(e) The Senate and House of Representatives may convene daily floor sessions beginning on April 5, 2021.

(f) Committee chairpersons shall schedule work sessions for measures in the chamber of origin no later than March 19, 2021. This paragraph does not apply to the Joint Committee on Ways and Means, other joint committees, the Senate Committee on Finance and Revenue, the House Committee on Revenue, the Senate Committee on Rules, the House Committee on Rules, the Senate Committee on Redistricting and the House Committee on Redistricting.

(g) Committees shall consider measures in the chamber of origin no later than April 13, 2021. This paragraph does not apply to the Joint Committee on Ways and Means, other joint committees, the Senate Committee on Finance and Revenue, the House Committee on Revenue, the Senate Committee on Rules, the House Committee on Rules, the Senate Committee on Redistricting and the House Committee on Redistricting.

(h) Committee chairpersons shall schedule work sessions for measures in the second chamber no later than May 14, 2021. This paragraph does not apply to the Joint Committee on Ways and Means, other joint committees, the Senate Committee on Finance and Revenue, the House Committee on Revenue, the Senate Committee on Rules, the House Committee on Rules, the Senate Com-

1 mittee on Redistricting and the House Committee on Redistricting, except that this paragraph  
2 applies to the Joint Committee on Transportation.

3 (i) Committees of the Senate and House of Representatives shall close no later than May 28,  
4 2021. This paragraph does not apply to the Joint Committee on Ways and Means, other joint com-  
5 mittees, the Senate Committee on Finance and Revenue, the House Committee on Revenue, the  
6 Senate Committee on Rules, the House Committee on Rules, the Senate Committee on Redistricting  
7 and the House Committee on Redistricting, except that this paragraph applies to the Joint Commit-  
8 tee on Transportation.

9 (3) The rules of the Senate and House of Representatives shall apply to matters not specified in  
10 this resolution and shall take precedence over matters specified in this resolution. The rules of the  
11 Senate and House of Representatives may establish timelines for priority measures, for measures  
12 approved by the presiding officers, for measures approved by joint committees or for appropriation  
13 and fiscal measures approved by the Joint Committee on Ways and Means that are different from  
14 the timelines established in subsection (2) of this resolution.
