**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Extends for one year sunset on Task Force on Universal Health Care and extends deadline for task force to submit recommendations to Legislative Assembly.

Declares emergency, effective on passage.

**A BILL FOR AN ACT**

1  
2 Relating to universal health care; creating new provisions; amending sections 8 and 10, chapter 629,  
3 Oregon Laws 2019; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** Section 10, chapter 629, Oregon Laws 2019, is amended to read:

6 **Sec. 10.** Sections 1 to 9, [*of this 2019 Act*] **chapter 629, Oregon Laws 2019**, are repealed on  
7 January 2, [2022] **2023**.

8 **SECTION 2.** Section 8, chapter 629, Oregon Laws 2019, is amended to read:

9 **Sec. 8.** (1) The members of the Task Force on Universal Health Care shall be appointed no later  
10 than May 31, 2020.

11 (2) No later than September 30, 2020, the Legislative Policy and Research Office shall begin  
12 preparing a work plan for the task force.

13 (3) **No later than September 30, 2022**, the task force shall submit a report **to the Legislative**  
14 **Assembly, in the manner provided in ORS 192.245**, containing its findings and recommendations  
15 for the design of the Health Care for All Oregon Plan and the Health Care for All Oregon Board  
16 [*to the 2021 regular session of the Legislative Assembly*].

17 **SECTION 3.** **In addition to and not in lieu of any other appropriation, there is appropri-**  
18 **ated to the Oregon Health Authority, for the biennium beginning July 1, 2021, out of the**  
19 **General Fund, the amount of \$516,768, which may be expended for extending the work of the**  
20 **Task Force on Universal Health Care under section 8, chapter 629, Oregon Laws 2019, as**  
21 **amended by section 2 of this 2021 Act.**

22 **SECTION 4.** **This 2021 Act being necessary for the immediate preservation of the public**  
23 **peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect**  
24 **on its passage.**
