SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes office of Superintendent of Public Instruction as statutory office. Takes effect on passage of Senate Joint Resolution 2 (2021) at next regular general election held throughout state.

- 5 Be It Enacted by the People of the State of Oregon:
- 6 <u>SECTION 1.</u> ORS 326.300 is repealed and section 2 of this 2021 Act is enacted in lieu 7 thereof.
- 8 <u>SECTION 2.</u> (1)(a) The Governor shall appoint a Superintendent of Public Instruction, 9 who holds office at the pleasure of the Governor.
- (b) The appointment of the superintendent is subject to confirmation by the Senate as
 provided by ORS 171.562 and 171.565.
- (2) In addition to any duties and powers prescribed by law, the superintendent shall su pervise and control the Department of Education.
- (3) The superintendent shall receive a salary set by the Governor, and shall be reim bursed for all expenses actually and necessarily incurred by the superintendent in the per-
