

## SENATE AMENDMENTS TO SENATE BILL 232

- 1 In line 2 of the printed bill, after the semicolon insert “amending ORS 342.448;”.
- 2 Delete lines 4 through 12 and insert:
- 3 “**SECTION 1.** ORS 342.448 is amended to read:
- 4 “342.448. (1) Representatives of the [*Education and Workforce Policy Advisor*] **Educator Ad-**
- 5 **vancement Council**, the Higher Education Coordinating Commission, the Department of Education
- 6 and the Teacher Standards and Practices Commission shall jointly create a report on the Educators
- 7 Equity Act. The report shall **be created in consultation with educator preparation providers**
- 8 **and shall** include:
- 9 “(a) A summary of the most recent data collected as provided by ORS 342.443 **(1)(d) to (h)**.
- 10 “(b) A summary of the plans currently implemented as provided by ORS 342.447.
- 11 “(c) [*Recommendations for meeting*] **A review of** the goal described in ORS 342.437, including:
- 12 “**(A) Determination of the need for additional related state goals.**
- 13 “**(B) Progress made by the state** toward meeting the goal described in ORS 342.437 **and any**
- 14 **other additional related state goals.**
- 15 “**(C) Recommendations and a long-term plan for meeting the goal described in ORS**
- 16 **342.437 and any other additional related state goals.**
- 17 “(d) A description of best practices within this state and other states for recruiting, hiring and
- 18 retaining diverse educators.
- 19 “**(e) Recommendations for legislation to help the state meet the goal described in ORS**
- 20 **342.437 and any other additional related state goals.**
- 21 “(2)(a) The report created as provided by subsection (1) of this section shall be submitted:
- 22 “(A) To the interim legislative committees on education [*in each even-numbered*] **by September**
- 23 **1 of each even-numbered** year; and
- 24 “(B) To the Legislative Assembly in the manner provided by ORS 192.245 [*in each*
- 25 *odd-numbered*] **by September 1 of each even-numbered** year.
- 26 “(b) The report submitted as required by paragraph (a)(B) of this subsection shall be submitted
- 27 with the data reported as required by ORS 342.443 **(1)(d) to (h)**.
- 28 “(3) The [*Education and Workforce Policy Advisor*] **Educator Advancement Council**, the Higher
- 29 Education Coordinating Commission, the Department of Education and the Teacher Standards and
- 30 Practices Commission shall make the report submitted as provided under subsection (2) of this sec-
- 31 tion available on the website of each agency.
- 32 “**SECTION 2. This 2021 Act being necessary for the immediate preservation of the public**
- 33 **peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect**
- 34 **on its passage.”.**
