

Senate Bill 300

Sponsored by Senator RILEY (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes State Board of Towing within Department of Transportation. Authorizes board to order department to deny, suspend, revoke or refuse to renew towing business certificate or letter of appointment to participate on rotational list of towing businesses for certain violations. Authorizes board to impose civil penalties for certain violations.

Becomes operative January 1, 2022.

Declares emergency, effective on passage.

2 Relating to towing; creating new provisions; amending ORS 646.608 and 822.215; repealing ORS
3 98.864; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. State Board of Towing; membership; term; compensation and expenses. (1)**

6 **The State Board of Towing is established within the Department of Transportation.**

7 **(2) The State Board of Towing consists of nine members appointed by the Governor as**
8 **follows:**

9 **(a) One tower who holds a towing business certificate issued under ORS 822.205 and who**
10 **represents a city in Oregon with a population of 100,000 or more;**

11 **(b) One tower who holds a towing business certificate issued under ORS 822.205 and who**
12 **represents a city in Oregon with a population of less than 100,000;**

13 **(c) One tower who holds a towing business certificate issued under ORS 822.205 and who**
14 **has specialized knowledge in towing equipment and vehicles with a gross vehicle weight rat-**
15 **ing of more than 44,000 pounds;**

16 **(d) One tower who holds a towing business certificate issued under ORS 822.205 and who**
17 **has specialized knowledge in towing vehicles with a gross vehicle weight rating of 26,000**
18 **pounds or less;**

19 **(e) One member who represents the insurance industry;**

20 **(f) One member from a tow program within the Department of State Police;**

21 **(g) One member who is a chief of police;**

22 **(h) One member who is a member of the public; and**

23 **(i) One member who is a consumer advocate.**

24 **(3) All members of the board must be residents of Oregon.**

25 **(4) The term of office of each member of the board is four years, but a member serves**
26 **at the pleasure of the Governor. Before the expiration of the term of a member, the Gover-**
27 **nor shall appoint a successor whose term begins on July 1 next following. A member is eli-**
28 **gible for reappointment. If there is a vacancy for any cause, the Governor shall make an**
29 **appointment to become immediately effective for the unexpired term.**

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (5) A member of the board is entitled to compensation and expenses as provided in ORS
2 292.495.

3 **SECTION 2. Initial terms of office.** Notwithstanding the term of office specified by sec-
4 tion 1 of this 2021 Act, of the members first appointed to the State Board of Towing:

5 (1) Two shall serve for a term ending July 1, 2022.

6 (2) Two shall serve for a term ending July 1, 2023.

7 (3) Two shall serve for a term ending July 1, 2024.

8 (4) Three shall serve for a term ending July 1, 2025.

9 **SECTION 3. Officers; quorum; meetings.** (1) The State Board of Towing shall select one
10 of its members as chairperson and another as vice chairperson, for terms and with duties
11 and powers necessary for the performance of the functions of the offices as the board de-
12 termines.

13 (2) Except as provided in subsection (3) of this section, a majority of the members of the
14 board constitutes a quorum for the transaction of business.

15 (3) When the board is deliberating or voting on a matter before it, four members of the
16 board constitute a quorum.

17 (4) No more than two members who are towers may vote on any matter. The chairperson
18 shall assign a rotation of voting members who are towers. If an assigned member who is a
19 tower has an actual or potential conflict of interest in a matter before the board, the chair-
20 person shall designate a different member who is a tower and who does not have an actual
21 or potential conflict of interest in the matter before the board to deliberate and vote on that
22 matter.

23 (5) The board shall meet at least once a quarter at a time and place determined by the
24 board. The board shall also meet at such other times and places as are specified by the call
25 of the chairperson, vice chairperson or administrative officer.

26 **SECTION 4. Administrative officer for board; other employees.** (1) The State Board of
27 Towing shall appoint an administrative officer to serve at the pleasure of the Governor. The
28 determination of qualifications of the administrative officer and appointment of the admin-
29 istrative officer shall be made by the board after consulting with the Governor.

30 (2) The administrative officer may not be a member of the board.

31 (3) The designation of the administrative officer must be by written order, filed with the
32 Secretary of State.

33 (4) The administrative officer is in the unclassified service under ORS chapter 240, and
34 the board shall fix the salary of the administrative officer in accordance with the applicable
35 provisions of ORS chapter 240.

36 (5) Subject to any applicable provisions of ORS chapter 240, the administrative officer
37 shall appoint all subordinate officers and employees of the board, prescribe their duties and
38 fix their compensation.

39 **SECTION 5. Rulemaking authority; board seal.** (1) In accordance with applicable pro-
40 visions of ORS chapter 183, the State Board of Towing may adopt rules:

41 (a) Necessary for the administration of the laws that the board is charged with admin-
42 istering.

43 (b) To implement ORS 98.853 to 98.862.

44 (2) The board may adopt a seal.

45 **SECTION 6. State Board of Towing Account.** (1) The State Board of Towing Account is

1 established in the State Treasury, separate and distinct from the General Fund.

2 (2) The account consists of the following:

3 (a) Moneys collected from fees imposed under section 9 of this 2021 Act.

4 (b) Moneys appropriated to the account by the Legislative Assembly.

5 (c) Moneys from any other source.

6 (3) Moneys in the account are continuously appropriated to the Department of Trans-
7 portation to carry out the provisions of sections 1 to 11 of this 2021 Act.

8 **SECTION 7. Administration of oaths; obtaining and taking evidence at board proceedings;**
9 **effect of failure to obey board subpoena.** The State Board of Towing, acting through its
10 chairperson or vice chairperson, may administer oaths, take depositions and issue subpoenas
11 to compel the attendance of witnesses and the production of documents or other written
12 information necessary to carry out the provisions of sections 1 to 11 of this 2021 Act. If any
13 person fails to comply with a subpoena issued under this section or refuses to testify on
14 matters on which the person lawfully may be interrogated, the procedure set out in ORS
15 183.440 shall be followed to compel obedience.

16 **SECTION 8. Denial, suspension, revocation or refusal of towing business certificate.** (1)
17 **As used in this section:**

18 (a) "Person" includes individuals, public bodies as defined in ORS 174.109, corporations,
19 firms, associations, partnerships, limited liability companies, joint stock companies or any
20 other business entity created under law.

21 (b) "Relative" means an individual related within the third degree as determined by the
22 common law, a spouse, an individual related to a spouse within the third degree as deter-
23 mined by the common law or an individual in an adoptive relationship within the third degree
24 as determined by the common law.

25 (2) In addition to any other penalty provided under ORS 822.215 and subject to ORS
26 chapter 183, the State Board of Towing may order the Department of Transportation to deny,
27 suspend, revoke or refuse to renew a towing business certificate issued under ORS 822.205,
28 if the person holding or applying for the certificate:

29 (a) Fails to comply with any rule adopted by the board;

30 (b) Violates any provision of, or rules or ordinances adopted under, ORS 98.853, 98.854,
31 98.856, 98.858, 181A.350, 822.200, 822.215, 822.225, 822.230, 822.235 or 822.605;

32 (c) Fails to comply with an order of the board, including but not limited to the failure to
33 pay a civil penalty as ordered by the board;

34 (d) Has performed work as a tower without the appropriate certification or letter of ap-
35 pointment to participate on the rotational list of towing businesses established under ORS
36 181A.350, or has employed individuals to perform work as towers without appropriate certi-
37 fication or letter of appointment;

38 (e) Has advertised or otherwise held themselves out as being a certified towing business
39 without holding the appropriate certification;

40 (f) As a, or as a relative of a, partner, officer, member or employee of a towing business,
41 advertises or holds themselves out as a towing business that is certified if the towing busi-
42 ness does not possess the appropriate certification;

43 (g) Has engaged in towing or recovering by any means, as part of any business operation
44 of the person, vehicles that are wrecked, damaged, disabled or abandoned or replacement
45 vehicles;

1 (h) Fails to meet any condition or requirement to obtain a certificate or letter of ap-
 2 pointment;

3 (i) Acts or has acted in a manner creating a serious danger to the public health or safety;
 4 or

5 (j) Has been subject to a revocation, cancellation or suspension order or to other disci-
 6 plinary action related to towing or the towing industry by any other public body, as defined
 7 in ORS 174.109, or has failed to pay a civil penalty imposed by the public body.

8 (3) A violation described in subsection (2) of this section for which the board orders that
 9 the department deny, suspend, revoke or refuse to renew a certificate to perform work or
 10 conduct business may be treated as a failure to be in conformance with sections 1 to 11 of
 11 this 2021 Act.

12 (4) A person subject to discipline under this section is entitled to a contested case hear-
 13 ing in accordance with ORS chapter 183.

14 (5) The board is the agency responsible for providing notice and contested case hearing
 15 rights under ORS chapter 183 to a person subject to discipline under this section.

16 **SECTION 9. Additional powers of the board.** (1) In carrying out its investigative and
 17 enforcement duties, functions and powers, and notwithstanding any other provision of law,
 18 the State Board of Towing may procure services and award a contract for the personal ser-
 19 vices of a subject matter expert, on a case-by-case basis, in any manner deemed practical
 20 or convenient. The price of such contracts, including any amendments, may not exceed
 21 \$25,000.

22 (2) If the board has reason to believe that any person has been engaged or is engaging
 23 in any violation of ORS 98.853, 98.854, 98.856, 98.858, 181A.350, 822.200, 822.215, 822.225, 822.230,
 24 822.235 or 822.605 or sections 1 to 11 of this 2021 Act or any rule adopted under those stat-
 25 utes, or any order issued by the board, the board may, without bond, bring suit in the name
 26 and on behalf of the State of Oregon in the circuit court of any county of this state to enjoin
 27 the acts or practices and to enforce compliance with ORS 98.853, 98.854, 98.856, 98.858,
 28 181A.350, 822.200, 822.215, 822.225, 822.230, 822.235 or 822.605 or sections 1 to 11 of this 2021
 29 Act or any rule adopted under those statutes, or any order issued by the board. Upon a
 30 proper showing, a permanent or temporary injunction, restraining order or writ of
 31 mandamus shall be granted.

32 (3) The board, by rule, may impose a fee on any person holding or applying for a towing
 33 business certificate. The amount of the fee shall be established to recover expenses incurred
 34 by the board in carrying out sections 1 to 11 of this 2021 Act. Any fees collected under this
 35 subsection shall be deposited into the State Board of Towing Account established under
 36 section 6 of this 2021 Act.

37 **SECTION 10. Participation in the Department of State Police tow rotation.** (1) As used
 38 in this section:

39 (a) "Person" includes individuals, public bodies as defined in ORS 174.109, corporations,
 40 firms, associations, partnerships, limited liability companies, joint stock companies or any
 41 other business entity created under law.

42 (b) "Relative" means an individual related within the third degree as determined by the
 43 common law, a spouse, an individual related to a spouse within the third degree as deter-
 44 mined by the common law or an individual in an adoptive relationship within the third degree
 45 as determined by the common law.

1 (2) Subject to ORS chapter 183, the State Board of Towing may order the Department
 2 of State Police to deny, suspend, condition or revoke a letter of appointment to participate
 3 on the rotational list of towing businesses established under ORS 181A.350, if the person
 4 holding or applying for the letter of appointment:

5 (a) Fails to comply with any rule adopted by the board;

6 (b) Violates any provision of, or rules or ordinances adopted under, ORS 98.853, 98.854,
 7 98.856, 98.858, 181A.350, 822.200, 822.215, 822.225, 822.230, 822.235 or 822.605;

8 (c) Fails to comply with an order of the board, including but not limited to the failure to
 9 pay a civil penalty as ordered by the board;

10 (d) Has performed work as a tower without the appropriate certification or letter of ap-
 11 pointment or has employed individuals to perform work as towers without appropriate cer-
 12 tification or letter of appointment;

13 (e) Has advertised or otherwise held themselves out as being a certified tower without
 14 holding the appropriate certification;

15 (f) As a, or as a relative of a, partner, officer, member or employee of a towing business,
 16 advertises or holds themselves out as a towing business that is certified if the towing busi-
 17 ness does not possess the appropriate certification;

18 (g) Has engaged in towing or recovering by any means, as part of any business operation
 19 of the person, vehicles that are wrecked, damaged, disabled or abandoned or replacement
 20 vehicles;

21 (h) Fails to meet any condition or requirement to obtain a certificate or letter of ap-
 22 pointment;

23 (i) Acts or has acted in a manner creating a serious danger to the public health or safety;
 24 or

25 (j) Has been subject to a revocation, cancellation or suspension order or to other disci-
 26 plinary action related to towing or the towing industry by any other public body, as defined
 27 in ORS 174.109, or has failed to pay a civil penalty imposed by the public body.

28 (3) A violation described in subsection (2) of this section for which the board orders the
 29 department to deny, suspend, condition or revoke a letter of appointment to participate on
 30 the rotational list of towing business established under ORS 181A.350 may be treated as a
 31 failure to be in conformance with sections 1 to 11 of this 2021 Act.

32 (4) A person subject to discipline under this section is entitled to a contested case hear-
 33 ing in accordance with ORS chapter 183.

34 (5) The board is the agency responsible for providing notice and contested case hearing
 35 rights under ORS chapter 183 to a person subject to discipline under this section.

36 **SECTION 11. Civil penalties; factors; rules.** (1) In addition to any other penalty provided
 37 by law, any person who violates any provision of ORS 98.853, 98.854, 98.856, 98.858, 181A.350,
 38 822.200, 822.215, 822.225, 822.230, 822.235 or 822.605 or any rule adopted by the State Board of
 39 Towing is subject to payment of a civil penalty to the board.

40 (2) The board may adopt rules establishing a schedule of civil penalties that may be im-
 41 posed under this section. Civil penalties imposed under this section may not exceed \$25,000
 42 for each violation.

43 (3) Civil penalties under this section shall be imposed as provided in ORS 183.745.

44 (4) In imposing a penalty pursuant to the schedule adopted under subsection (2) of this
 45 section, the board shall consider the following factors:

1 **(a) The past history of the person incurring a penalty in taking all feasible steps or pro-**
 2 **cedures necessary or appropriate to correct any violation.**

3 **(b) Any prior violations by the person incurring the penalty of statutes, rules or orders**
 4 **pertaining to facilities.**

5 **(c) The economic and financial conditions of the person incurring the penalty.**

6 **(d) The immediacy and extent to which a violation threatens the public health or safety.**

7 **SECTION 12.** ORS 646.608 is amended to read:

8 646.608. (1) A person engages in an unlawful practice if in the course of the person's business,
 9 vocation or occupation the person does any of the following:

10 (a) Passes off real estate, goods or services as the real estate, goods or services of another.

11 (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-
 12 proval, or certification of real estate, goods or services.

13 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-
 14 ciation with, or certification by, another.

15 (d) Uses deceptive representations or designations of geographic origin in connection with real
 16 estate, goods or services.

17 (e) Represents that real estate, goods or services have sponsorship, approval, characteristics,
 18 ingredients, uses, benefits, quantities or qualities that the real estate, goods or services do not have
 19 or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the
 20 person does not have.

21 (f) Represents that real estate or goods are original or new if the real estate or goods are de-
 22 teriorated, altered, reconditioned, reclaimed, used or secondhand.

23 (g) Represents that real estate, goods or services are of a particular standard, quality, or grade,
 24 or that real estate or goods are of a particular style or model, if the real estate, goods or services
 25 are of another.

26 (h) Disparages the real estate, goods, services, property or business of a customer or another
 27 by false or misleading representations of fact.

28 (i) Advertises real estate, goods or services with intent not to provide the real estate, goods or
 29 services as advertised, or with intent not to supply reasonably expectable public demand, unless the
 30 advertisement discloses a limitation of quantity.

31 (j) Makes false or misleading representations of fact concerning the reasons for, existence of,
 32 or amounts of price reductions.

33 (k) Makes false or misleading representations concerning credit availability or the nature of the
 34 transaction or obligation incurred.

35 (L) Makes false or misleading representations relating to commissions or other compensation to
 36 be paid in exchange for permitting real estate, goods or services to be used for model or demon-
 37 stration purposes or in exchange for submitting names of potential customers.

38 (m) Performs service on or dismantles any goods or real estate if the owner or apparent owner
 39 of the goods or real estate does not authorize the service or dismantling.

40 (n) Solicits potential customers by telephone or door to door as a seller unless the person pro-
 41 vides the information required under ORS 646.611.

42 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give
 43 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of
 44 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or
 45 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,

1 discount or other value is contingent upon an event occurring after the time the customer enters
2 into the transaction.

3 (p) Makes any false or misleading statement about a prize, contest or promotion used to publi-
4 cize a product, business or service.

5 (q) Promises to deliver real estate, goods or services within a certain period of time with intent
6 not to deliver the real estate, goods or services as promised.

7 (r) Organizes or induces or attempts to induce membership in a pyramid club.

8 (s) Makes false or misleading representations of fact concerning the offering price of, or the
9 person's cost for real estate, goods or services.

10 (t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any
11 known material defect or material nonconformity.

12 (u) Engages in any other unfair or deceptive conduct in trade or commerce.

13 (v) Violates any of the provisions relating to auction sales, consignment sales, auctioneers,
14 consignees or auction marts under ORS 698.640, whether in a commercial or noncommercial situ-
15 ation.

16 (w) Manufactures mercury fever thermometers.

17 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal
18 law, or is:

19 (A) Prescribed by a person licensed under ORS chapter 677; and

20 (B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and
21 on the proper cleanup of mercury should breakage occur.

22 (y) Sells a thermostat that contains mercury unless the thermostat is labeled in a manner to
23 inform the purchaser that mercury is present in the thermostat and that the thermostat may not be
24 disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the
25 mercury does not become part of the solid waste stream or wastewater. For purposes of this para-
26 graph, "thermostat" means a device commonly used to sense and, through electrical communication
27 with heating, cooling or ventilation equipment, control room temperature.

28 (z) Sells or offers for sale a motor vehicle manufactured after January 1, 2006, that contains
29 mercury light switches.

30 (aa) Violates the provisions of ORS 803.375, 803.385 or 815.410 to 815.430.

31 (bb) Violates ORS 646A.070 (1).

32 (cc) Violates any requirement of ORS 646A.030 to 646A.040.

33 (dd) Violates the provisions of ORS 128.801 to 128.898.

7 (5) Notwithstanding any other provision of ORS 336.184 and 646.605 to 646.652, if an action or
 8 suit is brought under subsection (1)(xx) of this section by a person other than a prosecuting attor-
 9 ney, relief is limited to an injunction and the prevailing party may be awarded reasonable attorney
 10 fees.

11 **SECTION 13.** ORS 822.215 is amended to read:

12 822.215. (1) The Department of Transportation may deny or refuse to issue any towing business
 13 certificate under ORS 822.205 or may suspend, revoke or refuse to renew any towing business cer-
 14 tificate issued upon proof that the applicant for or holder of the certificate has done any of the
 15 following:

16 [(1)] (a) Used fraud or deception in securing the certificate.

17 [(2)] (b) Received in any manner or by any device any rebate or other additional fee for towing
 18 or recovery from a person who performs repairs on a vehicle who does not also own the vehicle.
 19 This [subsection] **paragraph** does not prohibit the payment of the towing fee by a person who per-
 20 forms repairs on a vehicle if the fee is included in the charges by that person for repairs on the
 21 vehicle.

22 [(3)] (c) Used vehicles for the purposes of towing or recovering services that did not meet the
 23 minimum safety standards established by the department.

24 [(4)] (d) Failed to display special towing business registration plates, stickers or indicia or
 25 identification devices for proportionally registered tow vehicles authorized under ORS 805.200 on
 26 each vehicle used to tow or recover vehicles.

27 [(5)] (e) Failed to maintain the amounts and types of insurance required to qualify for issuance
 28 of a towing business certificate under ORS 822.205.

29 [(6)] (f) Failed to obtain any permits or authority required under any provision of ORS chapter
 30 825 or rules adopted thereunder.

31 [(7)] (g) Violated any provision of ORS 98.853, 98.854, 98.856 or 98.858 or a rule adopted under
 32 [ORS 98.864] **section 5 of this 2021 Act.**

33 **(2) After receiving an order from the State Board of Towing under section 8 of this 2021**
 34 **Act, the department shall impose the disciplinary action requested by the board.**

35 **SECTION 14.** ORS 98.864 is repealed.

36 **SECTION 15. Section captions.** The section captions used in this 2021 Act are provided
 37 only for the convenience of the reader and do not become part of the statutory law of this
 38 state or express any legislative intent in the enactment of this 2021 Act.

39 **SECTION 16. Operative date.** (1) Sections 1 to 11 of this 2021 Act, the amendments to
 40 ORS 646.608 and 822.215 by sections 12 and 13 of this 2021 Act and the repeal of ORS 98.864
 41 by section 14 of this 2021 Act become operative on January 1, 2022.

42 (2) The members of the State Board of Towing may be appointed before the operative
 43 date specified in subsection (1) of this section, and the board and the Department of Trans-
 44 portation may take any action before the operative date specified in subsection (1) of this
 45 section that is necessary to enable the board and the department to exercise, on and after

1 the operative date specified in subsection (1) of this section, the duties, functions and powers
2 of the board and the department pursuant to sections 1 to 11 of this 2021 Act, the amend-
3 ments to ORS 646.608 and 822.215 by sections 12 and 13 of this 2021 Act and the repeal of ORS
4 98.864 by section 14 of this 2021 Act.

5 SECTION 17. Effective date. This 2021 Act being necessary for the immediate preserva-
6 tion of the public peace, health and safety, an emergency is declared to exist, and this 2021
7 Act takes effect on its passage.
