A-Engrossed Senate Bill 334

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Requires directors of school districts and education service districts, superintendents of schools districts and education service districts, members of public charter school governing bodies and principals of public charter schools to receive specified training. Prescribes requirements of training.]

Requires governing body of public education provider to conduct self-assessment every two years and to use self-assessment to develop and refine professional learning plan for persons in leadership positions of public education provider. Prescribes requirements for professional learning plans.

Directs Department of Education to establish advisory group on professional learning and training to assist public education providers with professional learning and training. Declares emergency, effective July 1, 2021.

Be It Enacted by the People of the State of Oregon: 5 6 SECTION 1. (1) As used in this section: (a) "Governing body" means: 7 8 (A) For a school district, the school district board. 9 (B) For an education service district, the board of directors of the education service 10 district. (C) For a public charter school, the governing body of the public charter school. 11 12(b) "Persons in leadership positions" means: 13 (A) For a school district, the directors of the school district and the superintendent of the school district. 14 15 (B) For an education service district, the directors of the education service district and the superintendent of the education service district. 16 17 (C) For a public charter school, the members of the governing body of the public charter school and the principal or executive director of the public charter school. 18 19 (c) "Public education provider" means a school district, an education service district or a public charter school. 20(2)(a) Every two years, the governing body of a public education provider shall conduct 21a self-assessment. The self-assessment shall be used to develop and refine a professional 2223learning plan described in subsection (3) of this section.

(b) A self-assessment may be conducted using a method developed by a statewide repre-1 2 sentative of school district boards or a comparable method selected by the governing body, but must: 3 (A) Focus on education equity and board governance practices that are evidence-based 4 and produce improved equitable outcomes; and 5 (B) Include a review of any relevant data on student progress, access and opportunity 6 and a review of improvement plans and budgets. 7 (3)(a) The governing body of each public education provider shall develop or revise a 8 9 professional learning plan for persons in leadership positions. The professional learning plan shall be based on: 10 (A) The self-assessment conducted under subsection (2) of this section; 11 12(B) Shared professional learning goals identified by the governing body; and 13 (C) Progress made by the governing body on any previously developed professional learning plans. 14 15 (b) A professional learning plan shall address the following: (A) Ongoing professional learning and training in educational equity and board 16 governance that persons in leadership positions must complete together in order to support 17 18 student success, with an emphasis on students from historically underserved and underrepresented communities; 19 (B) Professional learning and training requirements for board members interested in 20serving as the chairperson or the vice chairperson of the governing body, which must be 2122satisfied before a person may become a chairperson or vice chairperson; 23(C) Professional learning and training requirements for new members of the governing body of the public education provider, which must be completed within 180 days of any 24 elections or appointments; and 25(D) Any additional goals or elements identified by the governing body. 2627(c) A professional learning plan must be adopted by the governing body at a public meeting. 28(4) No later than July 1 of each year, the governing body of each public education pro-2930 vider must produce a report on the implementation of the professional learning plan for the 31 public education provider. The report must be presented at a public meeting of the governing body and must be made available for public access. 32SECTION 2. The governing body of each public education provider must complete the 33 34 first self-assessment, as described in section 1 of this 2021 Act, no later than September 1, 2022. 35 SECTION 3. (1) The Department of Education shall establish an advisory group on pro-36 37 fessional learning and training to assist public education providers in complying with the 38 requirements of section 1 of this 2021 Act. (2) The advisory group established under this section shall consist of: 39 (a) Representatives of organizations representing school board members; 40 (b) Representatives of organizations representing school district administrators; 41 (c) Representatives of organizations representing education service districts; 42 (d) Representatives of public charter schools; 43 (e) Experts in professional learning and training for school board members; 44 (f) Students and stakeholders representing historically underserved and underrepre-45

sented communities; and 1 2 (g) A representative of the Teacher Standards and Practices Commission. (3) Taking equity and current research on school board governance best practices into 3 consideration, the advisory group shall advise and support the department with: 4 (a) The development and adoption of resources, tools and templates to provide profes-5 sional learning and training related to education equity and board governance, including 6 guidance with the self-assessment required under section 1 of this 2021 Act. 7 (b) The development of a framework that can be used to support the professional learning 8 9 and training of persons in leadership positions, as defined in section 1 of this 2021 Act. The framework must be reviewed and revised at least once every five years. The framework shall: 10 (A) Include guidance issued by the department related to professional learning and 11 12training; 13 (B) Prescribe minimum professional learning and training requirements for prospective persons in leadership positions; 14 15 (C) Provide tools and templates to assist governing bodies of public education providers in complying with the requirements of section 1 of this 2021 Act; and 16 (D) Assist persons in leadership positions with the development of the following skills: 1718 (i) Focusing on improving student progress, access, opportunity and outcomes, with an emphasis on students from underserved and underrepresented communities; 19 20(ii) Embedding a consideration of equity into the development of policies and practices to ensure policies and practices are equitable; 2122(iii) Prioritizing education equity and governance; 23(iv) Being aware of, and using, research and promising practices when developing policies 24and practices; (v) Using a continuous improvement approach and ongoing professional learning and 25training; 2627(vi) Aiming to foster stronger collaborations between all persons in leadership positions of the public education provider; and 28(vii) Supporting the development of professional learning goals, plans and progress 2930 measures. 31 (c) The creation of a directory of persons who are qualified to provide professional learning and training that align with the goals of the framework described in paragraph (b) 32of this subsection. For the directory, the advisory group must prescribe: 33 34 (A) The minimum requirements for being included in the directory; 35 (B) The process for being included in the directory; and (C) The availability of the directory, which must be available online. 36 37 (d) The development and provision of timelines, communications and technical support provided to public education providers. 38 (4) The department shall create and manage a professional learning and training fund 39 that can accept public and private moneys to support public education providers with their 40 professional learning and training. The department must consider equity when distributing 41 moneys from the fund. 42 (5) The State Board of Education may adopt any rules necessary for the administration 43 of this section. 44

2 332.005. (1) The directors of a school district in their official capacity shall be known as the 3 district school board.

4 (2) Directors must qualify by taking an oath of office before assuming the duties of office.

9 (a) "Instructional assistant" has the meaning given that term in ORS 342.120.

(b) "Intern teacher" means a regularly enrolled candidate of an approved educator preparation provider, as defined in ORS 342.120, who teaches under the supervision of the staff of the provider and of the employing district in order to acquire practical experience in teaching and for which the candidate receives both academic credit from the provider and financial compensation from the school district or education service district.

15 (2) A district school board may:

(a) Employ a superintendent of schools and necessary assistant superintendents for the district
and fix the terms and conditions of employment and the compensation. The district school board
[shall] may not contract with a superintendent for more than a period of three years at a time. The

successor.

42 (4) A newly appointed director of an education service district shall take office at the meeting
43 of the education service district board next following the appointment.

334.225. (1) The education service district board shall employ a superintendent who must hold 2930 an administrative license as a superintendent. The superintendent shall serve as the board's execu-31 tive officer, give an official bond or an irrevocable letter of credit issued by an insured institution, as defined in ORS 706.008, and have the duties prescribed by the board and the laws of this state. 32The board shall fix the term and compensation of the superintendent, provide office room for the 33 34 superintendent and allow all of the superintendent's necessary traveling expenses.

1 (b) Each member of a proposed public charter school governing body must:

2 (A) Comply with the training requirements provided in section 1 of this 2021 Act; and

3 **(B)** Provide an acknowledgment of understanding related to the standards of conduct and the 4 liabilities of a director of a nonprofit organization, as those standards and liabilities are described 5 in ORS chapter 65, if the public charter school is organized as required by ORS 338.035 (2)(a)(B) and 6 (C).

7 (4) At the request of the applicant, the school district board may provide technical assistance 8 in developing the proposal for operation of the public charter school.

(a) Is compatible with the budget and accounting system of the sponsor of the school; and

(b) Complies with the requirements of the uniform budget and accounting system adopted by ruleof the State Board of Education under ORS 327.511.

(2) A public charter school shall report to the sponsor and the Department of Education at least annually on the performance of the school and its students. A public charter school shall disclose in its report information necessary to make a determination of compliance with the requirements of this chapter. The sponsor or the sponsor's designee at least annually shall visit the public charter school site and review the public charter school's compliance with the terms and provisions of the charter.

(3) Except for a public charter school that is not required to comply with ORS 338.035 (2)(a)(B)
and (C) as provided by ORS 338.035 (2)(b), the public charter school shall have an annual audit of
the accounts of the public charter school prepared in accordance with the Municipal Audit Law,

3 (6) The State Board of Education may require public charter schools to file reports with the 4 Department of Education as necessary to enable the department to gather information on public 5 charter schools for inclusion in the Oregon Report Card issued pursuant to ORS 329.115.

6 <u>SECTION 11.</u> This 2021 Act being necessary for the immediate preservation of the public 7 peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect 8 July 1, 2021.
