## SENATE AMENDMENTS TO A-ENGROSSED SENATE BILL 48

1	On page 1 of the printed A-engrossed bill, line 2, after "ORS" delete the rest of the line and
<b>2</b>	delete line 3 and insert "135.235, 135.240, 135.245 and 135.247 and section 1, chapter,
3	Oregon Laws 2021 (Enrolled House Bill 3273); and repealing ORS 135.242.".
4	Delete lines 7 through 16 and delete pages 2 through 7 and insert:
5	"SECTION 2. (1) The presiding judge of a judicial district shall enter a standing pretrial
6	release order specifying to the sheriff of the county, or to the entity supervising the local
7	correctional facility responsible for pretrial incarceration within the judicial district, those
8	persons and offenses:
9	"(a) Subject to release on recognizance;
10	"(b) Subject to release with special conditions as specified in the order; and
11	"(c) That are not eligible for release until arraignment.
12	"(2) The Chief Justice of the Supreme Court, with input from a criminal justice advisory
13	committee appointed by the Chief Justice, shall establish release guidelines for the pretrial
14	release orders described in this section to:
15	"(a) Provide consistent release decision-making structure across the state;
16	"(b) Reduce reliance on the use of security;
17	"(c) Include provisions for victim notification and input; and
18	"(d) Balance the rights of the defendant and presumption of pretrial release against
19	community and victim safety and the risk of failure to appear.
20	"SECTION 3. ORS 135.235 is amended to read:
21	"135.235. (1) [If directed by the] A presiding judge for a judicial district[, a release assistance of-
22	ficer, and release assistance deputies who shall be responsible to the release assistance officer, shall
23	be appointed] may appoint release assistance officers under a personnel plan established by the
24	Chief Justice of the Supreme Court.
25	"(2) [The] A release assistance officer shall, except when impracticable, interview every person
26	detained pursuant to law and charged with an offense. If the person is charged with a person
27	felony or person Class A misdemeanor, as those terms are defined in the rules of the Oregon
28	Criminal Justice Commission, or with contempt of court for violating a court order protect-
29	ing or prohibiting contact with another person, the release assistance officer shall make
30	reasonable efforts to contact the victim prior to submitting a report or making a release
31	decision under subsection (3) of this section. If the release assistance officer is able to con-
32	tact the victim:
33	"(a) Information regarding the victim's position on release, including whether special
	and a second statement of the second second to the second second second second second second second second second

release conditions should be imposed, must be included in the report described in subsection
(3) of this section, and considered by the release assistance officer if the officer makes the

2 "(b) If the information is available, the release assistance officer shall inform the victim 3 of the location, date and time of the defendant's arraignment or other first appearance.

"(3) The release assistance officer shall verify release criteria information and may either:

5 "(a) Timely submit a written report to the magistrate containing, but not limited to, an evalu-6 ation of the release criteria and a recommendation for the form of release; or

"(b) If delegated release authority by the presiding judge for the judicial district, make the re-lease decision.

9 "(4) As used in this section, 'victim' means an individual that the charging instrument 10 indicates is the victim of the alleged offense or the person protected by the court order, 11 whether or not the individual is specifically named, so long as the release assistance officer 12 is able to confirm the identity of the individual.

"SECTION 4. ORS 135.240 is amended to read:

14 "135.240. (1) Except as provided in subsections (2)[,] and (4) [and (5)] of this section, a defendant 15 shall be released in accordance with ORS 135.230 to 135.290.

"(2)(a) When the defendant is charged with murder, aggravated murder or treason, release shall be denied when the proof is evident or the presumption strong that the person is guilty.

"(b) When the defendant is charged with murder or aggravated murder and the proof is not evident nor the presumption strong that the defendant is guilty, the court shall determine the issue of release as provided in subsection (4) of this section. In determining the issue of release under subsection (4) of this section, the court may consider any evidence used in making the determination required by this subsection.

23 "(3) The magistrate may conduct such hearing as the magistrate considers necessary to deter-24 mine whether, under subsection (2) of this section, the proof is evident or the presumption strong 25 that the person is guilty.

26 "(4)(a) [Except as otherwise provided in subsection (5) of this section,] When the defendant is 27 charged with a violent felony, release shall be denied if the court finds:

"(A) Except when the defendant is charged by indictment, that there is probable cause to believe
that the defendant committed the crime; and

30 "(B) By clear and convincing evidence, that there is a danger of physical injury or sexual 31 victimization to the victim or members of the public by the defendant while on release.

32 "(b) If the defendant wants to have a hearing on the issue of release, the defendant must request 33 the hearing at the time of arraignment in circuit court. If the defendant requests a release hearing, 34 the court must hold the hearing within five days of the request.

35 "(c) At the release hearing, unless the state stipulates to the setting of security or release, the 36 court shall make the inquiry set forth in paragraph (a) of this subsection. The state has the burden 37 of producing evidence at the release hearing subject to ORS 40.015 (4).

38 "(d) The defendant may be represented by counsel and may present evidence on any relevant 39 issue. However, the hearing may not be used for purposes of discovery.

40 "(e) If the court determines that the defendant is eligible for release in accordance with this 41 subsection, the court shall set security or other appropriate conditions of release.

"(f) When a defendant who has been released violates a condition of release and the violation:

43 "(A) Constitutes a new criminal offense, the court shall cause the defendant to be taken back
44 into custody and shall order the defendant held pending trial without release.

45 "(B) Does not constitute a new criminal offense, the court may order the defendant to be taken

back into custody[,] and may order the defendant held pending trial [and may set a security amount
of not less than \$250,000] or may make a new release decision.

3 "[(5)(a) Notwithstanding any other provision of law, the court shall set a security amount of not 4 less than \$50,000 for a defendant charged with an offense listed in ORS 137.700 or 137.707 unless the 5 court determines that amount to be unconstitutionally excessive, and may not release the defendant on 6 any form of release other than a security release if:]

"[(A) The United States Constitution or the Oregon Constitution prohibits the denial of release
under subsection (4) of this section;]

9 "[(B) The court determines that the defendant is eligible for release under subsection (4) of this 10 section; or]

11 "[(C) The court finds that the offense is not a violent felony.]

12 "[(b) In addition to the security amount described in paragraph (a) of this subsection, the court 13 may impose any supervisory conditions deemed necessary for the protection of the victim and the com-14 munity. When a defendant who has been released violates a condition of release and the violation:]

"[(A) Constitutes a new criminal offense, the court shall cause the defendant to be taken back into
custody, shall order the defendant held pending trial and shall set a security amount of not less than
\$250,000.]

"[(B) Does not constitute a new criminal offense, the court may order the defendant to be taken back into custody, may order the defendant held pending trial and may set a security amount of not less than \$250,000.]

21 "[(6)] (5) For purposes of this section, 'violent felony' means a felony offense in which there was 22 an actual or threatened serious physical injury to the victim, or a felony sexual offense.

"<u>SECTION 5.</u> ORS 135.245 is amended to read:

"135.245. (1) Except as provided in ORS 135.240, a person in custody has the right to [immediate security release or to] be taken before a magistrate without undue delay. [If the person is not released under ORS 135.270, or otherwise released before arraignment, the magistrate shall advise the person of the right of the person to a security release as provided in ORS 135.265.]

28 "[(2) If a person in custody does not request a security release at the time of arraignment, the 29 magistrate shall make a release decision regarding the person within 48 hours after the arraignment.]

30 "(2)(a) A magistrate shall make a release decision at the time of arraignment or other 31 first appearance after the defendant is taken into custody unless good cause to postpone the 32 release decision is shown, in which case a release hearing shall be held pursuant to sub-33 section (7) of this section.

34 "(b) The district attorney shall make reasonable efforts to inform the victim of the lo-35 cation, date and time of the arraignment or other first appearance and to determine if the 36 victim is present at the arraignment or appearance. If the victim is present, the victim has 37 the right to reasonably express any views relevant to the issues at the appearance.

"(c) As used in this subsection, 'good cause' includes circumstances in which:

"(A) The district attorney plans to seek preventative detention; or

40 "(B) There is a reasonable belief that additional evidence exists and would be relevant to 41 the release decision, but is not currently available.

42 "(3) If the magistrate, having given priority to the primary release criteria, decides to release 43 a defendant or to set security, the magistrate shall impose the least onerous condition reasonably 44 likely to ensure the safety of the public and the victim and the person's later appearance and, if the 45 person is charged with an offense involving domestic violence, ensure that the person does not en1 gage in domestic violence while on release. A person in custody, otherwise having a right to re-2 lease, shall be released upon the personal recognizance unless:

3 "(a) Release criteria show to the satisfaction of the magistrate that such a release is unwar-4 ranted; or

"(b) Subsection (6) of this section applies to the person.

6 "(4) Upon a finding that release of the person on personal recognizance is unwarranted, the 7 magistrate shall [*impose either*] **proceed to consider** conditional release [*or security release*.] **under** 8 **ORS 135.260. Only after determining that conditional release is unwarranted, or if otherwise** 9 **required by ORS 135.230 to 135.290, may the magistrate proceed to consider security release** 10 **under ORS 135.265.** 

11 "(5) At the release hearing:

"(a) The district attorney has a right to be heard in relation to issues relevant to the release decision; and

14 "(b) The victim has the right:

15 "(A) Upon request made within the time period prescribed in the notice required by ORS 16 147.417, to be notified by the district attorney of the release hearing;

17 "(B) To appear personally at the hearing; and

18 "(C) If present, to reasonably express any views relevant to the issues before the magistrate.

"(6) If a person refuses to provide a true name under the circumstances described in ORS 135.060 and 135.065, the magistrate may not release the person on personal recognizance or on conditional release. The magistrate may release the person on security release under ORS 135.265 except that the magistrate shall require the person to deposit the full security amount set by the magistrate.

"(7)(a) After the postponement of a release decision under subsection (2) of this section, 24 25upon the request of either party, or upon the magistrate's own motion, the magistrate shall 26make a release decision or reconsider the release decision, as applicable, at a release hearing. 27The release hearing must be held within 48 hours of arraignment or other first appearance after the defendant is taken into custody unless both parties agree, or the court finds good 28 29cause, to hold the hearing at a later time. Under no circumstances may the release hearing 30 be held more than five days after arraignment or other first appearance after the defendant is taken into custody unless the defendant consents to holding the hearing at a later time. 31

"(b) A hearing held under this subsection may not be used for purposes of discovery.

"[(7)] (8) This section shall be liberally construed to carry out the purpose of relying upon
 criminal sanctions instead of financial loss to [assure] ensure the appearance of the defendant.

"SECTION 6. ORS 135.247 is amended to read:

<sup>36</sup> "135.247. (1) When a release assistance officer [or a release assistance deputy] makes a release <sup>37</sup> decision under ORS 135.235 involving a defendant charged with a sex crime or a crime constituting <sup>38</sup> domestic violence, the release assistance officer [or deputy] shall include in the decision an order <sup>39</sup> that the defendant be prohibited from contacting or attempting to contact the victim, either directly <sup>40</sup> or through a third party, while the defendant is in custody. The release assistance officer [or <sup>41</sup> deputy] shall provide the defendant with a written copy of the order.

42 "(2) When a defendant who is charged with a sex crime or a crime that constitutes domestic 43 violence is arraigned, the court shall enter an order continuing an order issued under subsection (1) 44 of this section or, if no such order has been entered, enter an order prohibiting the defendant from 45 contacting or attempting to contact the victim, either directly or through a third party, while the 1 defendant is in custody.

2 "(3) Except as provided in subsection (4) of this section, an order described in subsection (1) or 3 (2) of this section:

4 "(a) Shall apply at any time during which the defendant is held in custody on the charge; and 5 "(b) Shall remain valid until the defendant is sentenced for the crime, the charge is dismissed

6 or the defendant is acquitted of the crime.

7 "(4) Upon petition of the victim, the court may enter an order terminating an order entered 8 under subsection (1) or (2) of this section if the court finds, after a hearing on the petition, that 9 terminating the order is in the best interests of the parties and the community.

"(5) An order described in subsection (1) or (2) of this section shall not limit contact with the victim by the defense attorney, or an agent of the defense attorney other than the defendant, in the manner prescribed by ORS 135.970 (2).

13 "(6) As used in this section:

14 "(a) 'Domestic violence' has the meaning given that term in ORS 135.230.

15 "(b) 'Sex crime' has the meaning given that term in ORS 163A.005.

16 "<u>SECTION 7.</u> ORS 135.242 is repealed.

"SECTION 8. If House Bill 3273 becomes law, section 1, chapter \_\_\_\_\_, Oregon Laws 2021
 (Enrolled House Bill 3273), is amended to read:

"Sec. 1. (1) Notwithstanding ORS 192.311 to 192.478, a law enforcement agency may not release
 a booking photo except as provided in subsection (2) of this section.

21 "(2) A law enforcement agency may release a booking photo described in subsection (1) of this
22 section:

23 "(a) To the person depicted in the booking photo;

24 "(b) To another law enforcement agency, or to a law enforcement officer employed by another 25 law enforcement agency, for a law enforcement purpose;

"(c) To the public, if the law enforcement agency determines that there is a law enforcement purpose for the release, including but not limited to assistance with the apprehension of a fugitive or a suspect in a criminal investigation, or the identification of additional criminal activity;

"(d) To a state mental hospital upon the admission to the hospital of the person depicted in the booking photo;

31 "(e) To a party in a criminal proceeding resulting from the arrest during which the booking 32 photo was obtained;

33 "(f) To the victim of the offense for which the person depicted in the booking photo was ar-34 rested; [or]

35 "(g) To the court, if the booking photo is part of a pretrial release report or is provided 36 to the court as part of the pretrial release process for the purposes of confirming the iden-37 tity of a defendant; or

38 "[(g)] (h) Upon the conviction of the person depicted in the booking photo, if the conviction 39 results from the arrest during which the booking photo was obtained.

40 "(3) As used in this section:

"(a) 'Booking photo' means a photograph of a person taken by a law enforcement agency for
identification purposes when the person is booked into custody.

43 "(b) 'Law enforcement agency' has the meaning given that term in ORS 131.915.

44 "(c) 'Law enforcement officer' means an officer, deputy, member or employee of a law enforce-45 ment agency. "SECTION 9. (1) Section 2 of this 2021 Act, the amendments to ORS 135.235, 135.240,
135.245 and 135.247 by sections 3 to 6 of this 2021 Act and the repeal of ORS 135.242 by section
7 of this 2021 Act become operative July 1, 2022.

4 "(2) The Judicial Department may take any action before the operative date specified in 5 subsection (1) of this section that is necessary to enable the department to exercise, on or 6 after the operative date specified in subsection (1) of this section, all the duties, functions 7 and powers conferred on the department by section 2 of this 2021 Act, the amendments to 8 ORS 135.235, 135.240, 135.245 and 135.247 by sections 3 to 6 of this 2021 Act and the repeal of 9 ORS 135.242 by section 7 of this 2021 Act.".

10
