Senate Bill 503

Sponsored by Senator THATCHER (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Provides person with privileges and legal defenses available to person with Oregon concealed handgun license if person is licensed to carry concealed handgun in another state that recognizes Oregon concealed handgun licenses.

ORS 166.173 is amended to read: 6 7 166.173. (1) A city or county may adopt ordinances to regulate, restrict or prohibit the possession of loaded firearms in public places as defined in ORS 161.015. 8 (2) Ordinances adopted under subsection (1) of this section do not apply to or affect: 9 (a) A law enforcement officer. 10 (b) A member of the military in the performance of official duty. 11 (c) A person who is licensed under ORS 166.291 and 166.292 to carry a concealed handgun. 12 (d) A person who is authorized to carry a concealed handgun pursuant to a valid recip-1314 rocal license. [(d)] (e) A person authorized to possess a loaded firearm while in or on a public building or 15 court facility under ORS 166.370. 16 [(e)] (f) An employee of the United States Department of Agriculture, acting within the scope 17of employment, who possesses a loaded firearm in the course of the lawful taking of wildlife. 18 19 [(f)] (g) An honorably retired law enforcement officer, unless the person who is a retired law 20 enforcement officer has been convicted of an offense that would make the person ineligible to obtain a concealed handgun license under ORS 166.291 and 166.292. 2122(3) As used in this section, "reciprocal license" means a license or permit issued by a 23state or local law enforcement agency, a court or another issuing authority of another state, if the other state authorizes a person who is licensed under ORS 166.291 and 166.292 to carry 24a concealed handgun in that state. 25 26 SECTION 2. (1) ORS 166.250 does not apply to or affect: 27 (a) A parole and probation officer, police officer or reserve officer, as those terms are defined 28 in ORS 181A.355. 29 30 (b) A federal officer, as defined in ORS 133.005, or a certified reserve officer or corrections officer, as those terms are defined in ORS 181A.355, while the federal officer, certified reserve officer 31

(h) Duly authorized military or civil organizations while parading, or the members thereof whengoing to and from the places of meeting of their organization.

(j) A person who is authorized to carry a concealed handgun pursuant to a valid recip rocal license.

(2) It is an affirmative defense to a charge of violating ORS 166.250 (1)(c)(C) that the person has
been granted relief from the disability under ORS 166.274.

(3) Except for persons who are otherwise prohibited from possessing a firearm under ORS
 166.250 (1)(c) or 166.270, ORS 166.250 does not apply to or affect:

(a) Members of any club or organization, for the purpose of practicing shooting at targets upon
the established target ranges, whether public or private, while such members are using any of the

166.370. (1) Any person who intentionally possesses a loaded or unloaded firearm or any other 8 9 instrument used as a dangerous weapon, while in or on a public building, shall upon conviction be guilty of a Class C felony. 10

(2)(a) Except as otherwise provided in paragraph (b) of this subsection, a person who inten-11 12 tionally possesses:

13 (A) A firearm in a court facility is guilty, upon conviction, of a Class C felony. A person who intentionally possesses a firearm in a court facility shall surrender the firearm to a law enforcement 14 15 officer.

16 (B) A weapon, other than a firearm, in a court facility may be required to surrender the weapon to a law enforcement officer or to immediately remove it from the court facility. A person who fails 17 18 to comply with this subparagraph is guilty, upon conviction, of a Class C felony.

(C) A firearm in a local court facility is guilty, upon conviction, of a Class C felony if, prior to 19 the offense, the presiding judge of the local court facility entered an order prohibiting firearms in 20the area in which the court conducts business and during the hours in which the court operates. 21

12[(c)] (d) "Vehicle" means a vehicle that is self-propelled and that is commonly known as a pas-13 senger car, van, truck or motorcycle.

15 166.380. (1) Except as provided in subsection (2) of this section, a peace officer may examine a firearm possessed by anyone on the person while in or on a public building to determine whether 16 the firearm is a loaded firearm. 17

18 (2)(a) A person who is licensed under ORS 166.291 and 166.292 to carry a concealed handgun may present a valid concealed handgun license to the peace officer instead of providing the firearm 19 to the peace officer for examination. 20

(b) A person who is authorized to carry a concealed handgun pursuant to a valid recip-2122rocal license may present the valid reciprocal license to the peace officer instead of providing 23the firearm to the peace officer for examination.
