SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Oregon Department of Aviation.

Limits biennial expenditures by department from federal funds.

Declares emergency, effective July 1, 2021.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Notwithstanding any other law limiting expenditures, the following amounts**
6 **are established for the biennium beginning July 1, 2021, as the maximum limits for payment**
7 **of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
8 **cluding lottery funds and federal funds, collected or received by the Oregon Department of**
9 **Aviation, for the following purposes:**

10 (1) **Operations..... \$ 4,596,296**

11 (2) **Aircraft registration \$ 166,706**

12 (3) **Pavement maintenance..... \$ 1,705,828**

13 (4) **General aviation**

14 **entitlement**

15 **grant program..... \$ 446,784**

16 (5) **Aviation system**

17 **action program \$ 9,719,459**

18 **SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts**
19 **are established for the biennium beginning July 1, 2021, as the maximum limits for payment**
20 **of expenses from federal funds collected or received by the Oregon Department of Aviation,**
21 **for the following purposes:**

22 (1) **Operations..... \$ 2,082,276**

23 (2) **General aviation**

24 **entitlement**

25 **grant program..... \$ 4,336,856**

1 **SECTION 3.** This 2021 Act being necessary for the immediate preservation of the public
