

SENATE AMENDMENTS TO SENATE BILL 5516

By JOINT COMMITTEE ON WAYS AND MEANS

1 On page 1 of the printed bill, delete lines 5 through 25 and delete page 2 and insert:

2 “**SECTION 1.** There are appropriated to the Department of Environmental Quality, for
3 the biennium beginning July 1, 2021, out of the General Fund, the following amounts, for the
4 following purposes:

- 5 (1) Air quality..... \$ 22,741,996
- 6 (2) Water quality..... \$ 37,311,837
- 7 (3) Land quality..... \$ 1,461,563
- 8 (4) Agency management..... \$ 170,550
- 9 (5) Debt service..... \$ 5,653,561

10 “**SECTION 2.** Notwithstanding any other law limiting expenditures, the following amounts
11 are established for the biennium beginning July 1, 2021, as the maximum limits for payment
12 of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, the
13 proceeds of bonds for the Orphan Site Account and federal funds from congestion mitigation
14 and air quality grants, drinking water protection, laboratory accreditation and woodstove
15 grants and for smoke monitoring laboratory services, but excluding lottery funds and federal
16 funds not described in this section, collected or received by the Department of Environ-
17 mental Quality, for the following purposes:

- 18 (1) Air quality..... \$ 93,100,325
- 19 (2) Water quality..... \$ 31,961,978
- 20 (3) Land quality..... \$ 80,046,998
- 21 (4) Agency management..... \$ 42,467,220
- 22 (5) Debt service..... \$ 300,000

23 “**SECTION 3.** Notwithstanding any other law limiting expenditures, the amount of
24 \$6,045,171 is established for the biennium beginning July 1, 2021, as the maximum limit for
25 payment of expenses from lottery moneys allocated from the Parks and Natural Resources
26 Fund to the Department of Environmental Quality for activities and projects to implement
27 Article XV, section 4 (8), of the Oregon Constitution.

28 “**SECTION 4.** For the biennium beginning July 1, 2021, the following expenditures by the
29 Department of Environmental Quality are not limited:

- 30 “(1) Expenditures for debt service and debt service administrative costs related to the
31 Water Pollution Control Revolving Fund and the Pollution Control Fund; and
- 32 “(2) Expenditures made for loans from the Water Pollution Control Revolving Fund and
33 loans from the Pollution Control Fund.

34 “**SECTION 5.** Notwithstanding any other law limiting expenditures, the following amounts
35 are established for the biennium beginning July 1, 2021, as the maximum limits for payment

1 of expenses from federal funds other than those described in section 2 of this 2021 Act, col-
2 lected or received by the Department of Environmental Quality, for the following purposes:

- 3 (1) Air quality..... \$ 10,829,797
- 4 (2) Water quality..... \$ 11,517,267
- 5 (3) Land quality..... \$ 7,503,831

6 “SECTION 6. This 2021 Act being necessary for the immediate preservation of the public
7 peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect
8 July 1, 2021.”
