SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Department of State Lands for certain purposes.

Limits certain biennial expenditures by department from federal funds.

Limits biennial expenditures by department from Portland Harbor Cleanup Fund.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2021.

1 A BILL FOR AN ACT

Relating to the financial administration of the Department of State Lands; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

<u>SECTION 1.</u> Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2021, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds, federal funds and funds described in section 2 of this 2021 Act, collected or received by the Department of State Lands, for the following purposes:

<u>SECTION 2.</u> Notwithstanding any other law limiting expenditures, the amount of \$5,249,000 is established for the biennium beginning July 1, 2021, as the maximum limit for payment of expenses by the Department of State Lands from the Portland Harbor Cleanup Fund established by ORS 274.064.

SECTION 3. Notwithstanding any other law limiting expenditures, the following amounts
