SENATE AMENDMENTS TO SENATE BILL 5546

1 Delete lines 4 through 15 of the printed bill and insert:

2 "<u>SECTION 1.</u> As used in sections 1 to 4 of this 2021 Act, 'state agency' means every state 3 officer, board, commission, department, institution, branch or agency of the state govern-4 ment, the costs of which are paid wholly or in part from funds held in the State Treasury.

5 "<u>SECTION 2.</u> (1) Notwithstanding ORS 291.232 to 291.260, and subject to section 5 of this 6 2021 Act and any rule that may be adopted by the Oregon Department of Administrative 7 Services, any obligations incurred by a state agency on or after July 1, 2021, that do not ex-8 ceed the level of expenditures authorized under ORS 291.232 to 291.260 or otherwise author-9 ized for the last quarter of the 2019-2021 biennium are authorized, and necessary funds are 10 appropriated therefor, unless the Oregon Department of Administrative Services determines 11 that the state agency's expenditure level should be modified, based on pending legislation.

12 "(2) The Oregon Department of Administrative Services by rule shall specify the means 13 whereby funds expended pursuant to subsection (1) of this section or section 5 of this 2021 14 Act are reconciled and charged to the state agency's 2021-2023 legislatively approved budget 15 during the 2021-2023 biennium.

"(3) All payments for debt service, certificates of participation and other financing
 agreements are hereby authorized during the period commencing July 1, 2021.

"<u>SECTION 3.</u> Sections 1 to 5 of this 2021 Act apply to a state agency for which no budget
 has become law on or before July 1, 2021.

20 "<u>SECTION 4.</u> (1)(a) If there is no 2021-2023 legislatively adopted budget upon final 21 adjournment of the regular session of the Eighty-first Legislative Assembly against which 22 any expenditure authorized by section 2 (1) or 5 of this 2021 Act can be applied, the expend-23 iture shall be considered to have been made from funds appropriated to the Oregon Depart-24 ment of Administrative Services.

25 "(b) For the purpose of paying the incurred expenses of state agencies, there is appro-26 priated to the Oregon Department of Administrative Services any cash or other funds re-27 maining in the accounts of the state agency for which no budget has been adopted and for 28 which no expenditure authority exists when the Legislative Assembly adjourns sine die.

29 "(c) The Oregon Department of Administrative Services may apply for reimbursement 30 from the Emergency Board of any expenditure made under this subsection during the 31 2021-2023 biennium.

32 "(2)(a) If, after final adjournment of the regular session of the Eighty-first Legislative 33 Assembly, the Governor vetoes a legislatively adopted budget against which any expenditure 34 authorized by section 2 (1) or 5 of this 2021 Act can be applied, the expenditure shall be 35 considered to have been made from funds appropriated to the Oregon Department of Ad1 ministrative Services.

"(b) For the purpose of paying the incurred expenses of state agencies, there is appropriated to the Oregon Department of Administrative Services any cash or other funds remaining in the accounts of the state agency for which a legislatively adopted budget has been vetoed and for which no expenditure authority exists when the Governor vetoes the budget. "(c) The Oregon Department of Administrative Services may apply for reimbursement

7 from the Emergency Board of any expenditure made under this subsection during the 8 2021-2023 biennium.

"SECTION 5. (1) Notwithstanding ORS 291.232 to 291.260 and section 2 of this 2021 Act, 9 and subject to any rule that may be adopted by the Oregon Department of Administrative 10 11 Services, any obligations incurred by the Department of Human Services on or after July 1, 2021, that do not exceed the level of expenditures authorized under ORS 291.232 to 291.260 1213or otherwise authorized for the seventh quarter of the 2019-2021 biennium are authorized, and necessary funds are appropriated therefor, unless the Oregon Department of Adminis-14 trative Services determines that the expenditure level for the Department of Human Services 1516 should be modified, based on pending legislation.

"(2) Notwithstanding ORS 291.232 to 291.260 and section 2 of this 2021 Act, and subject 17to any rule that may be adopted by the Oregon Department of Administrative Services, any 18 19 obligations incurred by the Oregon Health Authority on or after July 1, 2021, that do not 20exceed the level of expenditures authorized under ORS 291.232 to 291.260 or otherwise au-21thorized for the fourth quarter of the 2019-2021 biennium are authorized, and necessary funds 22are appropriated therefor, unless the Oregon Department of Administrative Services determines that the expenditure level for the Oregon Health Authority should be modified, based 23on pending legislation. 24

"SECTION 6. Sections 1 to 5 of this 2021 Act are repealed on September 15, 2021.

"<u>SECTION 7.</u> This 2021 Act being necessary for the immediate preservation of the public
peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect
July 1, 2021.".
