Senate Bill 694

Sponsored by Senator KNOPP

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Requires ballots for general and primary elections that are received after election to be counted if postmarked no later than Saturday before date of election and received no later than seven calendar days after election.

Prohibits individual from collecting and returning ballot of other individual, subject to specified exceptions.

Requires Secretary of State to submit biennial report to Legislative Assembly identifying name, address and birthdate of each individual who cast more than one ballot in single election during previous two years.

Declares emergency, effective on passage.

SECTION 1. ORS 254.470 is amended to read:

7 254.470. (1) The Secretary of State by rule shall establish requirements and criteria for the 8 designation of places of deposit for the ballots cast in an election. The rules shall also specify the 9 dates and times the places of deposit must be open and the security requirements for the places of 10 deposit. At a minimum, the places designated under this section shall be open on the date of the 11 election for a period of eight or more hours, but must be open until at least 8 p.m. At each place 12 of deposit designated under this section, the county clerk shall prominently display a sign stating 13that the location is an official ballot drop site.

14 (2)(a) Except as provided in paragraphs (b) and (c) of this subsection, the county clerk shall mail 15 by nonforwardable mail an official ballot with a return identification envelope and a secrecy envelope not sooner than the 20th day before the date of an election and not later than the 14th day 16 17 before the date of the election, to each active elector of the electoral district as of the 21st day 18 before the date of the election.

(b) If the county clerk determines that an active elector of the electoral district as of the 21st 19 20 day before the date of the election does not receive daily mail service from the United States Postal 21Service, the county clerk shall mail by nonforwardable mail an official ballot with a return iden-22 tification envelope and a secrecy envelope to the elector not sooner than the 20th day before the 23 date of an election and not later than the 18th day before the date of the election.

24(c) In the case of ballots to be mailed to addresses outside this state to electors who are not 25military or overseas electors, the county clerk may mail the ballots not sooner than the 29th day 26 before the date of the election.

27(3) For an election held on the date of a primary election:

1 (a) The county clerk shall mail the official ballot of a major political party to each elector who 2 is registered as being affiliated with the major political party as of the 21st day before the date of 3 the election.

4 (b) The county clerk shall mail the official ballot of a major political party to an elector not 5 affiliated with any political party if the elector has applied for the ballot as provided in this sub-6 section and that party has provided under ORS 254.365 for a primary election that admits electors 7 not affiliated with any political party.

8 (c) An elector not affiliated with any political party who wishes to vote in the primary election 9 of a major political party shall apply to the county clerk in writing. The application must be com-10 pleted, signed and submitted by the elector electronically, in person or by mail, in a manner deter-11 mined by the secretary by rule and must indicate which major political party ballot the elector 12 wishes to receive. Except for electors described in subsection (4) of this section, and subject to ORS 13 247.203, the application must be received by the county clerk not later than 5 p.m. of the 21st day 14 before the date of the election.

(d) If the primary election ballot includes city, county or nonpartisan offices or measures, the county clerk shall mail to each elector who is not eligible to vote for party candidates a ballot limited to those offices and measures for which the elector is eligible to vote.

(4) For each elector who updates a voter registration after the deadline in ORS 247.025, the county clerk shall make the official ballot, the return identification envelope and the secrecy envelope available either by mail or at the county clerk's office or at another place designated by the county clerk. An elector to whom this subsection applies must request a ballot from the county clerk.

(5) The ballot shall contain the following warning:

Any person who, by use of force or other means, unduly influences an elector to vote in any particular manner or to refrain from voting is subject to a fine.

(6)(a) Upon receipt of any ballot described in this section, the elector shall mark the ballot, sign
the return identification envelope supplied with the ballot and comply with the instructions provided
with the ballot.

(b) The elector may return the marked ballot to the county clerk by United States mail or by
depositing the ballot at the office of the county clerk, at any place of deposit designated by the
county clerk or at any location described in ORS 254.472 or 254.474.

(c) The ballot must be returned in the return identification envelope.

(d) Subject to paragraph (e) of this subsection, if a person returns a ballot for an elector in the manner permitted under section 16 of this 2021 Act, the person shall deposit the ballot in a manner described in paragraph (b) of this subsection not later than two days after receiving the ballot.

(e) [A] If the elector deposits the ballot at the office of the county clerk, at any place of
deposit designated by the county clerk or at any location described in ORS 254.472 or 254.474,
the ballot must be received at the office of the county clerk, at the designated place of deposit or
at any location described in ORS 254.472 or 254.474 not later than the end of the period determined

(8)(a) If the elector returns the ballot by mail, and the postmark is not present or legible,
the ballot shall be considered to be postmarked on the date the ballot was voted as indicated
by the elector on the return identification envelope.

(b) If a ballot is received by the county clerk by mail after the date of the election, the
ballot may not be counted if:

(A) The postmark is not present or legible; and

(B) The elector has not indicated on the return identification envelope the date that the
ballot was voted.

(c) The Secretary of State may adopt rules necessary to implement this subsection.

[(7)] (9) An elector may obtain a replacement ballot if the ballot is destroyed, spoiled, lost or 2627not received by the elector. Replacement ballots shall be issued and processed as described in this section and ORS 254.480. The county clerk shall keep a record of each replacement ballot provided 28under this subsection. Notwithstanding any deadline for mailing ballots in subsection (2) of this 2930 section, a replacement ballot may be mailed, made available in the office of the county clerk or made 31 available at one central location in the electoral district in which the election is conducted.
