## Senate Bill 706

Sponsored by Senator BEYER, Representative MEEK

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Requires Oregon Health Authority to provide grant to organization for purpose of conducting outreach to citizens of island nations in Compact of Free Association residing in Oregon to enroll citizens of island nations in Compact of Free Association in medical assistance.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

2 Relating to enrolling citizens of the island nations in the Compact of Free Association in the state

medical assistance program; creating new provisions; repealing ORS 735.601, 735.604, 735.608,

735.611 and 735.617; and declaring an emergency. 4

 $\mathbf{5}$ Whereas section 208 of the federal Consolidated Appropriations Act, 2021 (P.L. 116-260) removed

6 the barriers to enrollment in Medicaid for citizens of the island nations of the Compact of Free

7 Association; now, therefore,

8 Be It Enacted by the People of the State of Oregon:

9 SECTION 1. Section 2 of this 2021 Act is added to and made a part of ORS chapter 413.

10 SECTION 2. (1) As used in this section, "COFA citizen" means a citizen of any of the 11 island nations in the Compact of Free Association who is residing in Oregon.

12(2) The Oregon Health Authority is responsible for conducting statewide outreach to COFA citizens with the goal of enrolling all eligible COFA citizens in medical assistance. 13

14 (3) The authority, in collaboration with the work group described in subsection (5) of this section, shall evaluate and implement the outreach and marketing strategies designed to 1516 most effectively encourage the enrollment of all eligible COFA citizens in medical assistance.

17 (4) To maximize the enrollment and retention of eligible COFA citizens in medical as-18 sistance, the authority shall develop and administer a program to provide a \$500,000 grant to an organization: 19

20 (a) That represents all communities of COFA citizens in this state and is uniquely qual-21ified to deliver culturally specific and targeted outreach and direct application assistance to:

Moneys remaining in the COFA Premium Assistance Program Fund on the 33 34 operative date specified in section 6 of this 2021 Act are transferred to and deposited into the Oregon Health Authority Fund established in ORS 413.101, to be used to enroll individuals 35described in section 2 of this 2021 Act in the state medical assistance program. 36 37 SECTION 5. ORS 735.601, 735.604, 735.608, 735.611 and 735.617 are repealed. 38 SECTION 6. The amendments to section 2 of this 2021 Act by section 3 of this 2021 Act and the repeal of ORS 735.601, 735.604, 735.608, 735.611 and 735.617 by section 5 of this 2021 39 Act become operative on June 30, 2022. 40 SECTION 7. This 2021 Act being necessary for the immediate preservation of the public 41 peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect 4243 on its passage.
