

SENATE AMENDMENTS TO SENATE BILL 710

“RESTRAINT AND INVOLUNTARY SECLUSION

7 “SECTION 1. Definitions. As used in sections 1 to 11 of this 2021 Act:

8 “(1) ‘Certified foster home’ means a foster home subject to ORS 418.625 to 418.645.

9 “(2) ‘Chemical restraint’ means a drug or medication that is administered to a child in
10 care to control behavior or restrict freedom of movement.

11 “(3) ‘Child-caring agency’ has the meaning given that term in ORS 418.205.

12 “(4) ‘Child in care’ has the meaning given that term in ORS 418.257.

13 “(5) ‘Children’s emergency safety intervention specialist’ means a qualified mental health
14 professional licensed to order, monitor and evaluate the use of seclusion and restraint in
15 accredited and certified facilities that provide intensive mental health treatment services to
16 individuals under 21 years of age.

17 “(6) ‘Developmental disabilities residential facility’ has the meaning given that term in
18 ORS 418.257.

19 “(7)(a) ‘Involuntary seclusion’ means the confinement of a child in care alone in a room
20 from which the child in care is prevented from leaving by any means.

21 “(b) ‘Involuntary seclusion’ does not include age-appropriate discipline, including, but not
22 limited to, time-out if the time-out is in a setting from which the child in care is not pre-
23 vented from leaving.

24 “(8) ‘Mechanical restraint’ means a device used to restrict the movement of a child in
25 care or the movement or normal function of a portion of the body of a child in care.

26 “(9) ‘Proctor foster home’ means a foster home certified by a child-caring agency under
27 ORS 418.248.

28 “(10) ‘Program’ means:

29 “(a) A child-caring agency;

30 “(b) A proctor foster home; or

31 “(c) A developmental disabilities residential facility that is a residential training home
32 or facility licensed under ORS 443.415 to serve children under 18 years of age.

33 “(11) ‘Prone restraint’ means a restraint in which a child in care is held face down on
34 the floor.

35 “(12) ‘Reportable injury’ means any type of injury to a child in care, including but not

1 limited to rug burns, fractures, sprains, bruising, pain, soft tissue injury, punctures,
2 scratches, concussions, abrasions, dizziness, loss of consciousness, loss of vision, visual dis-
3 turbance or death.

4 “(13) ‘Restraint’ means the physical restriction of a child in care’s actions or movements
5 by holding the child in care or using pressure or other means.

6 “(14) ‘Secure adolescent inpatient treatment program’ means a child-caring agency that
7 is an intensive treatment services program, as described by the Oregon Health Authority by
8 rule, that provides inpatient psychiatric stabilization and treatment services to individuals
9 under 21 years of age who require a secure intensive treatment setting.

10 “(15) ‘Secure children’s inpatient treatment program’ means a child-caring agency that
11 is an intensive treatment services program, as described by the authority by rule, that pro-
12 vides inpatient psychiatric stabilization and treatment services to children under 14 years
13 of age who require a secure intensive treatment setting.

14 “(16) ‘Serious bodily injury’ means any significant impairment of the physical condition
15 of an individual, as determined by qualified medical personnel, whether self-inflicted or in-
16 flicted by someone else.

17 “(17) ‘Supine restraint’ means a restraint in which a child in care is held face up on the
18 floor.

19 “SECTION 2. Prohibitions on restraint or involuntary seclusion. (1) A child-caring
20 agency, proctor foster home, certified foster home or developmental disabilities residential
21 facility may not place a child in care in a restraint or involuntary seclusion as a form of
22 discipline, punishment or retaliation or for the convenience of staff, contractors or volun-
23 teers of the child-caring agency, proctor foster home, certified foster home or developmental
24 disabilities residential facility.

25 “(2) Except as provided in section 3 (4) of this 2021 Act, the use of the following types
26 of restraint of a child in care are prohibited:

27 “(a) Chemical restraint.

28 “(b) Mechanical restraint.

29 “(c) Prone restraint.

30 “(d) Supine restraint.

31 “(e) Any restraint that includes the nonincidental use of a solid object, including the
32 ground, a wall or the floor, to impede a child in care’s movement.

33 “(f) Any restraint that places, or creates a risk of placing, pressure on a child in care’s
34 neck or throat.

35 “(g) Any restraint that places, or creates a risk of placing, pressure on a child in care’s
36 mouth.

37 “(h) Any restraint that impedes, or creates a risk of impeding, a child in care’s breathing.

38 “(i) Any restraint that involves the intentional placement of hands, feet, elbows, knees
39 or any object on a child in care’s neck, throat, genitals or other intimate parts.

40 “(j) Any restraint that causes pressure to be placed, or creates a risk of causing pressure
41 to be placed, on a child in care’s stomach, chest, joints, throat or back by a knee, foot or
42 elbow.

43 “(k) Any other restraint, the primary purpose of which is to inflict pain.

44 “SECTION 3. Permissible use of restraint or involuntary seclusion. (1) Except as other-
45 wise provided in this section, a child-caring agency, proctor foster home or developmental

1 disabilities residential facility may only place a child in care in a restraint or involuntary
2 seclusion if the child in care's behavior poses a reasonable risk of imminent serious bodily
3 injury to the child in care or others and less restrictive interventions would not effectively
4 reduce that risk.

5 “(2) A certified foster home may not place a child in care in a restraint or involuntary
6 seclusion.

7 “(3) Notwithstanding subsection (1) or (2) of this section, a child-caring agency, proctor
8 foster home, certified foster home or developmental disabilities residential facility may use
9 the following types of restraints on a child in care:

10 “(a) Holding the child in care's hand or arm to escort the child in care safely and without
11 the use of force from one area to another;

12 “(b) Assisting the child in care to complete a task if the child in care does not resist the
13 physical contact; or

14 “(c) Using a physical intervention if:

15 “(A) The intervention is necessary to break up a physical fight or to effectively protect
16 a person from an assault, serious bodily injury or sexual contact;

17 “(B) The intervention uses the least amount of physical force and contact possible; and

18 “(C) The intervention is not a prohibited restraint described in section 2 (2) of this 2021
19 Act.

20 “(4) Notwithstanding section 2 (2) of this 2021 Act:

21 “(a) The restraint described in section 2 (2)(e) of this 2021 Act may be used if the re-
22 straint is necessary to gain control of a weapon.

23 “(b) The restraint described in section 2 (2)(g) of this 2021 Act may be used if the re-
24 straint is necessary for the purpose of extracting a body part from a bite.

25 “(c) If a program is a secure children's inpatient treatment program or secure adolescent
26 inpatient treatment program, the program may place a child in care in a restraint described
27 in section 2 (2)(d) or (e) of this 2021 Act only if:

28 “(A) The child in care is currently admitted to the program;

29 “(B) The restraint is authorized by an order written at the time of and specifically for
30 the current situation by a licensed medical practitioner or a licensed children's emergency
31 safety intervention specialist;

32 “(C) The restraint is used only as long as needed to prevent serious physical injury, as
33 defined in ORS 161.015, and while no other intervention or form of restraint is possible;

34 “(D) A licensed medical practitioner, children's emergency safety intervention specialist
35 or qualified mental health professional, who is certified in the use of the type of restraint
36 used, continuously monitors the use of the restraint and the physical and psychological
37 well-being of the child in care at all times while the restraint is being used;

38 “(E) Each individual placing the child in care in the restraint is trained, as required by
39 the Department of Human Services by rule, in the use of the type of restraint used and the
40 individual's training is current;

41 “(F) One or more individuals with current cardiopulmonary resuscitation training are
42 present for the duration of the restraint;

43 “(G) The program has written policies that require a licensed children's emergency safety
44 intervention specialist or other licensed practitioner to evaluate and document the physical,
45 psychological and emotional well-being of the child in care immediately following the use of

1 the restraint; and

2 “(H) The program is in compliance with any other requirements under sections 1 to 11
3 of this 2021 Act, and the use of the restraint does not otherwise violate any applicable con-
4 tract requirements or any state or federal law related to the use of restraints.

5 “(5) In addition to the restraints described in subsection (3) of this section, a program
6 may place a child in care in a restraint or involuntary seclusion if:

7 “(a) The restraint or involuntary seclusion is used only for as long as the child in care’s
8 behavior poses a reasonable risk of imminent serious bodily injury;

9 “(b) The individuals placing the child in care in the restraint are trained, as required by
10 the department by rule, in the use of the type of restraint or involuntary seclusion used;

11 “(c) The program staff continuously monitor the child in care for the duration of the
12 restraint or involuntary seclusion; and

13 “(d) The restraint or involuntary seclusion is performed in a manner that is safe,
14 proportionate and appropriate, taking into consideration the child in care’s chronological and
15 developmental age, size, gender identity, physical, medical and psychiatric condition and
16 personal history, including any history of physical or sexual abuse.

17 “(6) In addition to the requirements described in subsection (5) of this section, if a pro-
18 gram places a child in care in a restraint or involuntary seclusion for more than 10 minutes:

19 “(a) The program must provide the child in care with adequate access to the bathroom
20 and water at least every 30 minutes; and

21 “(b)(A) Every five minutes after the first 10 minutes of the restraint or involuntary se-
22 clusion, a program supervisor who is trained, as required by the department by rule, in the
23 use of the type of restraint or involuntary seclusion being used must provide written au-
24 thorization for the continuation of the restraint or involuntary seclusion.

25 “(B) If the supervisor is not on-site at the time the restraint is used, the supervisor may
26 provide the written authorization electronically.

27 “(C) The written authorization must document why the restraint or involuntary seclusion
28 continues to be the least restrictive intervention to reduce the risk of imminent serious
29 bodily injury in the given circumstances.

30 “**SECTION 4.** Section 3 of this 2021 Act is amended to read:

31 “**Sec. 3.** (1) Except as otherwise provided in this section, a child-caring agency, proctor foster
32 home or developmental disabilities residential facility may only place a child in care in a restraint
33 or involuntary seclusion if the child in care’s behavior poses a reasonable risk of imminent serious
34 bodily injury to the child in care or others and less restrictive interventions would not effectively
35 reduce that risk.

36 “(2) A certified foster home may not place a child in care in a restraint or involuntary seclusion.

37 “(3) Notwithstanding subsection (1) or (2) of this section, a child-caring agency, proctor foster
38 home, certified foster home or developmental disabilities residential facility may use the following
39 types of restraints on a child in care:

40 “(a) Holding the child in care’s hand or arm to escort the child in care safely and without the
41 use of force from one area to another;

42 “(b) Assisting the child in care to complete a task if the child in care does not resist the phys-
43 ical contact; or

44 “(c) Using a physical intervention if:

45 “(A) The intervention is necessary to break up a physical fight or to effectively protect a person

1 from an assault, serious bodily injury or sexual contact;

2 “(B) The intervention uses the least amount of physical force and contact possible; and

3 “(C) The intervention is not a prohibited restraint described in section 2 (2) of this 2021 Act.

4 “(4) Notwithstanding section 2 (2) of this 2021 Act:

5 “(a) The restraint described in section 2 (2)(e) of this 2021 Act may be used if the restraint is
6 necessary to gain control of a weapon.

7 “(b) The restraint described in section 2 (2)(g) of this 2021 Act may be used if the restraint is
8 necessary for the purpose of extracting a body part from a bite.

9 “(c) If a program is a secure children’s inpatient treatment program or secure adolescent inpa-
10 tient treatment program, the program may place a child in care in a restraint described in section
11 2 (2)(d) or (e) of this 2021 Act only if:

12 “(A) The child in care is currently admitted to the program;

13 “(B) The restraint is authorized by an order written at the time of and specifically for the cur-
14 rent situation by a licensed medical practitioner or a licensed children’s emergency safety inter-
15 vention specialist;

16 “(C) The restraint is used only as long as needed to prevent serious physical injury, as defined
17 in ORS 161.015, and while no other intervention or form of restraint is possible;

18 “(D) A licensed medical practitioner, children’s emergency safety intervention specialist or
19 qualified mental health professional, who is certified in the use of the type of restraint used, con-
20 tinuously monitors the use of the restraint and the physical and psychological well-being of the child
21 in care at all times while the restraint is being used;

22 “(E) Each individual placing the child in care in the restraint is [*trained, as required by the*
23 *Department of Human Services by rule,*] **certified as described in section 9 of this 2021 Act** in the
24 use of the type of restraint used and the individual’s training is current;

25 “(F) One or more individuals with current cardiopulmonary resuscitation training are present
26 for the duration of the restraint;

27 “(G) The program has written policies that require a licensed children’s emergency safety
28 intervention specialist or other licensed practitioner to evaluate and document the physical, psy-
29 chological and emotional well-being of the child in care immediately following the use of the re-
30 straint; and

31 “(H) The program is in compliance with any other requirements under sections 1 to 11 of this
32 2021 Act, and the use of the restraint does not otherwise violate any applicable contract require-
33 ments or any state or federal law related to the use of restraints.

34 “(5) In addition to the restraints described in subsection (3) of this section, a program may place
35 a child in care in a restraint or involuntary seclusion if:

36 “(a) The restraint or involuntary seclusion is used only for as long as the child in care’s be-
37 havior poses a reasonable risk of imminent serious bodily injury;

38 “(b) The individuals placing the child in care in the restraint **or involuntary seclusion are**
39 **certified as described in section 9 of this 2021 Act in the use of the type of restraint used**
40 **or** are trained, as required by the department by rule, in the use of the [*type of restraint or*] invol-
41 untary seclusion used;

42 “(c) The program staff continuously monitor the child in care for the duration of the restraint
43 or involuntary seclusion; and

44 “(d) The restraint or involuntary seclusion is performed in a manner that is safe, proportionate
45 and appropriate, taking into consideration the child in care’s chronological and developmental age,

1 size, gender identity, physical, medical and psychiatric condition and personal history, including any
2 history of physical or sexual abuse.

3 “(6) In addition to the requirements described in subsection (5) of this section, if a program
4 places a child in care in a restraint or involuntary seclusion for more than 10 minutes:

5 “(a) The program must provide the child in care with adequate access to the bathroom and
6 water at least every 30 minutes; and

7 “(b)(A) Every five minutes after the first 10 minutes of the restraint or involuntary seclusion,
8 a program supervisor who is **certified as described in section 9 of this 2021 Act in the use of**
9 **the type of restraint being used or** trained, as required by the department by rule, in the use of
10 the [*type of restraint or*] involuntary seclusion being used must provide written authorization for the
11 continuation of the restraint or involuntary seclusion.

12 “(B) If the supervisor is not on-site at the time the restraint is used, the supervisor may provide
13 the written authorization electronically.

14 “(C) The written authorization must document why the restraint or involuntary seclusion con-
15 tinues to be the least restrictive intervention to reduce the risk of imminent serious bodily injury
16 in the given circumstances.

17 “**SECTION 5. Procedures, notices and reports.** (1) **A program shall establish procedures**
18 **for the program to follow when a child in care is placed in a restraint or involuntary seclu-**
19 **sion. The procedures must be consistent with the provisions of this section and sections 2**
20 **and 3 of this 2021 Act.**

21 “(2) **A program shall maintain a record of each incident in which a reportable injury**
22 **arises from the use of a restraint or involuntary seclusion. The record under this subsection**
23 **must include any audio or video recording immediately preceding, during and following the**
24 **incident.**

25 “(3)(a) **If a program places a child in care in a restraint except as provided in section 3**
26 **(3)(a) or (b) of this 2021 Act, or involuntary seclusion, the program shall provide the child in**
27 **care’s case manager, attorney, court appointed special advocate and parents or guardians**
28 **with:**

29 “(A) **Verbal or electronic notice that the restraint or involuntary seclusion was used as**
30 **soon as practicable following the incident but not later than the end of the next business day;**
31 **and**

32 “(B) **Written notice that the restraint or involuntary seclusion was used as soon as**
33 **practicable following the incident but not later than the end of the next business day.**

34 “(b) **The written notice must include:**

35 “(A) **A description of the restraint or involuntary seclusion, the date of the restraint or**
36 **involuntary seclusion, the times when the restraint or involuntary seclusion began and ended**
37 **and the location of the restraint or involuntary seclusion.**

38 “(B) **A description of the child in care’s activity that necessitated the use of restraint**
39 **or involuntary seclusion.**

40 “(C) **The efforts the program used to de-escalate the situation and the alternatives to**
41 **restraint or involuntary seclusion the program attempted before placing the child in care in**
42 **the restraint or involuntary seclusion.**

43 “(D)(i) **The names of each of individual who placed the child in care in the restraint or**
44 **involuntary seclusion or who monitored or approved the placement of the child in care in the**
45 **restraint or involuntary seclusion.**

1 “(ii) For each individual identified in this subparagraph, whether the individual was
2 trained, as required by the Department of Human Services by rule, in the use of the type
3 of restraint or involuntary seclusion used, the date of the individual’s most recent training
4 and a description of the types of restraint the individual is trained to use, if any.

5 “(iii) If an individual identified in this subparagraph was not trained in the type of re-
6 straint or involuntary seclusion used, or if the individual’s training was not current, a de-
7 scription of the individual’s training deficiency and the reason an individual without the
8 proper training was involved in the restraint or involuntary seclusion.

9 “(4) If an incident requires notice under subsection (3) of this section, not later than two
10 business days following the date of the restraint or involuntary seclusion, the program shall
11 hold a debriefing meeting with each individual who was involved in the incident and with any
12 other appropriate program staff, shall take written notes of the debriefing meeting and shall
13 provide copies of the written notes to the child in care’s case manager, attorney, court ap-
14 pointed special advocate and parents or guardians.

15 “(5)(a) If a program places a child in care in a restraint or involuntary seclusion and the
16 child in care suffers a reportable injury arising from the restraint or involuntary seclusion,
17 the program shall immediately provide the department and the child in care’s attorney, court
18 appointed special advocate and parents or guardians with written notification of the incident
19 and access to and, upon request, copies of all records related to the restraint or involuntary
20 seclusion, including any photographs and audio or video recordings.

21 “(b) If serious bodily injury or the death of staff personnel occurs in connection to the
22 use of the restraint or involuntary seclusion, the program shall provide the department with
23 written notification of the incident not later than 24 hours following the incident.

24 “SECTION 6. Section 5 of this 2021 Act is amended to read:

25 “**Sec. 5.** (1) A program shall establish procedures for the program to follow when a child in care
26 is placed in a restraint or involuntary seclusion. The procedures must be consistent with the pro-
27 visions of this section and sections 2 and 3 of this 2021 Act.

28 “(2) A program shall maintain a record of each incident in which a reportable injury arises from
29 the use of a restraint or involuntary seclusion. The record under this subsection must include any
30 audio or video recording immediately preceding, during and following the incident.

31 “(3)(a) If a program places a child in care in a restraint except as provided in section 3 (3)(a)
32 or (b) of this 2021 Act, or involuntary seclusion, the program shall provide the child in care’s case
33 manager, attorney, court appointed special advocate and parents or guardians with:

34 “(A) Verbal or electronic notice that the restraint or involuntary seclusion was used as soon
35 as practicable following the incident but not later than the end of the next business day; and

36 “(B) Written notice that the restraint or involuntary seclusion was used as soon as practicable
37 following the incident but not later than the end of the next business day.

38 “(b) The written notice must include:

39 “(A) A description of the restraint or involuntary seclusion, the date of the restraint or invol-
40 untary seclusion, the times when the restraint or involuntary seclusion began and ended and the
41 location of the restraint or involuntary seclusion.

42 “(B) A description of the child in care’s activity that necessitated the use of restraint or invol-
43 untary seclusion.

44 “(C) The efforts the program used to de-escalate the situation and the alternatives to restraint
45 or involuntary seclusion the program attempted before placing the child in care in the restraint or

1 involuntary seclusion.

2 “(D)(i) The names of each of individual who placed the child in care in the restraint or invol-
3 untary seclusion or who monitored or approved the placement of the child in care in the restraint
4 or involuntary seclusion.

5 “(ii) For each individual identified in this subparagraph, whether the individual was **certified**
6 **as described in section 9 of this 2021 Act in the use of the type of restraint used or** trained,
7 as required by the Department of Human Services by rule, in the use of the *[type of restraint or]*
8 involuntary seclusion used, the date of the individual’s most recent **certification or** training and a
9 description of the types of restraint the individual is *[trained]* **certified** to use, if any.

10 “(iii) If an individual identified in this subparagraph was not **certified or** trained in the type
11 of restraint or involuntary seclusion used, or if the individual’s **certification or** training was not
12 current, a description of the individual’s **certification or** training deficiency and the reason an in-
13 dividual without the proper **certification or** training was involved in the restraint or involuntary
14 seclusion.

15 “(4) If an incident requires notice under subsection (3) of this section, not later than two busi-
16 ness days following the date of the restraint or involuntary seclusion, the program shall hold a de-
17 briefing meeting with each individual who was involved in the incident and with any other
18 appropriate program staff, shall take written notes of the debriefing meeting and shall provide copies
19 of the written notes to the child in care’s case manager, attorney, court appointed special advocate
20 and parents or guardians.

21 “(5)(a) If a program places a child in care in a restraint or involuntary seclusion and the child
22 in care suffers a reportable injury arising from the restraint or involuntary seclusion, the program
23 shall immediately provide the department and the child in care’s attorney, court appointed special
24 advocate and parents or guardians with written notification of the incident and access to and, upon
25 request, copies of all records related to the restraint or involuntary seclusion, including any photo-
26 graphs and audio or video recordings.

27 “(b) If serious bodily injury or the death of staff personnel occurs in connection to the use of
28 the restraint or involuntary seclusion, the program shall provide the department with written no-
29 tification of the incident not later than 24 hours following the incident.

30 “**SECTION 7. Reporting requirements.** (1) **A program must prepare and submit to the**
31 **Department of Human Services a quarterly report detailing the program’s use of restraint**
32 **and involuntary seclusion for the preceding three-month period, including, at a minimum:**

33 “(a) **The total number of incidents involving restraint.**

34 “(b) **The total number of incidents involving involuntary seclusion.**

35 “(c) **The total number of involuntary seclusions in a locked room.**

36 “(d) **The total number of rooms available for use by the program for involuntary seclu-**
37 **sion and a description of the dimensions and design of the rooms.**

38 “(e) **The total number of children in care placed in restraint.**

39 “(f) **The total number of children in care placed in involuntary seclusion.**

40 “(g) **The total number of incidents under paragraph (a) or (b) of this subsection that re-**
41 **sulted in reportable injuries.**

42 “(h) **The number of children in care who were placed in restraint or involuntary seclusion**
43 **more than three times during the preceding three-month period and a description of the**
44 **steps the program has taken to decrease the use of restraint and involuntary seclusion.**

45 “(i) **The number of incidents in which an individual who placed a child in care in a re-**

1 **straint or involuntary seclusion was not trained, as required by the department by rule, in**
2 **the use of the type of restraint or involuntary seclusion used.**

3 **“(j) The demographic characteristics of the children in care who the program placed in**
4 **a restraint or involuntary seclusion, including race, ethnicity, gender, disability status,**
5 **migrant status, English proficiency and status as economically disadvantaged, unless the**
6 **demographic information would reveal personally identifiable information about an individual**
7 **child in care.**

8 **“(2)(a) If a program provides services in more than one location, the reports under sub-**
9 **section (1) of this section must separate the data for each location that serves five or more**
10 **children in care.**

11 **“(b) If the site-specific data for a given location is not provided under paragraph (a) of**
12 **this subsection because the program serves fewer than five children in care at that location,**
13 **the program’s report must include a notation indicating the aggregate number of children**
14 **in care served by the program across all of the program’s locations and the reporting re-**
15 **quirements under paragraph (a) of this subsection continue to apply to any of the program’s**
16 **other locations serving five or more children in care.**

17 **“(3)(a) The department shall make each quarterly report it receives under this section**
18 **available to the public on the department’s website.**

19 **“(b) Each program that submits a report under this section shall make its quarterly re-**
20 **port available to the public upon request at the program’s main office and on the program’s**
21 **website if the program maintains a website.**

22 **“(c) Each program shall provide notice regarding how to access the quarterly reports to**
23 **the parents or guardians of children in care in the program. The program shall provide the**
24 **notice upon the child in care’s admission and at least two times each year thereafter.**

25 **“SECTION 8.** Section 7 of this 2021 Act is amended to read:

26 **“Sec. 7. (1) A program must prepare and submit to the Department of Human Services a quar-**
27 **terly report detailing the program’s use of restraint and involuntary seclusion for the preceding**
28 **three-month period, including, at a minimum:**

29 **“(a) The total number of incidents involving restraint.**

31 **“(c) The total number of involuntary seclusions in a locked room.**

32 **“(d) The total number of rooms available for use by the program for involuntary seclusion and**
33 **a description of the dimensions and design of the rooms.**

34 **“(e) The total number of children in care placed in restraint.**

35 **“(f) The total number of children in care placed in involuntary seclusion.**

36 **“(g) The total number of incidents under paragraph (a) or (b) of this subsection that resulted in**
37 **reportable injuries.**

38 **“(h) The number of children in care who were placed in restraint or involuntary seclusion more**
39 **than three times during the preceding three-month period and a description of the steps the program**
40 **has taken to decrease the use of restraint and involuntary seclusion.**

41 **“(i) The number of incidents in which an individual who placed a child in care in a restraint**
42 **or involuntary seclusion was not certified as described in section 9 of this 2021 Act or trained,**
43 **as required by the department by rule, in the use of the type of restraint or involuntary seclusion**
44 **used.**

45 **“(j) The demographic characteristics of the children in care who the program placed in a re-**

1 straint or involuntary seclusion, including race, ethnicity, gender, disability status, migrant status,
2 English proficiency and status as economically disadvantaged, unless the demographic information
3 would reveal personally identifiable information about an individual child in care.

4 “(2)(a) If a program provides services in more than one location, the reports under subsection
5 (1) of this section must separate the data for each location that serves five or more children in care.

6 “(b) If the site-specific data for a given location is not provided under paragraph (a) of this
7 subsection because the program serves fewer than five children in care at that location, the
8 program’s report must include a notation indicating the aggregate number of children in care served
9 by the program across all of the program’s locations and the reporting requirements under para-
10 graph (a) of this subsection continue to apply to any of the program’s other locations serving five
11 or more children in care.

12 “(3)(a) The department shall make each quarterly report it receives under this section available
13 to the public on the department’s website.

14 “(b) Each program that submits a report under this section shall make its quarterly report
15 available to the public upon request at the program’s main office and on the program’s website if
16 the program maintains a website.

17 “(c) Each program shall provide notice regarding how to access the quarterly reports to the
18 parents or guardians of children in care in the program. The program shall provide the notice upon
19 the child in care’s admission and at least two times each year thereafter.

42 “(d) **Offer options for certification in skills that do not include the use of restraint to**
43 **improve agency-wide safety, culture and trauma-informed practices;**

44 “(e) **Prioritize the reduction or elimination of the use of restraint and involuntary se-**
45 **clusion;**

1 “(f) Ensure that any physical intervention skills taught are trauma-informed, age-
2 appropriate and developmentally appropriate for children in care, reduce the risk of physical
3 or emotional harm and are consistent with all state and federal laws;

4 “(g) Include training to identify the physical, psychological and emotional risks for chil-
5 dren and program staff related to the use of restraint and involuntary seclusion;

6 “(h) Ensure fidelity of training through the publication of consistent training materials
7 and resources for certified instructors and certified program staff;

8 “(i) Include requirements for instructor training and certification; and

9 “(j) Require regular, ongoing support to certified instructors, including quality control,
10 monitoring of outcomes and provision of information regarding networks for professional
11 collaboration and support.

12 “(3) The department’s rules must require that training instructors:

13 “(a) Be certified to conduct the type of training the instructor is providing;

14 “(b) Complete a minimum of 26 hours of initial education with a focus on de-escalation,
15 nonviolent intervention and methods consistent with the department’s rules for the use of
16 physical intervention;

17 “(c) Complete a minimum of 12 hours of continuing education every two years;

18 “(d) Be recertified at least once every two years; and

19 “(e) Demonstrate written and physical competency before receiving certification or re-

22 in a program in a restraint must be certified in the use of the specific type of restraint used.

13 **appointed special advocate and Disability Rights Oregon.**

14 **“(2) The information described in subsection (1) of this section must be provided by:**

15 **“(a) The Department of Human Services if the department placed the child in care in the**
16 **child-caring agency;**

17 **“(b) The Oregon Youth Authority if the child in care has been committed to the custody**
18 **of the authority; or**

19 **“(c) The child-caring agency, as required by the department by rule, for all other children**
20 **in care.**

21 **“SECTION 12.** ORS 418.257 is amended to read:

22 418.257. As used in ORS 418.257 to 418.259:

23 **“(1) ‘Abuse’ means one or more of the following:**

24 **“(a) Any physical injury to a child in care caused by other than accidental means, or that ap-**
25 **pears to be at variance with the explanation given of the injury.**

27 **“(c) Abandonment, including desertion or willful forsaking of a child in care or the withdrawal**

30 **“(d) Willful infliction of physical pain or injury upon a child in care.**

34 **“(g) Financial exploitation.**

35 **“(h) Sexual abuse.**

36 **“(i) *Involuntary seclusion of a child in care for the convenience of a child-caring agency, caretaker,***
37 ***certified foster home or developmental disabilities residential facility or to discipline the child in***
38 ***care.*]**

39 **“(j) *A wrongful use of a physical or chemical restraint of a child in care, excluding an act of re-***
40 ***straint prescribed by a physician licensed under ORS chapter 677 and any treatment activities that are***
41 ***consistent with an approved treatment plan or in connection with a court order.*]**

42 **“(i) The use of restraint or involuntary seclusion of a child in care in violation of section**
43 **2 or 3 of this 2021 Act.**

44 **“(2) ‘Certified foster home’ means a foster home certified by the Department of Human Services**
45 **and subject to ORS 418.625 to 418.645.**

1 “(3)(a) ‘Child in care’ means a person under 21 years of age who is residing in or receiving care
2 or services from:

3 “(A) A child-caring agency or proctor foster home subject to ORS 418.205 to 418.327, 418.470,
4 418.475 or 418.950 to 418.970;

5 “(B) A certified foster home; or

6 “(C) A developmental disabilities residential facility.

7 “(b) ‘Child in care’ does not include a person under 21 years of age who is residing in any of
8 the entities listed in paragraph (a) of this subsection when the care provided is in the home of the
9 child by the child’s parent.

10 “[~~4~~] *‘Child-caring agency’ has the meaning given that term in ORS 418.205.*]

11 “[~~5~~] (4) ‘Developmental disabilities residential facility’ means a residential facility or foster

13 services that is subject to ORS 443.400 to 443.455, 443.830 and 443.835.

14 “[~~6~~] *‘Involuntary seclusion’ means the confinement of a child in care alone in a room from which
15 the child in care is physically prevented from leaving. ‘Involuntary seclusion’ does not include age-
16 appropriate discipline, including but not limited to a time-out.*]

17 “[~~7~~] *‘Proctor foster home’ has the meaning given that term in ORS 418.205.*]

18 “[~~8(a)~~] (5)(a) ‘Financial exploitation’ means:

19 “(A) Wrongfully taking the assets, funds or property belonging to or intended for the use of a
20 child in care.

21 “(B) Alarming a child in care by conveying a threat to wrongfully take or appropriate moneys
22 or property of the child in care if the child would reasonably believe that the threat conveyed would
23 be carried out.

24 “(C) Misappropriating, misusing or transferring without authorization any moneys from any ac-
25 count held jointly or singly by a child in care.

26 “(D) Failing to use the income or assets of a child in care effectively for the support and
27 maintenance of the child in care.

28 “(b) ‘Financial exploitation’ does not include age-appropriate discipline that may involve the
29 threat to withhold, or the withholding of, privileges.

30 “[~~9~~] (6) ‘Intimidation’ means compelling or deterring conduct by threat. ‘Intimidation’ does not
31 include age-appropriate discipline that may involve the threat to withhold privileges.

32 “(7) **‘Involuntary seclusion’ has the meaning given that term in section 1 of this 2021 Act.**

33 “[~~10~~] (8) ‘Law enforcement agency’ means:

34 “(a) Any city or municipal police department.

35 “(b) Any county sheriff’s office.

36 “(c) The Oregon State Police.

37 “(d) Any district attorney.

38 “(e) A police department established by a university under ORS 352.121 or 353.125.

39 “[~~11~~] (9) ‘Neglect’ means:

40 “(a) Failure to provide the care, supervision or services necessary to maintain the physical and
41 mental health of a child in care; or

2 housing, medical services, assistance with bathing or personal hygiene or any other service essential
3 to the well-being of a child in care.

4 “[(13)] (12) ‘Sexual abuse’ means:

5 “(a) Sexual harassment, sexual exploitation or inappropriate exposure to sexually explicit mate-
6 rial or language;

7 “(b) Any sexual contact between a child in care and an employee of a child-caring agency,
8 proctor foster home, certified foster home, developmental disabilities residential facility, caretaker
9 or other person responsible for the provision of care or services to a child in care;

10 “(c) Any sexual contact between a person and a child in care that is unlawful under ORS
11 chapter 163 and not subject to a defense under that chapter; or

12 “(d) Any sexual contact that is achieved through force, trickery, threat or coercion.

13 “[(14)] (13) ‘Sexual contact’ has the meaning given that term in ORS 163.305.

14 “[(15)] (14) ‘Sexual exploitation’ means sexual exploitation as described in ORS 419B.005
15 (1)(a)(E).

16 “[(16)] (15) ‘Verbal abuse’ means to threaten significant physical or emotional harm to a child
17 in care through the use of:

18 “(a) Derogatory or inappropriate names, insults, verbal assaults, profanity or ridicule; or

19 “(b) Harassment, coercion, threats, intimidation, humiliation, mental cruelty or inappropriate
20 sexual comments.

21 “**SECTION 13.** ORS 418.259, as amended by section 9, chapter 19, Oregon Laws 2020 (first spe-
22 cial session), is amended to read:

23 “418.259. (1) The investigation conducted by the Department of Human Services under ORS
24 418.258 must result in one of the following findings:

25 “(a) That the report is substantiated. A report is substantiated when there is reasonable cause
26 to believe that the abuse of a child in care occurred.

27 “(b) That the report is unsubstantiated. A report is unsubstantiated when there is no evidence
28 that the abuse of a child in care occurred.

29 “(c) That the report is inconclusive. A report is inconclusive when there is some indication that
30 the abuse occurred but there is insufficient evidence to conclude that there is reasonable cause to
31 believe that the abuse occurred.

33 subjected to abuse, the department shall notify the case managers for the child, the attorney for the

12 **“(F) Make all reasonable efforts to conduct trauma-informed interviews of each child**

15 **child and is not in the best interests of the child.**

28 **investigation if the child in care has not been committed to the custody of the department or the**
29 **youth authority. Notification under this paragraph may not include any details or information other**
30 **than that a report of abuse has been substantiated.**

31 **“(f) Any governmental agency that has a contract with the child-caring agency to provide care**
32 **or services to a child in care.**

33 **“(g) The local citizen review board established by the Judicial Department under ORS 419A.090.**

34 **“(5) The department shall report on a quarterly basis to the interim legislative committees on**
35 **child welfare for the purposes of public review and oversight of the quality and safety of child-caring**
36 **agencies, certified foster homes and developmental disabilities residential facilities that are licensed,**
37 **certified or authorized by the department in this state and of proctor foster homes that are certified**
38 **by the child-caring agencies. Information provided in reports under this subsection may not contain**
39 **the name or any identifying information of a child in care but must contain all of the following:**

41 **ORS 418.215 requires a secure transportation services provider that transports children
42 to or from a school, agency, organization or program along a route that begins or ends in
43 Oregon to be licensed by the Department of Human Services.**

1 “(3) As used in this section, ‘child’ and ‘secure transportation services provider’ have the
2 meanings given those terms in ORS 418.205.

3 “**SECTION 15.** ORS 418.205, as amended by sections 15a and 15b, chapter 19, Oregon Laws 2020

5 “418.205. As used in ORS 418.205 to 418.327, 418.470, 418.475, 418.950 to 418.970 and 418.992 to
6 418.998, unless the context requires otherwise:

7 “(1) ‘Child’ means an unmarried person under 21 years of age who resides in or receives care
8 or services from a child-caring agency.

9 “(2)(a) ‘Child-caring agency’:

10 “(A) Means any private school, private agency, private organization or county program provid-

12 “(i) Day treatment for children with emotional disturbances;

13 “(ii) Adoption placement services;

14 “(iii) Residential care, including but not limited to foster care or residential treatment for chil-

16 “(iv) Residential care in combination with academic education and therapeutic care, including
17 but not limited to treatment for emotional, behavioral or mental health disturbances;

18 “(v) Outdoor youth programs; or

19 “(vi) Other similar care or services for children.

25 **“(v) A secure transportation services provider that transports or provides escort services

28 paragraph, if the school, agency, organization or program is located in this state or in any

31 “(A) Residential facilities or foster care homes certified or licensed by the Department of Human

35 pursuant to a properly executed power of attorney under ORS 109.056. For purposes of this subpar-
36 agraph, ‘respite services’ means the voluntary assumption of short-term care and control of a minor
37 child without compensation or reimbursement of expenses for the purpose of providing a parent in
38 crisis with relief from the demands of ongoing care of the parent’s child;

40 “(D) A shelter-care home that is a foster home subject to ORS 418.625 to 418.645;

43 “(G) A facility that primarily serves both adults and children but requires that any child must
44 be accompanied at all times by at least one custodial parent or guardian.

45 “(3) ‘Child-caring facility’ has the meaning given that term in ORS 418.950.

1 “(4)(a) ‘County program’ means any county operated program that provides care or services to
2 children:

3 “(A) In the custody of the Department of Human Services or the Oregon Youth Authority[.];
4 **or**

5 “(B) **Under a contract with the Oregon Health Authority.**

6 “(b) ‘County program’ does not include any local juvenile detention facility that receives state
7 services provided and coordinated by the Department of Corrections under ORS 169.070.

8 “(5) ‘Governmental agency’ means an executive, legislative or judicial agency, department,
9 board, commission, authority, institution or instrumentality of this state or of a county, municipality
10 or other political subdivision of this state.

11 “(6) ‘Independent residence facility’ means a facility established or certified under ORS 418.475.

12 “(7)(a) ‘Outdoor youth program’ means a program that provides, in an outdoor living setting,
13 services to children who have behavioral problems, mental health problems or problems with abuse
14 of alcohol or drugs.

15 “(b) ‘Outdoor youth program’ does not include any program, facility or activity:

16 “(A) Operated by a governmental entity;

17 “(B) Operated or affiliated with the Oregon Youth Corps;

18 “(C) Licensed by the Department of Human Services under other authority of the department;

19 **or**

20 “(D) Operated by a youth job development organization as defined in ORS 344.415.

21 “(8) ‘Private’ means not owned, operated or administered by any governmental agency or unit.

22 “(9) ‘Private residential boarding school’ means either of the following as the context requires:

23 “(a) A child-caring agency that is a private school that provides residential care in combination
24 with academic education and therapeutic care, including but not limited to treatment for emotional,
25 behavioral or mental health disturbances; or

26 “(b) A private school providing residential care that is primarily engaged in educational work
27 under ORS 418.327.

28 “(10) ‘Proctor foster home’ means a foster home certified by a child-caring agency under ORS
29 418.248 that is not subject to ORS 418.625 to 418.645.

30 “(11) ‘Provider of care or services for children’ means a person, entity or organization that
31 provides care or services to children, regardless of whether the child is in the custody of the De-
32 partment of Human Services, and that does not otherwise meet the definition of, or requirements for,
33 a child-caring agency. ‘Provider of care or services for children’ includes a proctor foster home
34 certified by a child-caring agency under ORS 418.248.

35 “(12) ‘Qualified residential treatment program’ means a program described in section 12b, chap-
36 ter 19, Oregon Laws 2020 (first special session).

37 “(13) **‘Secure transportation services provider’ means a private organization or person**
38 **that provides secure transportation or secure escort services for children to or from a**
39 **school, agency, organization or program described in subsection (2)(a)(A) of this section, if**
40 **the school, agency, organization or program is located in this state or in any other state.**

41 “[13] (14) ‘Shelter-care home’ has the meaning given that term in ORS 418.470.

43 **“MISCELLANEOUS**

45 **“SECTION 16. Reports first due. The reports under section 7 of this 2021 Act are due on**

1 November 1, 2021, and quarterly thereafter. The reports due on November 1, 2021, must in-
2 clude data regarding the program’s use of restraint and involuntary seclusion from July 1,
3 2021, through September 1, 2021.

4 “**SECTION 17. Operative dates.** (1)(a) The amendments to sections 3, 5, 7 and 9 of this
5 2021 Act by sections 4, 6, 8 and 10 of this 2021 Act become operative on July 1, 2022.

6 “(b) The Department of Human Services may adopt rules and take any other action be-
7 fore the operative date specified in paragraph (a) of this subsection that is necessary to en-
8 able the department, on or after the operative date specified in paragraph (a) of this
9 subsection, to undertake and exercise all of the duties, functions and powers conferred on
10 the department by the amendments to sections 3, 5, 7 and 9 of this 2021 Act by sections 4,
11 6, 8 and 10 of this 2021 Act.

12 “(2)(a) Section 14 of this 2021 Act and the amendments to ORS 418.205 by section 15 of
13 this 2021 Act become operative on January 2, 2022.

14 “(b) The department may adopt rules and take any other action before the operative date
15 specified in paragraph (a) of this subsection that is necessary to enable the department, on
16 or after the operative date specified in paragraph (a) of this subsection, to undertake and
17 exercise all of the duties, functions and powers conferred on the department by section 14
18 of this 2021 Act and the amendments to ORS 418.205 by section 15 of this 2021 Act.

19 “**SECTION 18. Captions.** The unit and section captions used in this 2021 Act are provided
20 only for the convenience of the reader and do not become part of the statutory law of this
21 state or express any legislative intent in the enactment of this 2021 Act.

22 “**SECTION 19. Effective date.** This 2021 Act being necessary for the immediate preserva-
23 tion of the public peace, health and safety, an emergency is declared to exist, and this 2021
24 Act takes effect on its passage.”.
