

Senate Bill 817

Sponsored by COMMITTEE ON JUDICIARY AND BALLOT MEASURE 110 IMPLEMENTATION

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Eliminates fees, court costs and fines associated with juvenile delinquency matters. Provides for appointment of court-appointed counsel at state expense in all juvenile delinquency matters. Removes parental support obligation for youths, youth offenders or young persons in state custody. Applies retroactively, rendering as satisfied judgments with outstanding balances and waiving accrued interest, fees and collection expenses on those balances.

Takes effect on 91st day following adjournment sine die.

17 **SECTION 1.** ORS 419C.610 is amended to read:

18 419C.610. (1) Except as provided in ORS 419C.613, 419C.615 and 419C.616, the court may modify
19 or set aside any order made by it upon such notice and with such hearing as the court may direct.

20 (2) When the court modifies or sets aside an order of jurisdiction based on a petition alleging
21 that a youth offender has committed an act that would constitute a sex crime, as defined in ORS
22 163A.005, if committed by an adult, the court shall make written findings stating the reason for
23 modifying or setting aside the order.

24 **(3)(a) The court, on its own motion, may vacate an order or judgment directing a youth,**
25 **youth offender or young person, or the parent or guardian of a youth, youth offender or**
26 **young person, to pay any fees or costs inconsistent with this chapter or any other provision**
27 **of law.**

28 **(b) The court, upon the motion of any party, may vacate an order or judgment directing**

 6 **SECTION 2.** ORS 339.990 is amended to read:

7 339.990. Violation of [*ORS 339.020 or*] the requirements of ORS 339.035 is a Class C violation.

8 **SECTION 3.** ORS 339.095 is amended to read:

9 339.095. (1) In addition to any other persons permitted to enforce violations, the school district
 10 superintendent or education service district superintendent, or any employee specifically designated
 11 by either superintendent, may issue citations for violations established under ORS 339.990 in the
 12 manner provided by ORS chapter 153.

13 (2) Prior to issuing the citation described in subsection (3) of this section to the parent or
 14 guardian of a student not regularly attending full-time school, a school district superintendent or
 15 education service district superintendent shall:

16 (a) Provide a parent or guardian of the student and the student with written notification that:

17 (A) States that the student is required to attend regularly a full-time school;

18 [*(B) Explains that the failure to send the student and maintain the student in regular attendance*

 8 **FINES, FEES AND COSTS; COURT-APPOINTED COUNSEL**

9
 10 **SECTION 5.** Section 6 of this 2021 Act is added to and made a part of ORS chapter 419C.

11 **SECTION 6.** (1) A court may not assess any fee or fine under ORS 137.533, 137.540,
 12 409.220, 809.267 or 813.240 arising out of the actions of a person who:

13 (a) Was under 18 years of age at the time of the act or is subject to juvenile court pro-
 14 bation; and

15 (b) Was not waived to circuit court for prosecution as an adult under ORS 419C.340.

16 (2) The fees and fines described in subsection (1) of this section may not be assessed
 17 against the child, youth, youth offender, young person or, if the fee or cost would be assessed
 18 after the person attains the age of 18, the person, or against the parent or guardian of the
 19 child, youth, youth offender, young person or person.

20 **SECTION 6a.** ORS 1.188 is amended to read:

21 1.188. (1) As used in this section, “offense” means:

22 (a) A violation of a parking ordinance; or

23 (b) A traffic offense as defined in ORS 801.555 (2).

24 (2) Notwithstanding ORS 137.143, the presiding judge of the judicial district in which a county
 25 is located may order that the circuit court for the county impose a surcharge in the amount of \$5
 26 on each fine assessed for an offense in the county if:

27 (a) The county has received funds, or has legislative authorization to receive funds, for a county
 28 courthouse from the proceeds of bonds issued pursuant to Article XI-Q of the Oregon Constitution
 29 deposited in the Oregon Courthouse Capital Construction and Improvement Fund established in
 30 section 64, chapter 723, Oregon Laws 2013;

31 (b) Debt service is owed on any Article XI-Q bonds issued related to the county courthouse;

32 (c) Debt service is owed on any bonds issued under ORS 271.390 or ORS chapter 287A to finance
 33 capital costs of the courthouse project for which bonds are or will be issued under section 8, chapter
 34 705, Oregon Laws 2013, in the county imposing the surcharge;

35 (d) The board of county commissioners has requested that the presiding judge of the judicial
 36 district in which the county is located order the imposition of a surcharge and has identified the
 37 purposes for which the surcharge funds would be used; and

38 (e) The Chief Justice of the Supreme Court has approved the surcharge.

39 (3) The circuit court for the county may not impose a surcharge under this section unless, before
 40 July 1 of the calendar year preceding the imposition of the surcharge, the court submits to the State
 41 Court Administrator a copy of the order imposing the surcharge. The court may begin imposing the
 42 surcharge on fines for offenses occurring on and after January 1 of the calendar year following
 43 submission of the order to the State Court Administrator.

44 (4) Except as provided in ORS 153.640 and 221.315, the surcharge shall be levied fully if any fine
 45 is imposed.

1 (5) The surcharge shall be collected by the circuit court for the county and paid to the county
 2 for deposit in the account established under ORS 1.189 and used solely for:

3 (a) Payment of capital costs of the courthouse project for which bonds are or will be issued
 4 under section 8, chapter 705, Oregon Laws 2013, in the county imposing the surcharge; or

5 (b) Payment of debt service and related expenses and funding of debt service reserves, if any,
 6 for bonds issued under ORS 271.390 or ORS chapter 287A to finance capital costs of the courthouse
 7 project for which bonds are or will be issued under section 8, chapter 705, Oregon Laws 2013, in the
 8 county imposing the surcharge.

9 **(6) The circuit court for the county may not impose a surcharge under this section**
 10 **against a youth, youth offender or young person, or against the parent or guardian of a**
 11 **youth, youth offender or young person, if the surcharge would be imposed due to the actions**
 12 **of the youth, youth offender or young person.**

13 **SECTION 7.** ORS 1.202 is amended to read:

14 1.202. (1) All circuit courts and appellate courts of this state, and all commissions, departments
 15 and divisions in the judicial branch of state government, shall add a fee of not less than \$50 and
 16 not more than \$200 to any judgment that includes a monetary obligation that the court or judicial
 17 branch is charged with collecting. The fee shall cover the cost of establishing and administering an
 18 account for the debtor and shall be added without further notice to the debtor or further order of
 19 the court. The fee shall be added only if the court gives the defendant a period of time in which to
 20 pay the obligation after the financial obligation is imposed. Fees under this subsection shall be de-
 21 posited in the General Fund.

22 (2) All circuit courts and appellate courts of this state, and all commissions, departments and
 23 divisions in the judicial branch of state government, that use private collection agencies, the De-
 24 partment of Revenue or an offset of federal tax refunds pursuant to an agreement entered into under
 25 ORS 1.196 shall add a fee to any judgment referred for collection that includes a monetary obli-
 26 gation that the state court or the commission, department or division is charged with collecting. A
 27 fee to cover the costs of collecting judgments referred to the private collection agency, the De-
 28 partment of Revenue, the United States Financial Management Service or the Internal Revenue
 29 Service shall be added to the monetary obligation without further notice to the debtor or further
 30 order of the court. The fee may not exceed the actual costs of collecting the judgment.

31 **(3) The fees described in subsections (1) and (2) of this section may not be added to any**
 32 **order or judgment arising from the actions of a person who:**

33 **(a) Was under 18 years of age at the time of the act or is subject to juvenile court pro-**
 34 **bation; and**

35 **(b) Was not waived to circuit court for prosecution as an adult under ORS 419C.340.**

36 [(3)] (4) The Chief Justice of the Supreme Court may authorize courts to waive or suspend the
 37 fees required to be added to judgments under this section. Except to the extent authorized by the
 38 Chief Justice, a court may not waive or suspend the fees required to be added to judgments under
 39 this section.

41 21.135. (1) Unless a specific fee is provided by subsection (3) of this section or other law for a
 42 proceeding, a circuit court shall collect a filing fee of \$281 when a complaint or other document is
 43 filed for the purpose of commencing an action or other civil proceeding and when an answer or
 44 other first appearance is filed in the proceeding.

45 **(2) Except as provided in subsection (4) of this section,** the filing fee established by sub-

1 section (1) of this section applies to:

2 (a) Proceedings in which only equitable remedies are sought.

3 (b) Appeals from a conviction of a violation in justice or municipal courts as provided in ORS
4 21.285.

5 (c) Interpleader actions.

6 (d) Actions relating to a trust.

7 (e) Proceedings for judicial review of an agency order.

8 (f) Declaratory judgment actions.

9 (g) Any other action or proceeding that is statutorily made subject to the fee established by this
10 section and any other civil proceeding for which a specific filing fee is not provided.

11 (3)(a) The circuit court shall collect a filing fee of \$263 in adoption cases under ORS chapter
12 109, excluding readoptions under ORS 109.385, when a petition is filed for the purpose of commenc-
13 ing an adoption proceeding or when any other document or other first appearance is filed in the
14 proceeding. The fee shall include the cost of issuing one or more certificates of adoption under ORS
15 109.410.

16 (b) When separate petitions for adoption of multiple minor children are concurrently filed under
17 ORS 109.309 by the same petitioner, one filing fee shall be charged for the first petition filed and
18 the filing fees for concurrently filed petitions shall not be charged.

19 **(4) The filing fee established under subsection (1) of this section does not apply to:**

20 **(a) Expunction proceedings under ORS 419A.262;**

23 **(c) Any juvenile delinquency proceeding arising under ORS chapter 419B or 419C.**

24 **SECTION 9.** ORS 151.216 is amended to read:

25 151.216. (1) The Public Defense Services Commission shall:

26 (a) Establish and maintain a public defense system that ensures the provision of public defense
27 services in the most cost-efficient manner consistent with the Oregon Constitution, the United States
28 Constitution and Oregon and national standards of justice.

29 (b) Establish an office of public defense services and appoint a public defense services executive
30 director who serves at the pleasure of the commission.

31 (c) Submit the budget of the commission and the office of public defense services to the Legis-
32 lative Assembly after the budget is submitted to the commission by the director and approved by the
33 commission. The Chief Justice of the Supreme Court and the chairperson of the commission shall
34 present the budget to the Legislative Assembly.

35 (d) Review and approve any public defense services contract negotiated by the director before
36 the contract can become effective.

37 (e) Adopt a compensation plan, classification system and personnel plan for the office of public
38 defense services that are commensurate with other state agencies.

39 (f) Adopt policies, procedures, standards and guidelines regarding:

40 (A) The determination of financial eligibility of persons entitled to be represented by appointed
41 counsel at state expense;

42 (B) The appointment of counsel, **including the appointment of counsel at state expense re-**
43 **gardless of financial eligibility in juvenile delinquency matters;**

44 (C) The fair compensation of counsel appointed to represent a person [*financially*] eligible for
45 appointed counsel at state expense;

1 (D) Appointed counsel compensation disputes;

2 (E) Any other costs associated with the representation of a person by appointed counsel in the
3 state courts that are required to be paid by the state under ORS 34.355, 135.055, 138.500, 138.590,
4 161.346, 161.348, 161.365, 419A.211, 419B.201, 419B.208, 419B.518, 419B.908, 419C.206, 419C.209,
5 419C.408, 419C.535, 426.100, 426.135, 426.250, 426.307, 427.265, 427.295, 436.265 or 436.315 or any
6 other provision of law that expressly provides for payment of such compensation, costs or expenses
7 by the commission;

8 (F) Professional qualifications for counsel appointed to represent public defense clients;

9 (G) Performance for legal representation;

10 (H) The contracting of public defense services;

11 (I) Contracting with expert witnesses to allow contracting with out-of-state expert witnesses
12 only if in-state expert witnesses are not available or are more expensive than out-of-state expert
13 witnesses; and

14 (J) Any other matters necessary to carry out the duties of the commission.

15 (g) Establish a peer review system for the approval of nonroutine fees and expenses incurred in
16 cases involving aggravated murder and the crimes listed in ORS 137.700 and 137.707. The review
17 shall be conducted by a panel of attorneys who practice in the area of criminal defense.

18 (h) Establish a complaint process that allows district attorneys, criminal defense counsel and the
19 public to file complaints concerning the payment from public funds of nonroutine fees and expenses
20 incurred in cases.

21 (i) Reimburse the State Court Administrator from funds deposited in the Public Defense Services
22 Account established by ORS 151.225 for the costs of personnel and other costs associated with lo-
23 cation of eligibility verification and screening personnel pursuant to ORS 151.489 by the State Court
24 Administrator.

25 (2) Policies, procedures, standards and guidelines adopted by the commission supersede any
26 conflicting rules, policies or procedures of the Public Defender Committee, State Court Administra-
27 tor, circuit courts, the Court of Appeals, the Supreme Court and the Psychiatric Security Review
28 Board related to the exercise of the commission's administrative responsibilities under this section
29 and transferred duties, functions and powers as they occur.

30 (3) The commission may accept gifts, grants or contributions from any source, whether public
31 or private. However, the commission may not accept a gift, grant or contribution if acceptance
32 would create a conflict of interest. Moneys accepted under this subsection shall be deposited in the
33 Public Defense Services Account established by ORS 151.225 and expended for the purposes for
34 which given or granted.

35 (4) The commission may not:

36 (a) Make any decision regarding the handling of any individual case;

37 (b) Have access to any case file; or

38 (c) Interfere with the director or any member of the staff of the director in carrying out pro-
39 fessional duties involving the legal representation of public defense clients.

40 **SECTION 10.** ORS 151.219 is amended to read:

41 151.219. (1) The public defense services executive director shall:

42 (a) Recommend to the Public Defense Services Commission how to establish and maintain, in a
43 cost-effective manner, the delivery of legal services to persons entitled to, and, **where applicable**,
44 financially eligible for, appointed counsel at state expense under Oregon statutes, the Oregon Con-
45 stitution, the United States Constitution and consistent with Oregon and national standards of jus-

1 tice.

2 (b) Implement and ensure compliance with contracts, policies, procedures, standards and guide-
3 lines adopted by the commission or required by statute.

4 (c) Prepare and submit to the commission for its approval the biennial budget of the commission
5 and the office of public defense services.

6 (d) Negotiate contracts, as appropriate, for providing legal services to persons [*financially*] eli-
7 gible for appointed counsel at state expense. No contract so negotiated is binding or enforceable
8 until the contract has been reviewed and approved by the commission as provided in ORS 151.216.

9 (e) Employ personnel or contract for services as necessary to carry out the responsibilities of
10 the director and the office of public defense services.

11 (f) Supervise the personnel, operation and activities of the office of public defense services.

12 (g) Provide services, facilities and materials necessary for the performance of the duties, func-
13 tions and powers of the Public Defense Services Commission.

14 (h) Pay the expenses of the commission and the office of public defense services.

15 (i) Prepare and submit to the commission an annual report of the activities of the office of public
16 defense services.

17 (j) Prepare and submit to the Legislative Assembly a biennial report on the activities of the of-
18 fice of public defense services.

19 (k) Provide for legal representation, advice and consultation for the commission, its members,
20 the director and staff of the office of public defense services who require such services or who are
21 named as defendants in lawsuits arising from their duties, functions and responsibilities. If requested
22 by the director, the Attorney General may also provide for legal representation, advice and consul-
23 tation for the commission, its members, the director and staff of the office of public defense services
24 in litigation.

25 (2) The director may designate persons as representatives of the director for the purposes of
26 determining and paying bills submitted to the office of public defense services and determining pre-
27 authorization for incurring fees and expenses under ORS 135.055.

28 **SECTION 11.** ORS 419A.211 is amended to read:

29 419A.211. (1) If the child, ward, youth, youth offender, parent or guardian is determined to be
30 entitled to, and, **except as provided in subsection (4) of this section**, financially eligible for, ap-
31 pointment of counsel at state expense in an appeal as provided in ORS 419A.200 and 419A.208, the
32 court, upon request of the person or upon its own motion, shall appoint suitable counsel to represent
33 the person. Counsel appointed by the court shall be paid compensation determined by the public
34 defense services executive director as provided in ORS 135.055 if the circuit court is the appellate
35 court or as provided in ORS 138.500 if the Court of Appeals or the Supreme Court is the appellate
36 court. The court may not substitute one appointed counsel for another except pursuant to the poli-
37 cies, procedures, standards and guidelines of the Public Defense Services Commission.

38 (2)(a) When the court appoints counsel to represent the child[,] **or** ward, [*youth or youth*
39 *offender,*] it may order the parent, if able, or guardian of the estate, if the estate is able, to pay to
40 the Public Defense Services Account established by ORS 151.225, through the clerk of the court, in
41 full or in part the administrative costs of determining the ability of the parents or estate to pay for
42 legal services and the costs of the legal and other services that are related to the provision of ap-
43 pointed counsel.

44 (b) The test of the parent's or estate's ability to pay costs under paragraph (a) of this subsection
45 is the same test as applied to appointment of counsel for defendants under ORS 151.216. If counsel

1 is provided at state expense, the court shall apply this test in accordance with the guidelines
2 adopted by the Public Defense Services Commission under ORS 151.485.

3 (c) If counsel is provided at state expense, the court shall determine the amount the parents or
4 estate is required to pay for the costs of administrative, legal and other services related to the
5 provision of appointed counsel in the same manner as this amount is determined under ORS 151.487.

6 (d) The court's order of payment is enforceable in the same manner as an order of support under
7 ORS 419B.408 [*and 419C.600*].

8 (3) When the court appoints counsel [*and the child, ward, youth, youth offender, parent or*
9 *guardian has been determined to be entitled to, and financially eligible for, appointed counsel*] **under**
10 **this section** at state expense, the compensation for counsel and costs and expenses necessary to the
11 appeal shall be determined and paid as provided in ORS 135.055 if the circuit court is the appellate
12 court or as provided in ORS 138.500 if the Court of Appeals or the Supreme Court is the appellate
13 court.

14 (4) **Notwithstanding subsection (1) of this section, a youth or youth offender, or the**
15 **parent or guardian of the youth or youth offender, is entitled to court-appointed counsel at**
16 **state expense under this section regardless of the financial circumstances of the youth or**
17 **youth offender or the parent or guardian of the youth or youth offender. In addition, the**
18 **court may not order the youth's or youth offender's parent or guardian to pay any part of**
19 **the administrative costs of determining the entitlement of the youth, youth offender, parent**
20 **or guardian to court-appointed counsel at state expense nor any of the costs of the legal and**
21 **other services that are related to the provision of appointed counsel.**

22 **SECTION 12.** ORS 419C.020 is amended to read:

23 419C.020. (1) At the first appearance by the parents or guardian of a youth before the court, the
24 court shall inform the parents or guardian verbally and provide a standard notice describing:

25 [*(a) The obligation of the parents or guardian to pay for compensation and reasonable expenses for*
26 *counsel for the youth, support of the youth while the youth is in the custody of a state-financed or*
27 *state-supported residence and any other obligations to pay money that may arise as a result of the youth*
28 *being within the jurisdiction of the court;*]

29 [*(b) The assignment of support rights under ORS 419C.597;*]

30 (a) **The youth's right to court-appointed counsel at state expense;**

31 [(c)] (b) The right of the parents or guardian to appeal a decision on jurisdiction or disposition
32 made by the court; [*and*]

33 [(d)] (c) The time for filing an appeal of a decision by the court[.];

34 (d) **That neither the youth nor the youth's parents or guardian may be asked or ordered**
35 **to pay administrative costs associated with the youth's involvement with the court, pro-**
36 **batation, detention or Oregon Youth Authority services, including but not limited to applica-**
37 **tions for court-appointed counsel, court-appointed counsel attorney fees and costs associated**
38 **with legal representation, collection referral fees, transaction assessments, copy fees, fees**
39 **for applications for expunction of records, juvenile sex offender reporting fees, electronic**
40 **payment fees or fees for checks that are returned for insufficient funds; and**

41 (e) **The court's obligation to consider assessment of restitution, including establishing a**
42 **payment schedule and finding satisfaction of a restitution judgment, under ORS 419C.450.**

43 (2) The [*Oregon Youth Authority*] **Judicial Department** shall prepare and provide the standard
44 notice required under subsection (1) of this section.

 31 formal accountability agreement may not be entered into when the youth:

32 (a) Is alleged to have committed an act that if committed by an adult would constitute:

33 (A) A felony sex offense under ORS 163.355, 163.365, 163.375, 163.385, 163.395, 163.405, 163.408,
 34 163.411, 163.425 or 163.427; or

35 (B) An offense involving the use or possession of a firearm, as defined in ORS 166.210, or de-
 36 structive device, as described in ORS 166.382; or

37 (b) Is being referred to the county juvenile department for a second or subsequent time for
 38 commission of an act that if committed by an adult would constitute a felony.

39 (3) The juvenile department must consult the victim before entering into a formal accountability

42 (b) The formal accountability agreement involves an alleged act that if committed by an adult
 43 would constitute a violent felony.

8 (3)(a) A person conditionally released under this section remains within the jurisdiction of the

10 (b) At any time after the entry of an order of conditional release, the court, on its own motion
11 or on motion of the Department of Corrections, may amend the conditional release order to modify
12 the conditions of the person's release and supervision, providing that the modifications are consist-

42 tled to receive such payments.

43 (b) During a period for which support is assigned under ORS 412.024, for an obligee described
44 in subsection (1)(b) of this section, the department shall disburse to the obligee, from child support
45 collected each month, \$50 for each child up to a maximum of \$200 per family.

1 (3)(a) When the administrator is providing support enforcement services under ORS 25.080, the
2 obligee may enter into an agreement with a collection agency, as defined in ORS 697.005, for as-
3 sistance in collecting child support payments.

4 (b) The collection agency:

5 (A) May provide investigative and location services to the obligee and disclose relevant infor-
6 mation from those services to the administrator for purposes of providing support enforcement ser-
7 vices under ORS 25.080;

8 (B) May not charge interest or a fee for its services exceeding 29 percent of each support pay-
9 ment received unless the collection agency, if allowed by the terms of the agreement between the
10 collection agency and the obligee, hires an attorney to perform legal services on behalf of the

12 (C) May not initiate, without written authorization from the administrator, any enforcement

18 the obligor is not billed. In addition, the entity providing support enforcement services shall file with
19 the circuit court in which the support order or judgment has been entered a copy of the notice de-
20 scribed in subsection (3) of this section or, if an objection is made and the presumption is not re-
21 butted, a copy of the court's or administrative law judge's order.

22 (6) An order that has been suspended as provided in this section will automatically be reinstated
23 at 50 percent of the previously ordered support amount on the first day of the first month that fol-
