**PROPOSED AMENDMENTS TO
SENATE BILL 554**

1 On page 1 of the printed bill, delete lines 22 through 26 and delete page
2 2 and insert:

3 **“SECTION 2.** ORS 166.360 is amended to read:

4 “166.360. As used in ORS 166.360 to 166.380, unless the context requires
5 otherwise:

6 “(1) ‘Capitol building’ means the Capitol, the State Office Building, the
7 State Library Building, the Labor and Industries Building, the State Trans-
8 portation Building, the Agriculture Building or the Public Service Building
9 and includes any new buildings which may be constructed on the same
10 grounds as an addition to the group of buildings listed in this subsection.

11 “(2) ‘Court facility’ means a courthouse or that portion of any other
12 building occupied by a circuit court, the Court of Appeals, the Supreme
13 Court or the Oregon Tax Court or occupied by personnel related to the op-
14 erations of those courts, or in which activities related to the operations of
15 those courts take place.

16 “(3) ‘Judge’ means a judge of a circuit court, the Court of Appeals, the
17 Supreme Court, the Oregon Tax Court, a municipal court, a probate court
18 or a juvenile court or a justice of the peace.

19 “(4) ‘Judicial district’ means a circuit court district established under
20 ORS 3.012 or a justice of the peace district established under ORS 51.020.

21 “(5) ‘Juvenile court’ has the meaning given that term in ORS 419A.004.

1 “(6) ‘Loaded firearm’ means:
2 “(a) A breech-loading firearm in which there is an unexpended cartridge
3 or shell in or attached to the firearm including but not limited to, in a
4 chamber, magazine or clip which is attached to the firearm.
5 “(b) A muzzle-loading firearm which is capped or primed and has a powder
6 charge and ball, shot or projectile in the barrel or cylinder.
7 “(7) ‘Local court facility’ means the portion of a building in which a
8 justice court, a municipal court, a probate court or a juvenile court conducts
9 business, during the hours in which the court operates.
10 “(8) ‘Probate court’ has the meaning given that term in ORS 111.005.
11 “(9)(a) ‘Public building’ means:
12 “(A)(i) A hospital[,];
13 “(ii) A capitol building[,];
14 “(iii) A public or private school, as defined in ORS 339.315[,];
15 “(iv) A college or university[,];
16 “(v) A city hall; [or]
17 “(vi) The residence of any state official elected by the state at large, *and*
18 *the grounds adjacent to each such building.*];
19 “(vii) **A building owned by the state or by a city, a county or a**
20 **metropolitan service district organized under ORS chapter 268; or**
21 “(viii) The [*term also includes that*] portion of any other building occupied
22 **or controlled** by an agency of the state or a municipal corporation, as de-
23 fined in ORS 297.405, other than a court facility[.];
24 “(B) **The grounds adjacent to a building described in subparagraph**
25 **(A) of this paragraph;**
26 “(C) **Real property owned by a college or university; or**
27 “(D) **The passenger terminal, and grounds adjacent to the passenger**
28 **terminal, of a commercial service airport.**
29 “(b) **‘Public building’ does not include that part of any building or**
30 **grounds described in paragraph (a) of this subsection that serves as a**

1 **parking area or parking garage.**

2 “(10) ‘Weapon’ means:

3 “(a) A firearm;

4 “(b) Any dirk, dagger, ice pick, slingshot, metal knuckles or any similar
5 instrument or a knife, other than an ordinary pocketknife with a blade less
6 than four inches in length, the use of which could inflict injury upon a
7 person or property;

8 “(c) Mace, tear gas, pepper mace or any similar deleterious agent as de-
9 fined in ORS 163.211;

10 “(d) An electrical stun gun or any similar instrument;

11 “(e) A tear gas weapon as defined in ORS 163.211;

12 “(f) A club, bat, baton, billy club, bludgeon, knobkerrie, nunchaku,
13 nightstick, truncheon or any similar instrument, the use of which could in-
14 flict injury upon a person or property; or

15 “(g) A dangerous or deadly weapon as those terms are defined in ORS
16 161.015.”.
