**PROPOSED AMENDMENTS TO
HOUSE BILL 2004**

1 In line 2 of the printed bill, before the period insert “; and declaring an
2 emergency”.

3 Delete lines 4 through 8 and insert:

4 **“SECTION 1. In addition to and not in lieu of any other appropri-
5 ation, there is appropriated to the Housing and Community Services
6 Department, for the biennium beginning July 1, 2021, out of the Gen-
7 eral Fund, the following amounts:**

8 **“(1) \$27,000,000 for grants under section 9, chapter __, Oregon Laws
9 2021 (Enrolled House Bill 2006); and**

10 **“(2) \$2,000,000 for technical assistance under section 9, chapter __,
11 Oregon Laws 2021 (Enrolled House Bill 2006).**

12 **“SECTION 2. In addition to and not in lieu of any other appropri-
13 ation, there is appropriated to the Oregon Department of Administra-
14 tive Services, for the biennium beginning July 1, 2021, out of the
15 General Fund, the following amounts:**

16 **“(1) \$1,500,000 to the City of McMinnville for a navigation center,
17 pursuant to section 10, chapter __, Oregon Laws 2021 (Enrolled House
18 Bill 2006);**

19 **“(2) \$1,500,000 to the City of Roseburg for a navigation center pur-
20 suant to section 10, chapter __, Oregon Laws 2021 (Enrolled House Bill
21 2006).**

1 **“(3) \$2,500,000 to the City of Bend for a navigation center pursuant**
2 **to section 10, chapter ___, Oregon Laws 2021 (Enrolled House Bill 2006);**

3 **“(4) \$2,500,000 to the City of Medford for a navigation center pur-**
4 **suant to section 10, chapter ___, Oregon Laws 2021 (Enrolled House Bill**
5 **2006);**

6 **“(5) \$5,000,000 to the City of Salem for a navigation center pursuant**
7 **to section 10, chapter ___, Oregon Laws 2021 (Enrolled House Bill 2006);**
8 **and**

9 **“(6) \$5,000,000 to Lane County for a navigation center within the**
10 **City of Eugene pursuant to section 10, chapter ___, Oregon Laws 2021**
11 **(Enrolled House Bill 2006).**

12 **“SECTION 3. Sections 1 and 2 of this 2021 Act become operative on**
13 **the date that chapter ___, Oregon Laws 2021 (Enrolled House Bill 2006),**
14 **becomes law.**

15 **“SECTION 4. This 2021 Act being necessary for the immediate**
16 **preservation of the public peace, health and safety, an emergency is**
17 **declared to exist, and this 2021 Act takes effect on its passage.”.**
