**PROPOSED AMENDMENTS TO
HOUSE BILL 2004**

1 In line 2 of the printed bill, before the period insert “; and declaring an
2 emergency”.

3 Delete lines 4 through 8 and insert:

4 **“SECTION 1. In addition to and not in lieu of any other appropri-
5 ation, there are appropriated to the Housing and Community Services
6 Department, for deposit into the Housing and Community Services
7 Department Revolving Account under ORS 456.574, for the biennium
8 beginning July 1, 2021, out of the General Fund, the following
9 amounts:**

10 **“(1) \$27,000,000 for grants under section 9, chapter ___, Oregon Laws
11 2021 (Enrolled House Bill 2006); and**

12 **“(2) \$2,000,000 for technical assistance under section 9, chapter ___,
13 Oregon Laws 2021 (Enrolled House Bill 2006).**

14 **“SECTION 2. In addition to and not in lieu of any other appropri-
15 ation, there are appropriated to the Oregon Department of Adminis-
16 trative Services, for the biennium beginning July 1, 2021, out of the
17 General Fund, the following amounts:**

18 **“(1) \$1,500,000 to the City of McMinnville for a navigation center,
19 pursuant to section 10, chapter ___, Oregon Laws 2021 (Enrolled House
20 Bill 2006);**

21 **“(2) \$1,500,000 to the City of Roseburg for a navigational center**

1 pursuant to section 10, chapter ___, Oregon Laws 2021 (Enrolled House
2 Bill 2006);

3 “(3) \$2,500,000 to the City of Bend for a navigation center pursuant
4 to section 10, chapter ___, Oregon Laws 2021 (Enrolled House Bill 2006);

5 “(4) \$2,500,000 to the City of Medford for a navigation center pur-
6 suant to section 10, chapter ___, Oregon Laws 2021 (Enrolled House Bill
7 2006);

8 “(5) \$5,000,000 to the City of Salem for a navigation center pursuant
9 to section 10, chapter ___, Oregon Laws 2021 (Enrolled House Bill 2006);
10 and

11 “(6) \$5,000,000 to Lane County for a navigation center within the
12 City of Eugene pursuant to section 10, chapter ___, Oregon Laws 2021
13 (Enrolled House Bill 2006).

14 “SECTION 3. Sections 1 and 2 of this 2021 Act become operative on
15 the date that chapter ___, Oregon Laws 2021 (Enrolled House Bill 2006),
16 becomes law.

17 “SECTION 4. This 2021 Act being necessary for the immediate
18 preservation of the public peace, health and safety, an emergency is
19 declared to exist, and this 2021 Act takes effect on its passage.”.
