**PROPOSED AMENDMENTS TO

13 **“ADOPTIONS**

14 **“(Jurisdiction; Domicile; Hearing)**

15
16 **“SECTION 1.** Section 12, chapter 14, Oregon Laws 2020 (first special
17 session), is amended to read:

18 **“Sec. 12.** (1) Except as otherwise provided in this section, the [*juvenile*]
19 court’s jurisdiction under ORS **109.309 (4) or** 419B.100 (1) in a case involving
20 an Indian child is concurrent with the Indian child’s tribe.

21 **“(2)** If a tribe is not subject to Public Law 83-280, the tribe has exclusive

1 jurisdiction in a case described in ORS **109.309 (4) or** 419B.100 (1) involving
2 an Indian child if:

3 “(a) The Indian child is a ward of a tribal court of the [*Indian child’s*]
4 tribe; or

5 “(b) The Indian child resides or is domiciled within the reservation of the
6 tribe.

7 “(3)(a) An Indian tribe subject to Public Law 83-280 may limit the [*juve-*
8 *nile*] court’s exercise of jurisdiction under ORS **109.309 (4) or** 419B.100 (1)
9 over an Indian child by entering into a tribal-state agreement described in
10 section 10, **chapter 14, Oregon Laws 2020 (first special session)** [*of this*
11 *2020 special session Act*].

12 “(b) The [*juvenile*] court shall decline to exercise its jurisdiction under
13 ORS **109.309 (4) or** 419B.100 (1) over an Indian child who is a ward of a tribal
14 court [*of the Indian child’s tribe,*] or who resides or is domiciled within the
15 reservation of [*the*] a tribe[,] if:

16 “(A) The tribe has entered into a tribal-state agreement in which the state
17 has agreed to decline jurisdiction; and

18 “(B) The tribal-state agreement provides that the tribe has default juris-
19 diction over those cases.

20 “(c)(A) If the [*juvenile*] court declines to exercise its jurisdiction under
21 paragraph (b) of this subsection, the court shall coordinate with the tribal
22 court to facilitate the tribal court’s assumption of jurisdiction.

23 “(B) The [*juvenile*] court shall:

24 “(i) Allow the Indian child’s parent, Indian custodian or tribe to partic-
25 ipate in any communications under this subsection with a tribal court or, if
26 the person is unable to participate in a communication, provide the person
27 with an opportunity to represent facts and legal arguments supporting the
28 person’s position before the [*juvenile*] court makes a decision regarding ju-
29 risdiction;

30 “(ii) Create records of any communications under this subsection;

1 “(iii) Notify the Indian child’s parent, Indian custodian or tribe in ad-
2 vance of each communication; and

3 “(iv) Provide the Indian child’s parent, Indian custodian or tribe with
4 access to the record of the communication.

5 “(C) Communications between the [*juvenile*] court and a tribal court re-
6 garding calendars, court records and similar matters may occur without in-
7 forming the parties or creating a record of the communications.

8 “(D) As used in this paragraph, ‘record’ means information that is in-
9 scribed on a tangible medium or that is stored in an electronic or other
10 medium and is retrievable in perceivable form.

11 “(4) Notwithstanding subsections (2) and (3) of this section, the juvenile
12 court has temporary exclusive jurisdiction over an Indian child who is taken
13 into protective custody under ORS 419B.150 or 419B.152.

14 “**SECTION 2.** ORS 109.309 is amended to read:

15 “109.309. (1) Any person may petition the circuit court for leave to adopt
16 another person and, if desired, for a change of the other person’s name. Ex-
17 cept as provided in ORS 419B.529, a separate petition must be filed for each
18 person for whom leave to adopt is sought.

19 “(2) One petitioner, the child, one parent or the person, who is not an
20 adoption agency, consenting to the adoption as required under ORS 109.321
21 (1) must be a resident of this state. As used in this subsection, ‘resident’
22 means a person who has resided in this state continuously for a period of
23 six months prior to the date of the petition.

24 “(3) Except as provided in subsection (4) of this section, when the petition
25 is for the adoption of a minor child, the adoption is governed by the Uniform
26 Child Custody Jurisdiction and Enforcement Act, ORS 109.701 to 109.834.

27 “(4)(a) Notwithstanding ORS 109.741 and 109.744 **and except as provided**
28 **in section 12, chapter 14, Oregon Laws 2020 (first special session)**, a
29 court of this state has jurisdiction over the adoption of a minor child if,
30 immediately prior to the filing of a petition for adoption:

1 “(A) The minor child resided in this state for at least six consecutive
2 months including periods of temporary absence;

3 “(B) One parent or another person, who is not an adoption agency, con-
4 senting to the adoption as required under ORS 109.321 (1) **or section 19 of**
5 **this 2021 Act** resided in this state for at least six consecutive months in-
6 cluding periods of temporary absence;

7 “(C) The prospective adoptive parent resided in this state for at least six
8 consecutive months including periods of temporary absence and substantial
9 evidence is available in this state concerning the present or future care of
10 the minor child;

11 “(D) It appears that no court of another state would have jurisdiction
12 under circumstances substantially in accordance with subparagraphs (A) to
13 (C) of this paragraph; or

14 “(E) A court of another state has declined to exercise jurisdiction on the
15 grounds that this state is a more appropriate forum to hear a petition for
16 adoption of the minor child and it is in the best interests of the minor child
17 that a court of this state assume jurisdiction.

18 “(b) As used in paragraph (a) of this subsection, ‘periods of temporary
19 absence’ means periods of absence of not more than a total of 30 days in the
20 prior six consecutive months.

21 “(5) In a petition to adopt a minor child, venue lies in the Oregon county
22 with which the child has the most significant connection or in the Oregon
23 county in which the licensed adoption agency is located.

24 “(6) A petition for adoption of a minor child must comply with the re-
25 quirements, and be served in the manner, described in ORS 109.315.

26 “(7)(a) In a proceeding for the adoption of a minor child, a current home
27 study must be approved by either the Department of Human Services or an
28 Oregon licensed adoption agency for the purpose of demonstrating that the
29 petitioner meets the minimum standards for adoptive homes as set forth in
30 the department’s administrative rules.

1 “(b) **Except when the court finds that there is reason to know that**
2 **the child is an Indian child,** the department, upon request by the
3 petitioner, may waive the home study requirement in an adoption proceeding
4 in which one of the child’s biological parents or adoptive parents retains
5 parental rights, or when a relative who qualifies under the department’s ad-
6 ministrative rules for a waiver of the home study requirement is the pro-
7 spective adoptive parent.

8 “(c) The department shall, subject to ORS 109.306, adopt rules to imple-
9 ment the provisions of this subsection.

10 “(8)(a)(A) Within 90 days after service upon the Director of Human Ser-
11 vices as required under ORS 109.315, the Department of Human Services
12 shall investigate and file for the consideration of the judge before whom the
13 petition for adoption is pending a placement report containing information
14 regarding the status of the child and evidence concerning the suitability of
15 the proposed adoption. The department may designate an Oregon licensed
16 adoption agency to investigate and report to the court. If the department
17 designates an Oregon licensed adoption agency to investigate and report to
18 the court, the department shall make the designation and provide all neces-
19 sary information and materials to the Oregon licensed adoption agency no
20 later than 30 days after the service on the director and upon receipt of all
21 required documentation and fees.

22 “(B) **Except when the court finds that there is reason to know that**
23 **the child is an Indian child,** the department:

24 “(i) May waive the placement report requirement under this subsection;
25 [*but*] **and**

26 “(ii) Shall waive the placement report requirement in an adoption pro-
27 ceeding in which one of the child’s biological parents or adoptive parents
28 retains parental rights.

29 “(b) Upon receipt of a written request by the petitioner or the petitioner’s
30 attorney, the department shall furnish to the petitioner or the petitioner’s

1 attorney copies of any information that the department has filed with the
2 court.

3 “(c) Information gathered by the department or by an Oregon licensed
4 adoption agency during the preparation of the placement report may include
5 information concerning the child’s social, medical and genetic history and
6 the birth parent’s history as may be required by ORS 109.321 or 109.342 **or**
7 **section 19 of this 2021 Act.**

8 “(d) The court shall file and retain the placement report filed under this
9 subsection in the same location in the records, papers and files in the court’s
10 record of the adoption case as the petition and exhibits filed under ORS
11 109.315 are located. The placement report must be segregated from the
12 Adoption Summary and Segregated Information Statement and the exhibits
13 submitted under ORS 109.317.

14 “(e) The department shall, subject to ORS 109.306, adopt rules to imple-
15 ment the provisions of this subsection.

16 “(9) The department may charge the petitioner a fee for investigating a
17 proposed nonagency adoption and preparing the home study required under
18 subsection (7) of this section and the placement report required under sub-
19 section (8) of this section. The petitioner shall report the fee amount to the
20 court. The court granting the adoption shall make a finding as to whether
21 the fee is necessary and reasonable. Any fee charged may not exceed rea-
22 sonable costs for investigation, home study and placement report prepara-
23 tion. The department shall prescribe by rule the procedure for computing the
24 investigation, home study and placement report preparation fee. The rules
25 shall provide a waiver of either part or all of the fee based upon the
26 petitioner’s ability to pay.

27 “(10) The court may not rule upon a petition for the adoption of a minor
28 child until at least 90 days after the date that the petition and documents
29 required to be served on the Director of Human Services under ORS 109.315
30 and 109.317 have been served upon the director. The department may waive

1 the 90-day waiting period.

2 “(11) The amounts of any fees collected under subsection (9) of this sec-
3 tion are continuously appropriated to the department for use in preparing
4 home studies and placement reports required under this section.

5 “(12)(a) Except as provided in paragraph (b) of this subsection, a court
6 may not grant a judgment for the adoption of a minor child unless the
7 petitioner has filed with the court:

8 “(A) A petition, including exhibits attached to the petition, meeting the
9 requirements of ORS 109.315;

10 “(B) Written evidence that a home study has been completed and ap-
11 proved, unless waived, under subsection (7) of this section;

12 “(C) A placement report under subsection (8) of this section unless
13 waived; and

14 “(D) The Adoption Summary and Segregated Information Statement under
15 ORS 109.317, including exhibits attached to the statement.

16 “(b) **Except when the court finds that there is reason to know that**
17 **child is an Indian child**, a person is not required to file a home study or
18 a placement report with the court when the department has granted the
19 person a waiver under department rules.

20 “[*(13) The adoption shall comply with the Indian Child Welfare Act (25*
21 *U.S.C. 1901 et seq.), if applicable.*]

22 “(13) **When the court conducts a hearing under ORS 109.304 to**
23 **109.410 regarding the adoption of a minor child, the court shall make**
24 **the inquiries described in section 15 (4)(b), chapter 14, Oregon Laws**
25 **2020 (first special session), and make a finding and issue an order**
26 **subject to the procedures under section 15 (4), chapter 14, Oregon Laws**
27 **2020 (first special session), regarding whether there is reason to know**
28 **that the child is an Indian child.**

29 “**SECTION 3.** Section 9, chapter 14, Oregon Laws 2020 (first special ses-
30 sion), is amended to read:

1 “**Sec. 9.** In any **child custody** proceeding [*under*] **based on allegations**
2 **that an Indian child is within the jurisdiction of the court under ORS**
3 **109.304 to 109.410 or** ORS chapter 419B [*involving an Indian child*], the [*ju-*
4 *venile*] court must determine the residence and domicile of the Indian child
5 and whether the Indian child is a ward of tribal court. The [*juvenile*] court
6 shall communicate with any tribal courts to the extent necessary to make a
7 determination under this section.

8 “**SECTION 4.** Section 13, chapter 14, Oregon Laws 2020 (first special
9 session), is amended to read:

10 “**Sec. 13.** (1) Except as provided in subsection (5) of this section, the [*ju-*
11 *venile*] court shall transfer a **child custody** proceeding under **ORS 109.304**
12 **to 109.410 or** ORS chapter 419B involving an Indian child if, at any time
13 during the proceeding, the Indian child’s parent, Indian custodian or tribe
14 petitions the court to transfer the proceeding to the tribal court.

15 “(2) Upon receipt of a transfer motion, the [*juvenile*] court shall contact
16 the Indian child’s tribe and request a timely response regarding whether the
17 tribe intends to decline the transfer.

18 “[(3) A party may object to the transfer motion on the basis of one of the
19 following:]

20 “**(3) Transfer of the proceeding is inappropriate if:**

21 “(a) [*That*] The Indian child’s tribe has declined the transfer;

22 “(b) [*That*] One or both of the Indian child’s parents object to the trans-
23 fer; or

24 “(c) [*That*] Good cause exists to deny the transfer.

25 “(4)(a) If a party objects to the transfer motion for good cause, the court
26 shall fix the time for hearing on objections to the motion.

27 “(b) At the hearing, the objecting party has the burden of proof of estab-
28 lishing by clear and convincing evidence that good cause exists to deny the
29 transfer.

30 “(c) If the Indian child’s tribe contests the assertion that good cause ex-

1 ists to deny the transfer, the court shall give the tribe’s argument substantial
2 weight.

3 “(d) When making a determination whether good cause exists to deny the
4 transfer motion, the [*juvenile*] court may not consider:

5 “(A) Whether the proceeding is at an advanced stage;

6 “(B) Whether there has been a prior proceeding involving the Indian child
7 in which a transfer motion was not filed;

8 “(C) Whether the transfer could affect the placement of the Indian child;

9 “(D) The Indian child’s cultural connections with the tribe or the tribe’s
10 reservation;

11 “(E) The socioeconomic conditions of the Indian child’s tribe or any neg-
12 ative perception of tribal or United States Bureau of Indian Affairs’ social
13 services or judicial systems; or

14 “(F) Whether the transfer serves the best interests of the Indian child.

15 “(5)(a) The court shall deny the transfer motion if:

16 “(A) The tribe declines the transfer orally on the record or in writing;

17 “(B) The Indian child’s parent objects to the transfer; or

18 “(C) The court finds by clear and convincing evidence, after hearing, that
19 good cause exists to deny the transfer.

20 “(b) Notwithstanding paragraph (a)(B) of this subsection, the objection
21 of the Indian child’s parent does not preclude the transfer if:

22 “(A) The objecting parent dies or the objecting parent’s parental rights
23 are terminated and have not been reinstated under ORS 419B.532; and

24 “(B) The Indian child’s remaining parent, Indian custodian or tribe files
25 a new transfer motion subsequent to the death of the objecting parent or the
26 termination of the parental rights of the objecting parent.

27 “(6) If the [*juvenile*] court denies a transfer under this section, the court
28 shall document the basis for the denial in a written order.

29 **“SECTION 5.** Section 14, chapter 14, Oregon Laws 2020 (first special
30 session), is amended to read:

1 “**Sec. 14.** Upon granting a transfer motion under section 13, **chapter 14,**
2 **Oregon Laws 2020 (first special session)** [*of this 2020 special session Act*],
3 the [*juvenile*] court shall expeditiously:

4 “(1) Notify the tribal court of the pending dismissal of the **child custody**
5 proceeding;

6 “(2) Transfer all information regarding the proceeding, including [*but not*
7 *limited to*] pleadings and court records, to the tribal court;

8 “(3) **If the Indian child is within the jurisdiction of the juvenile**
9 **court under ORS 419B.100,** direct the Department of Human Services to:

10 “(a) Coordinate with the tribal court and the Indian child’s tribe to en-
11 sure that the transfer of the proceeding and the transfer of custody of the
12 Indian child is accomplished with minimal disruption of services to the In-
13 dian child and the Indian child’s family; and

14 “(b) Provide the Indian child’s tribe with documentation related to the
15 Indian child’s eligibility for state and federal assistance and information re-
16 lated to the Indian child’s social history, treatment diagnosis and services
17 and other relevant case and service related data; and

18 “(4) Dismiss the proceeding upon confirmation from the tribal court that
19 the tribal court received the transferred information.

20
21 **“(Inquiry; Verification; ICWA Compliance Reports)”**
22

23 “**SECTION 6. Section 7 of this 2021 Act is added to and made a part**
24 **of ORS 109.304 to 109.410.**

25 “**SECTION 7. (1) In a proceeding for the adoption or readoption of**
26 **a minor child, within 30 days after service of a petition or amended**
27 **petition upon the Director of Human Services as required under ORS**
28 **109.315 or 109.385, the Department of Human Services shall file with**
29 **the court an ICWA compliance report. The ICWA compliance report**
30 **must reflect the department’s review of the petition or amended peti-**

1 tion and must advise the court on whether the documentation sub-
2 mitted by the petitioner is sufficient and complete for the court to
3 make the findings and determinations required under subsection (2)
4 of this section. Nothing in this subsection or subsection (3) of this
5 section requires the department to make a determination of law re-
6 garding the documentation provided by the petitioner.

7 “(2)(a) Upon receiving an ICWA compliance report, the court shall
8 review the documentation provided by the petitioner and:

9 “(A) Determine whether the petitioner has satisfied the inquiry re-
10 quirements under section 15 (2), chapter 14, Oregon Laws 2020 (first
11 special session);

12 “(B) Make a finding, subject to the procedures under section 15 (4),
13 chapter 14, Oregon Laws 2020 (first special session), regarding whether
14 there is reason to know that the child is an Indian child; and

15 “(C) If there is reason to know that the child is an Indian child:

16 “(i) Make a determination regarding whether the petitioner satis-
17 fied the notice requirements under section 16 (2), chapter 14, Oregon
18 Laws 2020 (first special session); and

19 “(ii) Make a finding regarding whether the proposed adoptive
20 placement complies with the preferences under section 23 (2), chapter
21 14, Oregon Laws 2020 (first special session).

22 “(b)(A) If the court finds that there is reason to know that the child
23 is an Indian child, the order must include a finding regarding whether
24 the proposed adoptive placement complies with the placement prefer-
25 ences under section 23 (2), chapter 14, Oregon Laws 2020 (first special
26 session). If the court finds that the proposed adoptive placement does
27 not comply with the preferences or that the documentation provided
28 by the petitioner is insufficient for the court to make a finding, the
29 court shall order the petitioner to file a motion under section 23 (3),
30 chapter 14, Oregon Laws 2020 (first special session), for authority to

1 make the placement contrary to the placement preferences under
2 section 23 (2), chapter 14, Oregon Laws 2020 (first special session).

3 “(B) If the court determines that the petitioner failed to satisfy the
4 inquiry and, if applicable, notice requirements under sections 15 (2)
5 and 16 (2), chapter 14, Oregon Laws 2020 (first special session), or if the
6 documentation supplied by the petitioner is insufficient for the court
7 to make those determinations, the court shall order the petitioner to
8 cure the inquiry or notice deficiency and file an amended petition.

9 “(c) The court shall order the petitioner to appear and show cause
10 why the court should not dismiss the petition if the court orders the
11 petitioner to file an amended petition or a motion under paragraph (b)
12 of this subsection and the petitioner fails to file the amended petition
13 or motion within a reasonable amount of time.

14 “(3)(a) The department shall, by rule, provide a nonexhaustive de-
15 scription of the documentation that petitioners or moving parties in
16 proceedings under ORS 109.304 to 109.410 may submit to the court to
17 document compliance with the inquiry and notice requirements under
18 sections 15 (2) and (4) and 16 (2) and (3), chapter 14, Oregon Laws 2020
19 (first special session), and the placement preferences under section 23,
20 chapter 14, Oregon Laws 2020 (first special session), including:

21 “(A) Descriptions of the consultations the petitioner or moving
22 party made with the individuals described in section 15 (2), chapter 14,
23 Oregon Laws 2020 (first special session), and the responses the
24 petitioner or moving party obtained;

25 “(B) Descriptions of any oral responses and copies of any written
26 responses the petitioner or moving party obtained from the individuals
27 described in section 15 (2) or 16 (3), chapter 14, Oregon Laws 2020 (first
28 special session);

29 “(C) Copies of any identification cards or other records indicating
30 the membership of the child or the child’s parent in an Indian tribe;

1 **“(D) Copies of any tribal court records regarding the Indian child;**

2 **“(E) Any reports, declarations or testimony on the record docu-**
3 **menting the due diligence of the petitioner or moving party to identify**
4 **and work with all of the tribes of which the petitioner or moving party**
5 **has reason to know that the child may be a member or in which the**
6 **child may be eligible for membership; and**

7 **“(F) The declaration of compliance regarding the section 16 (2),**
8 **section 14, Oregon Laws 2020 (first special session), notices the**
9 **petitioner sent, as described in ORS 109.315 (5)(d) and 109.385 (7)(b).**

10 **“(b) The department shall adopt any other rules for the preparation**
11 **of ICWA compliance reports that are necessary for the department to**
12 **carry out the department’s duties under ORS 109.304 to 109.410.**

13 **“(c) The State Court Administrator may prepare and make available**
14 **to the public forms and information to assist petitioners to comply**
15 **with the requirements under this section, ORS 109.315 and 109.385 and**
16 **sections 15 (2), 16 (2) and (3) and 23 (2) and (3), chapter 14, Oregon Laws**
17 **2020 (first special session), and any related rules, including:**

18 **“(A) Forms of petitions required under ORS 109.315 and 109.385,**
19 **motions to request a deviation from the placement preferences under**
20 **section 23 (3), chapter, chapter 14, Oregon Laws 2020 (first special ses-**
21 **sion), and notices required under section 16 (2), chapter 14, Oregon**
22 **Laws 2020 (first special session); and**

23 **“(B) Worksheets and checklists to assist petitioners with the in-**
24 **quiry required under section 15 (2), chapter 14, Oregon Laws 2020 (first**
25 **special session), the notices required under section 16 (2), chapter 14,**
26 **Oregon Laws 2020 (first special session), and assessing whether pro-**
27 **posed adoptive placements satisfy the preferences under section 23 (2),**
28 **chapter 14, Oregon Laws 2020 (first special session).**

29 **“(d) The Judicial Department may design and offer trainings to**
30 **courts having jurisdiction over adoption matters regarding the appli-**

1 **cation of sections 1 to 23, chapter 14, Oregon Laws 2020 (first special**
2 **session), to adoptions of minor children, including but not limited to**
3 **identifying when there is reason to know that the child is an Indian**
4 **child and making findings of fact and determinations of law regarding**
5 **the sufficiency of inquiry and notice and the appropriateness of**
6 **adoptive placements.**

7 **“SECTION 8.** ORS 109.315 is amended to read:

8 “109.315. (1) A petition for adoption of a minor child must be signed by
9 the petitioner and, unless stated in the petition why the information or
10 statement is omitted, must contain the following:

11 “(a) The full name of the petitioner;

12 “(b) The state and length of residency in the state of the petitioner and
13 information sufficient to establish that the residency requirement of ORS
14 109.309 (2) has been met;

15 “(c) The current marital or domestic partnership status of the petitioner;

16 “(d) An explanatory statement as to why the petitioner is of sufficient
17 ability to bring up the minor child and furnish suitable nurture and educa-
18 tion sufficient for judgment to be entered under ORS 109.350;

19 “(e) Information sufficient for the court to establish that the petitioner
20 has complied with the jurisdictional and venue requirements of ORS 109.309
21 (4) and (5);

22 “(f) The full name, gender and date and place of birth of the minor child;

23 “(g) The marital or domestic partnership status of the biological mother
24 at the time of conception, at the date of birth and during the 300 days prior
25 to the date of birth of the minor child;

26 “[*h*] *A statement that the minor child is not an Indian child as defined*
27 *in the Indian Child Welfare Act (25 U.S.C. 1901 et seq.) or, if the Indian Child*
28 *Welfare Act applies:]*

29 “[*A*] *A statement of the efforts to notify the appropriate Indian tribe or*
30 *tribes of the adoption; and]*

1 “[B) A statement of the efforts to comply with the placement preferences

28 **or in the home of a guardian, when parental rights to the Indian child**
29 **have not been terminated but when the Indian child may not be re-**
30 **stored to the Indian child's home on demand;**

1 **“(B) The termination of parental rights;**
2 **“(C) The placement of an Indian child following the termination of**
3 **parental rights but prior to the child’s adoption;**
4 **“(D) The guardianship of an Indian child;**
5 **“(E) The permanent placement of an Indian child for adoption; or**
6 **“(F) The placement of an Indian child in an out-of-home placement**
7 **as the result of the Indian child’s status offense.**
8 **“(c) ‘Child custody proceeding’ does not include:**
9 **“(A) A proceeding for the custody or support of, or parenting time**
10 **with, a child under ORS 109.100, 109.103 or 109.119;**
11 **“(B) Except as provided in paragraph (b)(F) of this subsection, a**
12 **proceeding under ORS chapter 419C; or**
13 **“(C) An emergency proceeding.**
14 **“[(1)] (2) ‘Emergency proceeding’ means any court action that involves the**
15 **emergency removal or emergency placement of an Indian child, including**
16 **removal under ORS 419B.150, with or without a protective custody order, or**
17 **a shelter care proceeding under ORS 419B.185.**
18 **“[(2)(a)] (3)(a) ‘Extended family member’ has the meaning given that term**
19 **by the law or custom of an Indian child’s tribe.**
20 **“(b) If the meaning of ‘extended family member’ cannot be determined**
21 **under paragraph (a) of this subsection, ‘extended family member’ means a**
22 **person who has attained 18 years of age and who is the Indian child’s**
23 **grandparent, aunt, uncle, brother, sister, sister-in-law, brother-in-law, niece,**
24 **nephew, first cousin, second cousin, stepparent or, as determined by the In-**
25 **dian child’s tribe, clan or band member.**
26 **“[(3)] (4) ‘Indian’ means a person who is a member of an Indian tribe or**
27 **who is an Alaska Native and a member of a regional corporation as defined**
28 **in section 7 of the Alaska Native Claims Settlement Act (43 U.S.C. 1606).**
29 **“[(4)] (5) ‘Indian child’ means any unmarried person who has not attained**
30 **18 years of age and:**

1 “(a) Is a member or citizen of an Indian tribe; or

2 “(b) Is eligible for membership or citizenship in an Indian tribe and is the
3 biological child of a member of an Indian tribe.

4 “[5] (6) ‘Indian custodian’ means an Indian, other than the Indian child’s
5 parent, who has custody, as described in section 3 (1), **chapter 14, Oregon**
6 **Laws 2020 (first special session)** [*of this 2020 special session Act*], of the
7 Indian child, or to whom temporary physical care, custody and control has
8 been transferred by the Indian child’s parent.

9 “[6] (7) ‘Indian tribe’ or ‘tribe’ means any Indian tribe, band, nation or
10 other organized group or community of Indians federally recognized as eli-
11 gible for the services provided to Indians by the United States Secretary of
12 the Interior because of their status as Indians, including any Alaska Native
13 village as defined in 43 U.S.C. 1602(c).

14 “[7] (8) ‘Juvenile court’ has the meaning given that term in ORS
15 419A.004.

16 “[8] (9) ‘Member’ or ‘membership’ means a determination by an Indian
17 tribe that a person is a member or citizen in that Indian tribe.

18 “[9] (10) ‘Parent’ means:

19 “(a) A biological parent of an Indian child;

20 “(b) An Indian who has lawfully adopted an Indian child, including
21 adoptions made under tribal law or custom; or

22 “(c) A father whose parentage has been acknowledged or established un-
23 der **ORS 109.065** or section 4, **chapter 14, Oregon Laws 2020 (first special**
24 **session)** [*of this 2020 special session Act*].

25 “[10] (11) ‘Party’ or ‘parties’ means parties to a proceeding, as described
26 in ORS 419B.875.

27 “[11] (12) ‘Reservation’ means Indian country as defined in 18 U.S.C.
28 1151 and any lands not covered under that section, title to which is held by
29 the United States in trust for the benefit of an Indian tribe or individual or
30 held by an Indian tribe or individual subject to a restriction by the United

1 States against alienation.

2 “[~~(12)~~] (13) ‘Tribal court’ means a court with jurisdiction over child cus-
3 tody proceedings and that is either a Court of Indian Offenses, a court es-
4 tablished and operated under the code or custom of an Indian tribe or any
5 other administrative body of a tribe that is vested with authority over child
6 custody proceedings.

7 **“SECTION 12.** Section 8, chapter 14, Oregon Laws 2020 (first special
8 session), is amended to read:

9 **“Sec. 8. (1)** In a **child custody proceeding in which an Indian child is**
10 **alleged to be within the jurisdiction of the court** under ORS chapter 109,
11 **418, 419A or 419B** [*when there is reason to know that the child is an Indian*
12 *child*], the Indian child’s tribe is:

13 “(a) If the Indian child is a member of or is eligible for membership in
14 only one tribe, the tribe of which the Indian child is a member or eligible

- 22 “(B) The parents or guardian of the child or ward;
- 23 “(C) A putative father of the child or ward who has demonstrated a direct
- 24 and significant commitment to the child or ward by assuming, or attempting
- 25 to assume, responsibilities normally associated with parenthood, including
- 26 but not limited to:
- 27 “(i) Residing with the child or ward;

23 “(a) Determine whether [*there is*] **the person has** reason to know that
24 the child is an Indian child; and [*to*]

25 “(b) Contact by telephone, electronic mail, facsimile or other means of
26 immediate communication any tribe of which the child is or may be a mem-
27 ber to determine the child’s affiliation.

28 “(2) Except as provided in subsection (1) of this section **or if the person**

4 or [*of*] **in** which the Indian child may be eligible for membership;

5 “(E) If notice is required to be sent to the United States Bureau of Indian

7 mation regarding the child’s direct lineal ancestors, an ancestral chart for
8 each biological parent, and the child’s tribal affiliations and blood quantum;

9 “(F) A copy of the petition **or motion** initiating the proceeding and, if
10 a hearing has been scheduled, information on the date, time and location of
11 the hearing;

12 “(G) The name of the petitioner and the name and address of the
13 petitioner’s attorney;

14 “**(H) In a proceeding under ORS chapter 419B:**

15 “[*H*] (i) A statement that the child’s parent or Indian custodian[, *as a*
16 *party to the proceeding under ORS 419B.875,*] has the right to participate in
17 the proceeding **as a party to the proceeding under ORS 419B.875;**

18 “[*I*] (ii) A statement that the child’s tribe[, *as a party to the proceeding*
19 *under ORS 419B.875,*] has the right to participate in the proceeding **as a**
20 **party or in an advisory capacity under ORS 419B.875;**

21 “[*J*] (iii) A statement that if the court determines that the child’s parent
22 or Indian custodian is unable to afford counsel, the parent or Indian custo-
23 dian has the right to court-appointed counsel; **and**

24 “[*K*] (iv) A statement that the child’s parent, Indian custodian or tribe
25 has the right, upon request, to up to 20 additional days to prepare for the
26 proceeding;

27 “**(I) In a proceeding under ORS 109.304 to 109.410, a statement that**
28 **the child’s tribe may intervene in the proceeding;**

29 “[*L*] (J) A statement that the child’s parent, Indian custodian or tribe
30 has the right to petition the court to transfer the **child custody** proceeding

1 to the tribal court;

2 “[*M*] (**K**) A statement describing the potential legal consequences of the
3 proceeding on the future parental and custodial rights of the parent or In-
4 dian custodian;

5 “[*N*] (**L**) The mailing addresses and telephone numbers of the court and
6 contact information for all parties to the proceeding and individuals notified
7 under this section; and

8 “[*O*] (**M**) A statement that the information contained in the notice is
9 confidential and that the notice should not be shared with any person not
10 needing the information to exercise rights under sections 1 to 23, **chapter**
11 **14, Oregon Laws 2020 (first special session)** [*of this 2020 special session*
12 *Act*].

13 “(4) If there is a reason to know that the Indian child’s parent or Indian
14 custodian has limited English proficiency and may not understand the con-

5 **“(i) The petitioner complied with the notice requirements as re-**
6 **quired under section 16 (2), chapter 14, Oregon Laws 2020 (first special**
7 **session);**

8 **“(ii) Despite petitioner's active efforts, evidence, including the tes-**
9 **timony of one or more qualified expert witnesses under section 17,**
10 **chapter 14, Oregon Laws 2020 (first special session), establishes beyond**
11 **a reasonable doubt that the continued custody of the Indian child by**
12 **the spouse is likely to result in serious emotional or physical damage**
13 **to the Indian child and that the petitioner's active efforts under sec-**
14 **tion 18, chapter 14, Oregon Laws 2020 (first special session), to reunite**
15 **the Indian family did not eliminate the necessity for termination of**
16 **the spouse's parental rights based on serious emotional or physical**
17 **damage to the Indian child; and**

18 **“(iii) That the adoptive placement complies with the placement**
19 **preferences under section 23 (2), chapter 14, Oregon Laws 2020 (first**
20 **special session), or, if not, a finding upon the petitioner's motion un-**

22 **that good cause exists for placement contrary to the placement pref-**
23 **erences in section 23 (2), chapter 14, Oregon Laws 2020 (first special**
24 **session).**

25 **“(c) The evidence under paragraph (b)(C)(ii) of this subsection must**
26 **show a causal relationship between the particular conditions in the**
27 **Indian child's home and the likelihood that the spouse's continued**
28 **custody will result in serious emotional or physical damage to the In-**
29 **dian child who is the subject of the adoption proceeding. Evidence that**
30 **shows the existence of community or family poverty, isolation, single**

1 **parenthood, custodian age, crowded or inadequate housing, substance**
2 **abuse or nonconforming social behavior does not, by itself, establish**
3 **a causal relationship as required by this paragraph.**

4 “[10] (13) There shall be sufficient proof to enable the court to grant the
5 relief sought without notice to the spouse [*provided that*] **if:**

6 “(a) The affidavit of the mother of the child, of the spouse or of another
7 person with knowledge of the facts filed in the proceeding states or the court
8 finds from other competent evidence:

9 “[a] (A) That the mother of the child was not cohabiting with the
10 mother’s spouse at the time of conception of the child and that the spouse
11 is not the parent of the child;

12 “[b] (B) That the spouse has not been judicially determined to be the
13 parent of the child;

14 “[c] (C) That the child has not resided with the spouse; and

15 “[d] (D) That the spouse has not contributed or tried to contribute to
16 the support of the child[.]; **and**

17 “(b) **The court finds by evidence beyond a reasonable doubt that the**
18 **child is not an Indian child.**

19 “[11] (14) Notwithstanding ORS 109.070 (1)(a), service of a summons and
20 a motion and order to show cause on the spouse under subsection (3) of this
21 section is not required and the spouse’s consent, authorization or waiver is
22 not required in adoption proceedings concerning the child unless **the child**
23 **is an Indian child or** the spouse has met the requirements of subsection
24 [(3)(a), (b) or (c)] (3)(b)(A), (B) or (C) of this section.

25 “[12] (15) A spouse who was not cohabiting with the mother at the time
26 of the child’s conception has the primary responsibility to protect the
27 spouse’s rights.

28 “[13] (16) Nothing in this section shall be used to set aside an act of a
29 permanent nature, including but not limited to adoption, unless the parent
30 establishes, within one year **or, if the child is an Indian child, four years**

1 after the entry of the order or general judgment, as defined in ORS 18.005,

4 **“(17) If the child is an Indian child, the child’s tribe or Indian
5 custodian may intervene at any time as a matter of right.**

6 **“SECTION 27.** ORS 109.308 is amended to read:

7 “109.308. **(1)** In an adoption proceeding that is contested or in which a
8 summons is required to be served, the court may preserve the confidentiality
9 of the names and addresses of the petitioners for the adoption if the court
10 finds that to do so is in the best interests of the child.

11 **“(2) The preservation of confidentiality under this section does not
12 relieve the court or any petitioners in an adoption proceeding from the
13 duty to comply with the placement preferences under section 23 (2),
14 chapter 14, Oregon Laws 2020 (first special session), if the child is an
15 Indian child.**

16 **“SECTION 28.** Section 21, chapter 14, Oregon Laws 2020 (first special
17 session), is amended to read:

18 **“Sec. 21. (1)** In any **child custody** proceeding under **ORS 109.326 or
19 109.330 or** ORS chapter 419B when there is reason to know that the child is
20 an Indian child, each party has the right to timely examine all reports or
21 other documents held by the Department of Human Services that are not
22 otherwise subject to a discovery exception under ORS 419B.881 or precluded
23 under state or federal law.

24 **“(2) The preservation of confidentiality under this section does not
25 relieve the court or any petitioners in an adoption proceeding from the
26 duty to comply with the placement preferences under section 23 (2),
27 chapter 14, Oregon Laws 2020 (first special session), if the child is an
28 Indian child.**

“(Agency Consent)

1 **“SECTION 29.** ORS 418.270 is amended to read:

2 “418.270. (1) If licensed for such purposes by the Department of Human
3 Services, a child-caring agency may receive children from the children’s
4 parents or legal guardians for special, temporary or continued care. **Upon**
5 **receiving a child under this section, the agency shall make inquiries,**
6 **as described in section 15 (2), chapter 14, Oregon Laws 2020 (first spe-**
7 **cial session), to determine whether there is reason to know that the**
8 **child is an Indian child.** The parents or guardians may sign releases or
9 surrenders giving to the agency guardianship and control of the children
10 during the period of care, which may be extended until the children arrive
11 at legal age. Releases do not surrender the rights of parents or guardians in
12 respect to the adoption of children and do not entitle the agency to give
13 consent to the adoption of the children unless the release or surrender ex-
14 pressly recites that the release or surrender is given for the purpose of
15 adoption. Child-caring agencies are authorized to place children for adoption
16 or family foster care only if authorized by the department in the license is-
17 sued by the department to the agency.

18 “(2) Severance of family ties with children by adoption or otherwise may
19 be accomplished only by the order of a court of competent jurisdiction.

20 “(3) In the absence of the certificate provided for in subsection (4) of this

26 **schedule a hearing no fewer than 10 days following the child’s date of**
27 **birth and no more than 30 days following the date the petition is filed.**

29 **record in detail and in the language of the parent, the terms and**
30 **consequences of the release, surrender or certificate of irrevocability**

1 and waiver and inform the parent that the release, surrender or cer-

3 to the entry of the judgment of adoption.

4 “(B) The parent must execute the release, surrender or certificate

19 “(A) A juvenile court that is a circuit court has entered an order of per-
20 manent commitment of a ward to the Department of Human Services under
21 ORS 419B.527; or

22 “(B) The parent has signed and the department has accepted a release and
23 surrender to the department, and the parent has signed[:]

24 “[*i*] a certificate of irrevocability and waiver as provided in ORS 418.270
25 regarding a child; [*or*]

26 “[*ii*] *A certificate of waiver under the Indian Child Welfare Act regarding*

30 ward and the department consents to the adoption of the child or ward by

1 the prospective parent;

2 “(c) If the child is an Indian child:

3 “(A) The department has offered to coordinate mediation between the In-
4 dian child’s tribe and the proposed adoptive placement;

5 “(B) If requested by the tribe, an agreement is in place that requires the
6 proposed adoptive parent to maintain connection between the Indian child
7 and the Indian child’s tribe; and

8 “(C) If an agreement described in [*paragraph (c)(B) of this subsection*]
9 **subparagraph (B) of this paragraph** is in place, the department incorpo-
10 rates the terms of the agreement into the placement report;

11 “(d) Written evidence of the home study and a placement report request-
12 ing the juvenile court to enter a judgment of adoption have been filed in the
13 juvenile court proceeding; and

14 “(e) At the time the placement report is filed under paragraph (d) of this
15 subsection, the prospective adoptive parent files the adoption report form
16 required under ORS 109.400.

17 “**(2) If the child is an Indian child, a parent’s release, surrender or**
18 **certificate of irrevocability and waiver under subsection (1)(a) of this**
19 **section must meet the following requirements:**

20 “**(a) The court explained to the parent, on the record in detail and**
21 **in the language of the parent, the terms and consequences of the re-**
22 **lease, surrender or certificate of irrevocability and waiver and in-**
23 **formed the parent that the parent may revoke the release, surrender**
24 **or certificate of irrevocability and waiver at any time prior to the**
25 **entry of the judgment of adoption;**

7 “[2] **(3)** Notwithstanding subsection (1) of this section, a prospective
8 adoptive parent is required to file an Adoption Summary and Segregated In-
9 formation Statement with accompanying exhibits as provided under ORS
10 109.317.

11 “[3] **(4)** Notwithstanding ORS 21.135, the clerk of the juvenile court may
12 not charge or collect first appearance fees for a proceeding under this sec-
13 tion.

14 “[4(a)] **(5)(a)**After the filing of written evidence of a home study and the
15 placement report requesting the court to enter a judgment of adoption, the
16 juvenile court that entered the order of permanent commitment, or the ju-
17 venile court having jurisdiction over a ward for whom the department has
18 accepted a release and surrender and a certificate **and waiver** signed by the
19 parent as provided in subsection (1)(a)(B) of this section, may proceed as
20 provided in ORS 109.307 and 109.350 and may enter a judgment of adoption.

21 **“(b)** If the child is an Indian child and the Indian child’s tribe has entered

1 **“SECTION 32. (1) As used in this section:**

2 **“(a) ‘Former parent’ means a person who was previously the legal**
3 **parent of an Indian child subject to a judgment of adoption under ORS**
4 **109.350 or 419B.529 and whose parental rights have not been restored**
5 **under section 33 or 39 of this 2021 Act.**

6 **“(b) ‘Prior Indian custodian’ means a person who was an Indian**
7 **child’s Indian custodian before entry of a judgment of adoption of the**
8 **child under ORS 109.350 or 419B.529.**

9 **“(2) If a judgment of adoption of an Indian child under ORS 109.350**

28 **if any. If the former parent or prior Indian custodian has requested**
29 **anonymity, the execution of the waiver must be made on the record**
30 **before the judge but is not required to be made in a session of court**

2 “(b) Prior to the execution of a waiver under this subsection, the
3 court must explain to the former parent or prior Indian custodian, on
4 the record in detail and in the language of the former parent or prior

8 “(c) After execution of the waiver, the court shall certify that it

28 mail, return receipt requested, notice of the motion for the Indian

30 dian custodian and the time set for filing objections to the motion,

1 together with notice of proceeding in the form required under section
2 16 (3), chapter 14, Oregon Laws 2020 (first special session), to:

3 “(i) Each tribe of which the child may be a member or in which the
4 Indian child may be eligible for membership;

5 “(ii) The child’s parents;

6 “(iii) The child’s Indian custodian, if applicable; and

7 “(iv) The appropriate United States Bureau of Indian Affairs Re-
8 gional Director listed in 25 C.F.R. 23.11(b), if the identify or location
9 of the child’s parents cannot be ascertained.

10 “(B) The petitioner shall file a declaration of compliance, including
11 an original or a copy of each notice sent under this subsection, to-
12 gether with any return receipts or other proof of service.

15 “(d) The court shall order the Indian child returned to the custody
16 of the former parent or prior Indian custodian and restore the parental
17 rights to the Indian child unless the court finds, by clear and con-
18 vincing evidence, that the return of custody or restoration of parental
19 rights is not in the child’s best interests, as described in section 5,
20 chapter 14, Oregon Laws 2020 (first special session).

21 **“SECTION 33. (1) A petition to vacate a judgment of adoption of**
22 **an Indian child under ORS 109.350 or 419B.529 may be filed in a state**
23 **or local court of competent jurisdiction by a parent who consented to**

25 “(2) Upon the filing of a petition under this section, the court shall
26 set a time for a hearing on the petition and provide notice of the pe-

22 **“(b)** In an adoption or readoption [*subject to the Indian Child Welfare*

2 419B.529 (1)(c)(B), the terms of the agreement; and

3 “(D)(i) A finding that the adoptive placement complies with the
4 placement preferences under section 23, chapter 14, Oregon Laws 2020
5 (first special session); or

6 “(ii) If the placement does not comply with the placement prefer-
7 ences under section 23 (2), chapter 14, Oregon Laws 2020 (first special
8 session), a determination upon the petitioner's motion under section
9 23 (3), chapter 14, Oregon Laws 2020 (first special session), that good
10 cause exists for placement contrary to the placement preferences.

12 section, the court must provide a description of the facts upon which
13 the finding or determination is based.

3 *guardianship of an Indian child or the termination of parental rights involv-*
4 *ing an Indian child may be filed in any court of competent jurisdiction by:]*

5 “(1) **A petition to vacate an order or a judgment involving an Indian**
6 **child regarding jurisdiction, placement, guardianship or the termi-**

28 “(c) If the Department of Human Services consented or has the authority

19 [*and*]

20 “[*c*] (C) The Administrator of the Division of Child Support of the De-
21 partment of Justice or the branch office providing support services to the
22 county in which the court is located[.]; **and**

23 “(D) **If the child is an Indian child, the child’s Indian custodian and**
24 **tribe, together with the notice of proceeding in the form required un-**
25 **der section 16 (2), chapter 14, Oregon Laws 2020 (first special session).**

26 “(3) When appropriate, the court shall inform a person before the court
27 claiming to be the parent of a child or ward that parentage establishment
28 services may be available through the administrator if the child or ward:

29 “(a) Is a child born out of wedlock;

30 “(b) Has not been placed for adoption; and

1 “(c) Has fewer than two legal parents.

2 “(4) As used in this section:

3 “(a) ‘Administrator’ has the meaning given that term in ORS 25.010.

4 “(b) ‘Child born out of wedlock’ has the meaning given that term in ORS
5 109.124.

6 “(c) ‘Legal parent’ has the meaning given that term in ORS 419A.004 (19).

7
8 **“JUVENILE DEPENDENCY**

9
10 **“SECTION 47.** Section 7, chapter 14, Oregon Laws 2020 (first special
11 session), is amended to read:

12 **“Sec. 7.** (1) Unless an Indian child’s parent objects, the Department of
13 Human Services shall provide assistance with enrolling an Indian child
14 within the juvenile court’s jurisdiction under ORS 419B.100 in a tribe with
15 which the child is eligible for enrollment.

16 “(2) In any **child custody** proceeding under ORS chapter 419B, [*where*
17 *there is*] **when the department determines the department has** reason to
18 know **that** the child is an Indian child, and **if** the department reasonably
19 believes that the Indian child is eligible for enrollment in a tribe, the de-
20 partment shall notify the Indian child’s parent of the parent’s right to object
21 to the department’s assistance under subsection (1) of this section.

22 **“SECTION 48.** Section 3, chapter 14, Oregon Laws 2020 (first special
23 session), is amended to read:

24 **“Sec. 3.** (1) An individual has custody of an Indian child under sections
25 1 to 23, **chapter 14, Oregon Laws 2020 (first special session)**, [*of this 2020*
26 *special session Act*] if the individual has physical custody or legal custody
27 of the Indian child under any applicable tribal law, tribal custom or state
28 law.

29 “(2) An Indian child’s parent has continued custody of the Indian child
30 **under sections 1 to 23, chapter 14, Oregon Laws 2020 (first special ses-**

1 **sion**), if the parent currently has, or previously had, custody of the Indian
2 child.

3 “(3) For purposes of sections 1 to 23, **chapter 14, Oregon Laws 2020**
4 **(first special session)** [*of this 2020 special session Act*], the following indi-
5 viduals are presumed to have continued custody of an Indian child:

6 “(a) The Indian child’s biological mother.

7 “(b) A man who is married to the Indian child’s biological mother.

8 “(c) A man whose parentage has been acknowledged or established as
9 described in section 4, **chapter 14, Oregon Laws 2020 (first special ses-**
10 **sion)** [*of this 2020 special session Act*].

11 “**SECTION 49.** Section 5, chapter 14, Oregon Laws 2020 (first special
12 session), is amended to read:

13 “**Sec. 5. In a child custody proceeding involving an Indian child,**
14 when making a determination regarding the best interests of [*an Indian*] **the**
15 child under **ORS 109.304 to 109.410, ORS chapter 419B**, sections 1 to 23,
16 **chapter 14, Oregon Laws 2020 (first special session)** [*of this 2020 special*
17 *session Act, ORS chapter 419B*], the Indian Child Welfare Act (25 U.S.C. 1901
18 et seq.) or any regulations or rules regarding **ORS 109.304 to 109.410, ORS**
19 **chapter 419B**, sections 1 to 23, **chapter 14, Oregon Laws 2020 (first spe-**
20 **cial session)**, [*of this 2020 special session Act*] or the Indian Child Welfare
21 Act, the [*juvenile*] court shall, in consultation with the Indian child’s tribe,
22 consider the following [*relevant factors*]:

23 “(1) The protection of the safety, well-being, development and stability of
24 the Indian child;

25 “(2) The prevention of unnecessary out-of-home placement of the Indian
26 child;

27 “(3) The prioritization of placement of the Indian child in accordance with
28 the placement preferences under section 23, **chapter 14, Oregon Laws 2020**
29 **(first special session)** [*of this 2020 special session Act*];

30 “(4) The value to the Indian child of establishing, developing or main-

1 taining a political, cultural, social and spiritual relationship with the Indian
2 child's tribe and tribal community; and

3 “(5) The importance to the Indian child of the Indian tribe's ability to
4 maintain the tribe's existence and integrity in promotion of the stability and
5 security of Indian children and families.

6 **“SECTION 50.** Section 10, chapter 14, Oregon Laws 2020 (first special
7 session), is amended to read:

8 **“Sec. 10.** (1)(a) The Department of Human Services shall make a good
9 faith effort to enter into a tribal-state agreement with any Indian tribe
10 within the borders of this state.

11 “(b) The department may also enter into a tribal-state agreement with any
12 Indian tribe outside of this state having significant numbers of member
13 children or membership-eligible children residing in this state.

14 “(2) The purposes of a tribal-state agreement are to promote the continued
15 existence and integrity of the Indian tribe as a political entity and to protect
16 the vital interests of Indian children in securing and maintaining political,
17 cultural and social relationships with their tribe.

18 “(3) A tribal-state agreement may include[, *but is not limited to,*] agree-
19 ments regarding default jurisdiction over cases in which the state courts and
20 tribal courts have concurrent jurisdiction, the transfer of cases between state
21 courts and tribal courts, the assessment, removal, placement, [*and*] custody
22 **and adoption** of Indian children and any other child welfare services pro-
23 vided to Indian children.

24 “(4) A tribal-state agreement must:

25 “(a) Provide for the cooperative delivery of child welfare services to In-
26 dian children in this state, including the utilization, to the extent available,
27 of services provided by the tribe or an organization whose mission is to serve
28 the American Indian or Alaska Native population to implement the terms
29 of the tribal-state agreement; and

30 “(b) If services provided by the tribe or an organization whose mission is

1 to serve the American Indian or Alaska Native population are unavailable,
2 provide for the department's use of community services and resources devel-
3 oped specifically for Indian families and that have the demonstrated experi-
4 ence and capacity to provide culturally relevant and effective services to
5 Indian children.

6 **"SECTION 51.** Section 11, chapter 14, Oregon Laws 2020 (first special
7 session), is amended to read:

8 **"Sec. 11.** Section 10 (3), chapter 14, Oregon Laws 2020 (first special
9 session), [of this 2020 special session Act] applies to tribal-state agreements
10 entered into or renewed on or after [the effective date of this 2020 special
11 session Act] **January 1, 2021.**

12 **"SECTION 52.** Section 17, chapter 14, Oregon Laws 2020 (first special
13 session), is amended to read:

14 **"Sec. 17.** (1) In any **child custody** proceeding under ORS chapter **109 or**
15 **419B** that requires the testimony of a qualified expert witness, the petitioner
16 shall contact the Indian child's tribe and request that the tribe identify one
17 or more individuals meeting the criteria described in subsection (3) or (4) of
18 this section. The petitioner may also request the assistance of the United
19 States Bureau of Indian Affairs in locating individuals meeting the criteria
20 described in subsection (3) or (4) of this section. The petitioner shall file a
21 declaration with the court describing the efforts the petitioner made under
22 this subsection to identify a qualified expert witness.

23 **"(2)** At a hearing under ORS **109.326, 109.330, 419B.340, 419B.365, 419B.366**
24 **or 419B.521, [when there] if the court has found that there** is reason to
25 know **that** a child is an Indian child [and a qualified expert witness is re-
26 quired], at least one qualified expert witness must testify regarding:

27 **"(a)** Whether the [Indian child's] continued custody **of the Indian child**
28 by the [Indian] child's parent or **custody by the child's** Indian custodian
29 is likely to result in serious emotional or physical damage to the Indian
30 child; and

1 “(b) The prevailing social and cultural standards and child rearing prac-
2 tices of the Indian child’s tribe.

3 “(3) A person is a qualified expert witness under this section if the Indian
4 child’s tribe has designated the person as being qualified to testify to the
5 prevailing social and cultural standards of the tribe.

6 “(4) If the Indian child’s tribe has not identified a qualified expert wit-
7 ness, the following individuals, in order of priority, may testify as a qualified
8 expert witness:

9 “(a) A member of the Indian child’s tribe or another person [*of the tribe’s*
10 *choice*] who is recognized by the tribe as knowledgeable **about** tribal customs
11 regarding family organization or child rearing practices;

12 “(b) A person having substantial experience in the delivery of child and
13 family services to Indians and extensive knowledge of prevailing social and
14 cultural standards and child rearing practices within the Indian child’s tribe;
15 or

16 “(c) Any person having substantial experience in the delivery of child and
17 family services to Indians and knowledge of prevailing social and cultural
18 standards and child rearing practices in Indian tribes with cultural similar-
19 ities to the child’s tribe.

20 “(5) In addition to testimony from a qualified expert witness, the court
21 may hear supplemental testimony regarding information described in sub-
22 section (2) of this section from a professional having substantial education
23 and experience in the area of the professional’s specialty.

24 “(6) No petitioning party, employees of the petitioning party or an em-
25 ployee of the Department of Human Services may serve as a qualified expert
26 witness or a professional under this section.

27 “**SECTION 53.** ORS 418.312, as amended by section 53, chapter 14, Oregon
28 Laws 2020 (first special session), and sections 16a and 16b, chapter 19,
29 Oregon Laws 2020 (first special session), is amended to read:

30 “418.312. (1) The Department of Human Services may not require any

1 parent or legal guardian to transfer legal custody of a child in order to have
2 the child placed in a child-caring agency under ORS 418.205 to 418.327,
3 418.470, 418.475, 418.480 to 418.500, 418.950 to 418.970 and 418.992 to 418.998
4 in a foster home, group home or institutional child care setting, when the
5 sole reason for the placement is the need to obtain services for the child's
6 emotional, behavioral or mental disorder or developmental or physical disa-
7 bility. In all such cases, the child shall be placed pursuant to a voluntary
8 placement agreement. When a child is placed pursuant to a voluntary
9 placement agreement, the department shall have responsibility for the child's
10 placement and care.

11 “(2) If a child is placed pursuant to a voluntary placement agreement in
12 a qualified residential treatment program as described in section 12b, chapter
13 19, Oregon Laws 2020 (first special session), the placement is subject to ju-
14 dicial approval under section 14b, chapter 19, Oregon Laws 2020 (first special
15 session).

16 “[*(3)(a) If a child is placed pursuant to a voluntary placement agreement
17 and there is reason to know under section 15, chapter 14, Oregon Laws 2020
18 (first special session), that the child is an Indian child, the placement and
19 voluntary placement agreement must be approved by the juvenile court.*]

20 **“(3)(a) When a child is placed pursuant to a voluntary placement
21 agreement, the department shall make inquiries, as described in sec-
22 tion 15 (2), chapter 14, Oregon Laws 2020 (first special session), to de-
23 termine whether the department has reason to know that the child is
24 an Indian child.**

25 **“(b) If the department has reason to know that the child is an In-
26 dian child, the placement agreement must be executed in person be-
27 fore the juvenile court, consistent with this subsection, and the
28 placement must be approved by the court.**

29 **“(c) At a hearing, the juvenile court shall explain to the Indian
30 child's parent or Indian custodian, on the record in detail and in the**

1 language of the parent or Indian custodian, the terms and conse-
2 quences of the voluntary placement agreement, including that if the
3 Indian child remains in custody for more than 12 months, the court
4 will hold a permanency hearing that could eventually result in the
5 termination of parental rights, and the court must inform the parent
6 or Indian custodian that the voluntary placement agreement may be
7 revoked at any time prior to an entry of a final decree of termination
8 of parental rights and have the child returned to the parent's custody.
9 The parent or Indian custodian must execute the voluntary placement
10 agreement before the court. The parent or Indian custodian shall file
11 a record of the voluntary placement agreement with the court. The
12 court shall certify that the court provided the explanation consistent
13 with the requirements under this paragraph and that the parent or
14 Indian custodian fully understood the explanation.

15 “[*(b)*] (d) The juvenile court may approve the voluntary placement agree-
16 ment if:

17 “(A) The court finds that the Indian child's parent or Indian custodian
18 entered into the voluntary placement agreement without a threat of removal
19 by the Department of Human Services or an Oregon licensed adoption
20 agency; **and**

21 “(B) The proposed placement conforms with the placement preferences
22 described in section 23, chapter 14, Oregon Laws 2020 (first special
23 session)[;].

24 “[*(C)* The agreement is executed in writing and filed with the court;]

25 “[*(D)* The court has explained to the Indian child's parent or Indian
26 custodian the terms and consequences of the agreement, including that if the
27 Indian child remains in custody for more than 12 months, the juvenile court
28 will hold a permanency hearing which could eventually result in the termi-
29 nation of parental rights, and that the Indian child's parent or Indian custo-
30 dian may withdraw consent to the agreement at any time prior to an entry of

1 a final decree of termination of parental rights and have the child returned to
2 the parent's custody; and]

3 “[*(E)*] The juvenile court certifies that the explanation required under par-
4 agraph *(b)(D)* of this subsection was provided in English or, if English is not
5 the primary language of the Indian child's parent or Indian custodian, in the
6 primary language of the Indian child's parent or Indian custodian, and that
7 the explanation was fully understood by the parent or Indian custodian.]

8 “[*(c)*] **(e)** An Indian child's parent or Indian custodian may terminate the
9 voluntary placement agreement at any time prior to an entry of an order
10 terminating parental rights. To terminate the voluntary placement agree-
11 ment, the parent or Indian custodian must file a written notice of termi-
12 nation with the **juvenile** court or otherwise testify before the court. The
13 court shall promptly notify the department of the termination and order the
14 immediate return of the Indian child to the physical custody of the Indian
15 child's parent or Indian custodian.

16 “(4)(a) If a child remains in voluntary placement for more than 180 days,
17 the juvenile court shall make a judicial determination, within the first 180
18 days of the placement, that the placement is in the best interests of the child.

19 “(b) If a child remains in voluntary placement for more than 12 months,
20 the juvenile court shall hold a permanency hearing as provided in ORS
21 419B.476 no later than 14 months after the child's original voluntary place-
22 ment, and not less frequently than once every 12 months thereafter during
23 the continuation of the child's original voluntary placement, to determine
24 the future status of the child.

25 “(5) As used in this section, ‘voluntary placement agreement’ means a
26 binding, written agreement between the department and the parent or legal
27 guardian of a minor child that does not transfer legal custody to the de-

1 **“SECTION 54.** ORS 419B.150, as amended by section 29, chapter 14,
2 Oregon Laws 2020 (first special session), is amended to read:

3 “419B.150. (1) As used in this section:

4 “(a) ‘Abuse’ has the meaning given that term in ORS 419B.005.

5 “(b) ‘Reasonable cause’ means a subjectively and objectively reasonable
6 belief, given all of the circumstances and based on specific and articulable
7 facts.

8 “(c) ‘Severe harm’ means:

9 “(A) Life-threatening damage; or

10 “(B) Significant or acute injury to a person’s physical, sexual or psycho-
11 logical functioning.

12 “(2) The following persons are authorized to take a child into protective
13 custody under this section:

14 “(a) A peace officer, as defined in ORS 420.905;

15 “(b) A counselor; or

16 “(c) An employee of the Department of Human Services.

17 “(3)(a) Prior to taking a child into protective custody under this section,
18 the person taking the child into protective custody shall **conduct the in-**
19 **quiry described in section 15, chapter 14, Oregon Laws 2020 (first spe-**
20 **cial session), to** determine whether *[there is]* **the person has** reason to
21 know **that** the child is an Indian child[, *as provided in section 15, chapter*
22 *14, Oregon Laws 2020 (first special session)*].

23 “(b) If *[there is]* **the person has** reason to know **that** the child is an In-
24 dian child, the **person taking the child into protective custody shall**
25 **provide the** emergency notification *[requirements of]* **under** section 16 (1),
26 chapter 14, Oregon Laws 2020 (first special session), *[must be met prior to]*
27 **before** taking the child into protective custody.

28 “(4)(a) Except as provided in paragraph (b) of this subsection, a child may
29 be taken into protective custody without a court order only when there is
30 reasonable cause to believe that:

1 “(A) There is an imminent threat of severe harm to the child;

2 “(B) The child poses an imminent threat of severe harm to self or others;

3 or

4 “(C) There is an imminent threat that the child’s parent or guardian will
5 cause the child to be beyond the reach of the juvenile court before the court
6 can order that the child be taken into protective custody under subsection
7 (7) of this section.

8 “(b) If [*there is*] **the person has** reason to know that the child is an In-
9 dian child, the child may be taken into protective custody without a court
10 order only when it is necessary to prevent imminent physical damage or
11 harm to the child.

12 “(5) A person authorized to take a child into protective custody shall ap-
13 ply for a protective custody order, as described in subsection (7) of this sec-
14 tion, by submitting a declaration based on information and belief that sets
15 forth with particularity:

16 “(a) Why protective custody is necessary and the least restrictive means
17 available to:

18 “(A) Protect the child from abuse;

19 “(B) Prevent the child from inflicting harm on self or others;

20 “(C) Ensure that the child remains within the reach of the juvenile court
21 to protect the child from abuse or to prevent the child from inflicting harm
22 on self or others; or

23 “(D) If the department [*knows or*] has reason to know that the child is
24 an Indian child, prevent imminent physical damage or harm to the child.

25 “(b) Why protective custody is in the best interests of the child.

26 “(6)(a) The applicant under subsection (5) of this section shall deliver the
27 declaration described in subsection (5) of this section to the juvenile court.

28 “(b) At the applicant’s request, instead of the declaration described in
29 subsection (5) of this section, the judge may take an oral statement under
30 oath. If the applicant makes the oral statement to the judge out of court, the

1 applicant shall record the oral statement and retain a copy of the recording.
2 The recording constitutes a declaration for the purposes of subsection (5) of
3 this section.

4 “(7) The juvenile court may order that a child be taken into protective
5 custody if, after reviewing the declaration described in subsection (5) of this
6 section, the court [*determines that*]:

7 “(a) **Determines that the person complied with the inquiry require-**
8 **ments under section 15, chapter 14, Oregon Laws 2020 (first special**
9 **session);**

10 “(b) **Makes a finding, subject to the procedures under section 15 (4),**
11 **chapter 14, Oregon Laws 2020 (first special session), regarding whether**
12 **there is reason to know that the child is an Indian child;**

13 “(c) **If the court finds that there is reason to know that the child**
14 **is an Indian child, determines that the person complied with the notice**
15 **requirements under section 16 (1), chapter 14, Oregon Laws 2020 (first**
16 **special session);**

17 “[*a*] (d) **Determines that** protective custody is necessary and the least
18 restrictive means available to:

19 “(A) Protect the child from abuse;

20 “(B) Prevent the child from inflicting harm on self or others;

21 “(C) Ensure that the child remains within the reach of the juvenile court
22 to protect the child from abuse or prevent the child from inflicting harm on
23 self or others;

24 “(D) Ensure the safety of a child who has run away from home; or

25 “(E) If the [*department knows or has*] **court finds that there is** reason
26 to know that the child is an Indian child, prevent imminent physical damage
27 or harm to the child; and

28 “[*b*] (e) **Determines that** protective custody is in the best interests of
29 the child.

30 “(8) When the court issues a protective custody order under subsection

1 (7) of this section, the court may transmit the signed order to the applicant
2 by a form of electronic communication approved by the court that delivers
3 a complete printable image of the signed order. The court shall file the ori-
4 ginal order in the court record.

5 **“SECTION 55.** ORS 419B.171, as amended by section 30, chapter 14,
6 Oregon Laws 2020 (first special session), is amended to read:

7 “419B.171. (1) Except where the child is taken into protective custody
8 pursuant to an order of the court, the person taking the child into protective
9 custody shall promptly file with the court or a counselor a brief written re-
10 port stating all of the following:

11 “(a) The child’s name, age and address.

12 “(b) The name and address of the person having legal or physical custody
13 of the child.

14 “(c) Efforts to notify the person having legal or physical custody of the
15 child and the results of those efforts.

16 “(d) Reasons for and circumstances under which the child was taken into
17 protective custody.

18 “(e) If the child is not taken to court, the placement of the child.

19 “(f) If the child was not released, the reason why the child was not re-
20 leased.

21 “(g) If the child is not taken to court, why the type of placement was
22 chosen.

23 “(h) **A statement and documentation of the person’s** efforts to deter-
24 mine whether *[there is]* **the person has** reason to know that the child is an
25 Indian child[, *as required under section 15, chapter 14, Oregon Laws 2020 (first*
26 *special session),]* and the results of those efforts.

27 “(2) If *[there is]* **the person has** reason to know that the child is an In-
28 dian child, the report under subsection (1) of this section must also include:

29 “(a) The name and address of the Indian child’s parents and, if any, Indian
30 custodian;

1 “(b) Confirmation that notification about the emergency proceeding [*un-*
2 *der section 16 (1), chapter 14, Oregon Laws 2020 (first special session),*] has
3 been provided **as required under section 16 (1), chapter 14, Oregon Laws**
4 **2020 (first special session)**;

5 “(c) If the Indian child’s parent or Indian custodian is unknown, a de-
6 tailed [*explanation*] **description and documentation** of [*what efforts have*
7 *been*] **the efforts the person has** made to locate and contact the parent or
8 Indian custodian, including contact with the appropriate United States Bu-
9 reau of Indian Affairs Regional Director;

10 “(d) The tribal affiliation of the Indian child and the Indian child’s parent
11 or Indian custodian;

12 “(e) The residence and the domicile of the Indian child;

13 “(f) If either the residence or the domicile of the Indian child is believed
14 to be on a reservation or in an Alaska Native village, the name of the tribe
15 affiliated with that reservation or village;

16 “(g) A specific and detailed account of the circumstances that led the
17 person responsible for the emergency removal of the Indian child to deter-
18 mine that removal of the Indian child was necessary to prevent imminent
19 physical damage or harm and to remove the Indian child;

20 “(h) If the Indian child is believed to reside or **to** be domiciled on a res-
21 ervation, a statement describing the efforts that were made and are being
22 made to contact the tribe and transfer the Indian child to the tribe’s juris-
23 diction; and

24 “(i) A statement of the efforts that have been [*taken*] **made** to assist the
25 Indian child’s parent or Indian custodian so that the Indian child may re-
26 main in or safely be returned to the custody of the Indian child’s parent or
27 Indian custodian.

28 “**SECTION 56.** ORS 419B.185, as amended by section 31, chapter 14,
29 Oregon Laws 2020 (first special session), is amended to read:

30 “419B.185. (1) When a child or ward is taken, or is about to be taken, into

1 protective custody pursuant to ORS 419B.150, 419B.152, 419B.160, 419B.165,
2 419B.168 or 419B.171 and placed in shelter care, a parent, child or ward shall
3 be given the opportunity to present evidence to the court at the hearings
4 specified in ORS 419B.183, and at any subsequent review hearing, that the
5 child or ward can be returned home without further danger of suffering
6 physical injury or emotional harm, endangering or harming others, or not
7 remaining within the reach of the court process prior to adjudication. [At
8 *the hearing:*]

9 **“(2) When the court conducts a hearing described in subsection (1)**
10 **of this section, unless the court has previously entered an order find-**
11 **ing that the child is an Indian child, before the court may enter an**
12 **order taking a child or ward into protective custody the court shall**
13 **inquire and make a finding, subject to the procedures under section**
14 **15 (4), chapter 14, Oregon Laws 2020 (first special session), regarding**
15 **whether there is reason to know that the child is an Indian child.**

16 *“(a) The court shall make written findings as to:”*

17 *“(A) Whether there is reason to know, as described in section 15, chapter*
18 *14, Oregon Laws 2020 (first special session), that the child or ward is an In-*
19 *Indian child; and]*

20 *“(B) Whether the Department of Human Services has made reasonable ef-*
21 *forts or, if there is reason to know as described in section 15, chapter 14,*
22 *Oregon Laws 2020 (first special session), the child or ward is an Indian child,*
23 *active efforts pursuant to section 18, chapter 14, Oregon Laws 2020 (first spe-*
24 *cial session), to prevent or eliminate the need for removal of the child or ward*
25 *from the home and to make it possible for the child or ward to safely return*
26 *home.]*

27 **“(3)(a) At a hearing described in subsection (1) of this section, the**
28 **court shall make written findings as to whether the Department of**

30 **dian child, active efforts to prevent or eliminate the need for removal**

3 **“(b)** [*When*] **If** the court finds that no services were provided [*but that*
4 *reasonable services would not have eliminated the need for protective*
5 *custody*], the court shall consider the department to have made reasonable
6 efforts or, if [*there is reason to know that*] the child or ward is an Indian
7 child, active efforts to prevent or eliminate the need for protective
8 custody[.] **if:**

9 **“(A) The court finds that reasonable services would not have elim-**
10 **inated the need for protective custody; or**

11 **“(B) If the child is an Indian child, the court finds that active ef-**
12 **forts to provide services as described in section 5, chapter 14, Oregon**
13 **Laws 2020 (first special session), would not have eliminated the need**
14 **for protective custody.**

15 **“(c)** The court shall include in the written findings **under paragraphs**
16 **(a) and (b) of this subsection** a brief description of the preventive and re-
17 unification efforts made by the department.

5 “**(a)** The department provides documentation **showing** that the depart-
6 ment [*has*] made inquiries as required under section 15, chapter 14, Oregon

10 minated, unless admitted, must be established by clear and convincing evi-

4 “(f) The progress which has been made toward alleviating the need for

29 breakup of the Indian family prior to the child’s removal and whether those
30 efforts did not eliminate the necessity for removal based on serious emo-

1 tional or physical damage to the child;

2 “(B) If the case plan at the time of the review is to reunify the family,
3 whether the department has provided active efforts to make it possible for
4 the child to safely return home, whether active efforts have eliminated the
5 necessity for continued removal based on serious emotional or physical
6 damage to the child and whether the parent has made sufficient progress to
7 make it possible for the child to return home;

8 “(C) If the case plan at the time of review is to reunify the family and
9 the child or ward is placed in a home outside the placement preferences de-
10 scribed in section 23, chapter 14, Oregon Laws 2020 (first special session),
11 whether the department has continued to maintain the relationship of the
12 child or ward with potential adoption preferences or whether the department
13 has continued to search for a permanent placement that satisfies the place-
14 ment preferences described in section 23, chapter 14, Oregon Laws 2020 (first
15 special session); and

16 “(D) If the case plan at the time of the review is something other than
17 to reunify the family, whether the department has made active efforts to

20 “(2) The local citizen review board may, if the case plan has changed
21 during the period since the last review by a local citizen review board or
22 court hearing, make written findings and recommendations with respect to:

24 forts or, if [*there is reason to know, as described in section 15, chapter 14,*
25 *Oregon Laws 2020 (first special session),*] **the department has reason to**

3 ing, if appropriate, placement of the child or ward through an interstate
4 placement, and to complete the steps necessary to finalize the permanent
5 placement of the child or ward, if a case plan other than to reunify the
6 family was in effect for any part of the period since the last review or
7 hearing.

8 “(3) In determining whether the Department of Human Services has made
9 reasonable efforts or, if [*there is reason to know, as described in section 15,*
10 *chapter 14, Oregon Laws 2020 (first special session),*] **the department has**
11 **reason to know** that the child is an Indian child, active efforts to make it
12 possible for the child or ward to safely return home, the local citizen review
13 board shall consider the child or ward’s health and safety the paramount
14 concerns.

15 “(4) No later than 10 days after receiving the findings and recommen-
16 dations of the local citizen review board, a party adversely affected by the

4 “(c) Must have skills and experience in representing persons with mental

16 or vacate a guardianship, the court shall consider, but is not limited to
17 considering:

18 “(a) The ward’s emotional and developmental needs;

19 “(b) The ward’s need to maintain existing attachments and relationships
20 and to form attachments and relationships, including those with the birth
21 family;

22 “(c) The ward’s health and safety; and

23 “(d) The ward’s wishes.

24 “(6) In addition to service required under ORS 419B.851, a party filing a
25 motion to vacate a guardianship shall serve the motion upon the Department
26 of Human Services.

27 “(7) Notwithstanding subsection (1) of this section, a parent may not move
28 the court to vacate a guardianship once a guardianship is granted under ORS
29 419B.365.

30 “(8) If a guardianship is established under ORS 419B.366 and 419B.371, the

1 court shall conduct a court review not later than 60 days before the ward
2 reaches 18 years of age. At the hearing, the court shall inform the ward that
3 after reaching 18 years of age the ward may not be placed in substitute care
4 in the legal custody of the Department of Human Services.

5 **“SECTION 73.** ORS 419B.449, as amended by section 46, chapter 14,
6 Oregon Laws 2020 (first special session), is amended to read:

7 “419B.449. (1) Upon receiving any report required by ORS 419B.440, the
8 court may hold a hearing to review the child or ward’s condition and cir-
9 cumstances and to determine if the court should continue jurisdiction and
10 wardship or order modifications in the care, placement and supervision of the
11 child or ward. The court shall hold a hearing:

12 “(a) In all cases under ORS 419B.440 (1)(b)(B) when the parents’ rights
13 have been terminated;

14 “(b) If requested by the child or ward, the attorney for the child or ward,
15 if any, the parents or the public or private agency having guardianship or
16 legal custody of the child or ward within 30 days of receipt of the notice
17 provided in ORS 419B.452;

18 “(c) Not later than six months after receipt of a report made under ORS
19 419B.440 (1)(a) on a ward who is in the legal custody of the Department of
20 Human Services pursuant to ORS 419B.337 but who is placed in the physical
21 custody of a parent or a person who was appointed the ward’s legal guardian
22 prior to placement of the ward in the legal custody of the department;

23 “(d) Within 30 days after receipt of a report made under ORS 419B.440
24 (1)(b)(C); or

25 “(e) Within 10 days after receipt of a report made under ORS 419B.440
26 (1)(c).

27 “(2) The court shall conduct a hearing provided in subsection (1) of this
28 section in the manner provided in ORS 419B.310, except that the court may
29 receive testimony and reports as provided in ORS 419B.325. At the conclusion
30 of the hearing, the court shall enter findings of fact.

1 “(3) If the child or ward is in substitute care and the decision of the court
2 is to continue the child or ward in substitute care, the findings of the court
3 shall specifically state:

4 “(a)(A) Why continued care is necessary as opposed to returning the child
5 or ward home or taking prompt action to secure another permanent place-
6 ment; and

7 “(B) The expected timetable for return or other permanent placement.

8 “(b) Whether the agency having guardianship or legal custody of the child
9 or ward has made diligent efforts to place the child or ward pursuant to ORS
10 419B.192.

11 “(c) The number of placements made, schools attended, face-to-face con-
12 tacts with the assigned case worker and visits had with parents or siblings
13 since the child or ward has been in the guardianship or legal custody of the
14 agency and whether the frequency of each of these is in the best interests
15 of the child or ward.

16 “(d) For a child or ward 14 years of age or older, whether the child or
17 ward is progressing adequately toward graduation from high school and, if
18 not, the efforts that have been made by the agency having custody or
19 guardianship to assist the child or ward to graduate.

20 “(e) For a ward 16 years of age or older with a permanency plan of an-
21 other planned permanent living arrangement, the steps the department is
22 taking to ensure that:

23 “(A) The ward’s substitute care provider is following the reasonable and
24 prudent parent standard; and

25 “(B) The ward has regular, ongoing opportunities to engage in age-
26 appropriate or developmentally appropriate activities, including consultation
27 with the ward in an age-appropriate manner about the opportunities the
28 ward has to participate in the activities.

29 “(4) If the ward is in the legal custody of the department but has been
30 placed in the physical custody of the parent or a person who was appointed

1 the ward’s legal guardian prior to placement of the ward in the legal custody
2 of the department, and the decision is to continue the ward in the legal
3 custody of the department and the physical custody of the parent or guard-
4 ian, the findings of the court shall specifically state:

5 “(a) Why it is necessary and in the best interests of the ward to continue
6 the ward in the legal custody of the department; and

7 “(b) The expected timetable for dismissal of the department’s legal cus-
8 tody of the ward and termination of the wardship.

9 “(5) If [*there is reason to know, as described in section 15, chapter 14,*
10 *Oregon Laws 2020 (first special session), that*] the child or ward is an Indian
11 child and the child or ward is in the legal custody of the department but has
12 been placed in the physical custody of the parent or a person who was ap-
13 pointed the child’s or ward’s legal guardian prior to placement of the child
14 or ward in the legal custody of the department, the court may order that the
15 child or ward be placed in the physical custody of a substitute care provider
16 only after making all of the inquiry, notice and findings required under ORS
17 419B.305 and 419B.310.

18 “(6) In making the findings under subsection (2) of this section, the court
19 shall consider the efforts made to develop the concurrent case plan, includ-
20 ing, but not limited to, identification of appropriate permanent placement
21 options for the child or ward both inside and outside this state and, if
22 adoption is the concurrent case plan, identification and selection of a suit-
23 able adoptive placement for the child or ward.

24 “(7)(a) If [*there is reason to know, as described in section 15, chapter 14,*
25 *Oregon Laws 2020 (first special session), that*] the child or ward is an Indian
26 child, the findings of the court shall specifically state whether the depart-
27 ment has provided active efforts to reunify the Indian child with the Indian
28 child’s parent or Indian custodian.

29 “(b) If the court finds that active efforts have not been provided, the court
30 shall order that the Indian child be immediately returned to the Indian

1 child's parent.

2 “(c) Notwithstanding paragraph (b) of this subsection, if the court finds
3 that returning the Indian child to the Indian child's parent will result in
4 substantial and immediate danger or threat of danger to the Indian child, the
5 court shall:

6 “(A) Determine the period of time during which active efforts were not
7 provided;

8 “(B) Order the department to provide those services necessary for the
9 provision of active efforts;

10 “(C) Order the department to continue placement of the Indian child
11 pursuant to the placement preferences under section 23, chapter 14, Oregon
12 Laws 2020 (first special session); and

13 “(D) Order the department to continue to foster relationships with any
14 individuals identified by the department as long-term placement resources
15 meeting the placement preferences under section 23, chapter 14, Oregon Laws
16 2020 (first special session).

17 “(8) In addition to findings of fact required by subsection (2) of this sec-
18 tion, the court may order the department to consider additional information
19 in developing the case plan or concurrent case plan.

20 “(9) Any final decision of the court made pursuant to the hearing provided
21 in subsection (1) of this section is appealable under ORS 419A.200.

22 **“SECTION 74.** ORS 419B.452, as amended by section 59, chapter 14,
23 Oregon Laws 2020 (first special session), is amended to read:

24 “419B.452. Except when a child or ward has been surrendered for adoption
25 or the parents' rights have been terminated, the court shall send a copy of
26 the report required by ORS 419B.440 to the parents and shall notify the
27 parents either that a hearing will be held or that the parents may request
28 a hearing at which time they may ask for modifications in the care, treat-
29 ment and supervision of the child or ward. If the court finds that informing
30 the parents of the identity and location of the foster parents of the child or

1 ward is not in the best interest of the child or ward, the court may order
2 such information deleted from the report before sending the report to the
3 parents. [*If there is reason to know, as described in section 15, chapter 14,*
4 *Oregon Laws 2020 (first special session), that an Indian child is involved*] **If**
5 **the child is an Indian child**, the court shall send a copy of the report to
6 the Indian child’s tribe as required by the notice requirements under section
7 16, chapter 14, Oregon Laws 2020 (first special session).

8 **“SECTION 75.** ORS 419B.476, as amended by section 38, chapter 14,
9 Oregon Laws 2020 (first special session), is amended to read:

10 “419B.476. (1) A permanency hearing shall be conducted in the manner
11 provided in ORS 418.312, 419B.310, 419B.812 to 419B.839 and 419B.908, except
12 that the court may receive testimony and reports as provided in ORS
13 419B.325.

14 “(2) At a permanency hearing the court shall:

15 “(a) If the case plan at the time of the hearing is to reunify the family,
16 determine whether the Department of Human Services has made reasonable
17 efforts or, if [*there is reason to know as described in section 15, chapter 14,*
18 *Oregon Laws 2020 (first special session), that*] the ward is an Indian child,
19 active efforts as described in section 18, chapter 14, Oregon Laws 2020 (first
20 special session), to make it possible for the ward to safely return home and
21 whether the parent has made sufficient progress to make it possible for the
22 ward to safely return home. In making its determination, the court shall
23 consider the ward’s health and safety the paramount concerns.

24 “(b) If the case plan at the time of the hearing is something other than
25 to reunify the family, determine whether the department has made reasonable
26 efforts to place the ward in a timely manner in accordance with the plan,
27 including, if appropriate, reasonable efforts to place the ward through an
28 interstate placement, and to complete the steps necessary to finalize the
29 permanent placement.

30 “(c) If the case plan at the time of the hearing is something other than

1 to reunify the family, determine whether the department has considered
2 permanent placement options for the ward, including, if appropriate, whether
3 the department has considered both permanent in-state placement options
4 and permanent interstate placement options for the ward.

5 “(d) Make the findings of fact under ORS 419B.449 (3).

6 “(3) When the ward is 14 years of age or older, in addition to making the
7 determination required by subsection (2) of this section, at a permanency
8 hearing the court shall review the comprehensive plan for the ward’s tran-
9 sition to successful adulthood and determine and make findings as to:

10 “(a) Whether the plan is adequate to ensure the ward’s transition to
11 successful adulthood;

12 “(b) Whether the department has offered appropriate services pursuant to
13 the plan; and

14 “(c) Whether the department has involved the ward in the development
15 of the plan.

16 “(4) At a permanency hearing the court may:

17 “(a) If the case plan changed during the period since the last review by
18 a local citizen review board or court hearing and a plan to reunify the family
19 was in effect for any part of that period, determine whether the department
20 has made reasonable efforts or, if [*there is reason to know as described in*
21 *section 15, chapter 14, Oregon Laws 2020 (first special session), that*] the ward
22 is an Indian child, active efforts as described in section 18, chapter 14,
23 Oregon Laws 2020 (first special session), to make it possible for the ward to
24 safely return home. In making its determination, the court shall consider the
25 ward’s health and safety the paramount concerns;

26 “(b) If the case plan changed during the period since the last review by
27 a local citizen review board or court hearing and a plan other than to reu-
28 nify the family was in effect for any part of that period, determine whether
29 the department has made reasonable efforts to place the ward in a timely
30 manner in accordance with the plan, including, if appropriate, placement of

1 the ward through an interstate placement, and to complete the steps neces-
2 sary to finalize the permanent placement;

3 “(c) If the court determines that further efforts will make it possible for
4 the ward to safely return home within a reasonable time, order that the
5 parents participate in specific services for a specific period of time and make
6 specific progress within that period of time;

7 “(d) Determine the adequacy and compliance with the case plan and the
8 case progress report;

9 “(e) Review the efforts made by the department to develop the concurrent
10 permanent plan, including but not limited to identification of appropriate
11 permanent in-state placement options and appropriate permanent interstate
12 placement options and, if adoption is the concurrent case plan, identification
13 and selection of a suitable adoptive placement for the ward;

14 “(f) Order the department to develop or expand the case plan or concur-
15 rent permanent plan and provide a case progress report to the court and
16 other parties within 10 days after the permanency hearing;

17 “(g) Order the department or agency to modify the care, placement and
18 supervision of the ward;

19 “(h) Order the local citizen review board to review the status of the ward
20 prior to the next court hearing; or

21 “(i) Set another court hearing at a later date.

22 “(5) The court shall enter an order within 20 days after the permanency
23 hearing. In addition to any determinations or orders the court may make
24 under subsection (4) of this section, the order shall include the following:

25 “(a) The court’s determinations required under subsections (2) and (3) of
26 this section, including a brief description of the efforts the department has
27 made with regard to the case plan in effect at the time of the permanency
28 hearing.

29 “(b) The court’s determination of the permanency plan for the ward that
30 includes whether and, if applicable, when:

1 “(A) The ward will be returned to the parent;

2 “(B) The ward will be placed for adoption, and a petition for termination
3 of parental rights will be filed;

4 “(C) The ward will be referred for establishment of legal guardianship;

5 “(D) The ward will be placed with a fit and willing relative; or

6 “(E) If the ward is 16 years of age or older, the ward will be placed in
7 another planned permanent living arrangement.

8 “(c) If the court determines that the permanency plan for the ward should
9 be to return home because further efforts will make it possible for the ward
10 to safely return home within a reasonable time, the court’s determination
11 of the services in which the parents are required to participate, the progress
12 the parents are required to make and the period of time within which the
13 specified progress must be made.

14 “(d) If the court determines that the permanency plan for the ward should
15 be adoption, the court’s determination of whether one of the circumstances
16 in ORS 419B.498 (2) is applicable.

17 “(e) If the court determines that the permanency plan for the ward should
18 be establishment of a legal guardianship, the court’s determination of why
19 neither placement with parents nor adoption is appropriate.

20 “(f) If the court determines that the permanency plan for a ward should
21 be placement with a fit and willing relative, the court’s determination of why
22 placement with the ward’s parents, or for adoption, or placement with a legal
23 guardian, is not appropriate.

24 “(g) If the court determines that the permanency plan for a ward 16 years
25 of age or older should be another planned permanent living arrangement, the
26 court’s determinations:

27 “(A) Why another planned permanent living arrangement is in the ward’s
28 best interests and a compelling reason, that must be documented by the de-
29 partment, why it would not be in the best interests of the ward to be re-
30 turned home, placed for adoption, placed with a legal guardian or placed

1 with a fit and willing relative; and

2 “(B) That the department has taken steps to ensure that:

3 “(i) The ward’s substitute care provider is following the reasonable and
4 prudent parent standard; and

5 “(ii) The ward has regular, ongoing opportunities to engage in age-
6 appropriate or developmentally appropriate activities, including consultation
7 with the ward in an age-appropriate manner about the opportunities the
8 ward has to participate in the activities.

9 “(h) If the current placement is not expected to be permanent, the court’s
10 projected timetable for return home or for placement in another planned
11 permanent living arrangement. If the timetable set forth by the court is not
12 met, the department shall promptly notify the court and parties.

13 “(i) If [*there is reason to know that an Indian child is involved*] **the ward**
14 **is an Indian child**, the tribal affiliation of the ward.

15 “(j) If [*there is reason to know that*] the ward is an Indian child and **if** the
16 court determines that the permanency plan for the ward should be something
17 other than to reunify the family, the court’s determination, by clear and
18 convincing evidence, that:

19 “(A) Active efforts as described in section 18, chapter 14, Oregon Laws
20 2020 (first special session), were provided to make it possible for the Indian
21 child to safely return home;

22 “(B) Despite the efforts provided, continued removal of the Indian child
23 is necessary to prevent serious emotional or physical damage to the Indian
24 child;

25 “(C) The parent has not made sufficient progress to make it possible for
26 the Indian child to safely return home; and

27 “(D) The new permanency plan complies with the placement preferences
28 described in section 23, chapter 14, Oregon Laws 2020 (first special session).

29 “(k) If the ward has been placed in an interstate placement, the court’s
30 determination of whether the interstate placement continues to be appropri-

1 ate and in the best interests of the ward.

2 “(6) In making the determinations under subsection (5)(g) of this section,
3 the court shall ask the ward about the ward’s desired permanency outcome.

4 “(7) If [*there is reason to know that an Indian child is involved*] **the child**
5 **is an Indian child:**

6 “(a) The court shall follow the placement preferences described in section
7 23, chapter 14, Oregon Laws 2020 (first special session).

8 “(b) If the court finds that the department did not provide active efforts
9 to make it possible for the Indian child to safely return home, the court may
10 not, at that permanency hearing, change the permanency plan to something
11 other than to reunify the family.

12 “(c) If the court finds that the department did not provide active efforts
13 to make it possible for the Indian child to return home, except as otherwise
14 required under ORS 419B.470, the court may not set a date for a subsequent
15 permanency hearing until the department has provided active efforts for the
16 number of days that active efforts were not previously provided.

17 “(8) Any final decision of the court made pursuant to the permanency
18 hearing is appealable under ORS 419A.200. On appeal of a final decision of
19 the court under this subsection, the court’s finding, if any, under ORS
20 419B.340 (5) that the department is not required to make reasonable efforts
21 to make it possible for the ward to safely return home is an interlocutory
22 order to which a party may assign error.

23 **“SECTION 76.** ORS 419B.532, as amended by section 51, chapter 14,
24 Oregon Laws 2020 (first special session), is amended to read:

25 “419B.532. (1) As used in this section, ‘former parent’ means a person who
26 was previously the legal parent of a ward and whose parental rights to the
27 ward have been terminated.

28 “(2)(a) In a proceeding under ORS 419B.500, the Department of Human
29 Services or a ward may file a motion to reinstate the parental rights of a
30 former parent if:

1 “(A)(i) The ward has not been adopted; or
2 “(ii) The ward was previously adopted but no longer has a legal parent;
3 “(B) No legal action to achieve the adoption of the ward has been initi-
4 ated under ORS 109.309 or 419B.529;
5 “(C) At least 18 months have passed since entry of the judgment termi-
6 nating the former parent’s parental rights to the ward or, in the event of an
7 appeal, at least six months have passed since issuance of an appellate judg-
8 ment affirming the termination judgment, whichever is later; and
9 “(D) Except as provided in paragraph (b) of this subsection, the ward is
10 at least 12 years of age at the time the motion to reinstate parental rights
11 is filed.
12 “(b) If the ward is under 12 years of age at the time the motion to rein-
13 state parental rights is filed, the court may allow the motion upon a showing
14 of good cause.
15 “(3) A motion to reinstate parental rights under this section must be in
16 writing and state with particularity the factual and legal grounds for the
17 motion.
18 “(4) The moving party shall provide a copy of the motion to reinstate
19 parental rights to the former parent and shall notify the court, the parties
20 and, if there is reason to know[, *as described in section 15, chapter 14, Oregon*
21 *Laws 2020 (first special session),*] that the ward is an Indian child, the tribe
22 that a copy of the motion has been provided.
23 “(5) If a motion to reinstate parental rights does not state a prima facie
24 case as to the facts that must be proved under subsection (6) of this section,
25 the court may deny the motion without a hearing.
26 “(6)(a) If a motion to reinstate parental rights states a prima facie case
27 as to the facts that must be proved under this subsection, the court shall
28 hold a hearing on the merits of the motion. The court shall grant the motion
29 if the moving party proves by clear and convincing evidence that:
30 “(A) The former parent’s conduct and conditions that led to the termi-

1 nation of parental rights have been ameliorated and the former parent is
2 presently fit;

3 “(B) The former parent wishes to have parental rights reinstated;

4 “(C) The ward consents to the reinstatement of parental rights; and

5 “(D) Reinstatement of parental rights is in the ward’s best interests.

6 “(b) In determining whether reinstatement of parental rights is in the
7 ward’s best interests under paragraph (a) of this subsection, the court shall
8 consider:

9 “(A) The ward’s health, safety, permanency, age, maturity and ability to
10 express the ward’s preferences;

11 “(B) The reasons that the former parent’s parental rights were terminated;

12 “(C) The former parent’s stated reasons for wishing to have parental
13 rights reinstated; and

14 “(D) The likely impact on the ward of the former parent’s past abuse or
15 neglect.

16 “(c) The moving party shall provide notice to the former parent of a
17 hearing on the merits under paragraph (a) of this subsection.

18 “(d) The department shall establish by rule procedures for investigating
19 the present fitness of the former parent and for providing appropriate reu-
20 nification services.

21 “(7) If the court grants the motion to reinstate parental rights under
22 subsection (6) of this section:

23 “(a) The court shall enter an order reinstating parental rights that shall
24 restore all parental rights and duties of the former parent as to the ward;

25 “(b) The ward shall continue as a ward of the court for at least six
26 months after entry of the order reinstating parental rights; and

27 “(c) The court shall conduct a permanency hearing as provided in ORS
28 419B.470 within 60 days after entering the order under paragraph (a) of this
29 subsection.

30 “(8) An order reinstating parental rights under this section does not va-

1 cate or otherwise affect the validity of the original judgment terminating the
2 parental rights of the former parent except to the extent that the order
3 reinstates parental rights.

4 “(9) In any proceeding under this section, the ward is entitled to have
5 counsel appointed at state expense if the ward is determined to be financially
6 eligible under the policies, procedures, standards and guidelines of the Public
7 Defense Services Commission.

8 **“SECTION 77.** ORS 419B.878, as amended by section 40, chapter 14,
9 Oregon Laws 2020 (first special session), is amended to read:

10 “419B.878. (1) When a court conducts a hearing, the court shall inquire
11 **and make a finding, [as described in] subject to the procedures under**
12 **section 15 (4), chapter 14, Oregon Laws 2020 (first special session), regard-**
13 **ing** whether a child is an Indian child.

14 “(2) If the court [*knows or has reason to know that an Indian child is in-*
15 *involved*] **enters an order described in section 15 (4)(b), chapter 14, Oregon**
16 **Laws 2020 (first special session), directing that the child be treated as**
17 **an Indian child**, the court shall enter an order requiring the Department
18 of Human Services to comply with the inquiry and notice provisions of
19 sections 15 and 16, chapter 14, Oregon Laws 2020 (first special session)[, *and*
20 *shall enter an order that the child be treated as an Indian child until such*
21 *time as the court determines that the child is not an Indian child*].

22 **“SECTION 78.** ORS 419B.923, as amended by section 60, chapter 14,
23 Oregon Laws 2020 (first special session), is amended to read:

24 “419B.923. (1) Except as otherwise provided in this section, on motion and
25 such notice and hearing as the court may direct, the court may modify or
26 set aside any order or judgment made by it. Reasons for modifying or setting
27 aside an order or judgment include, but are not limited to:

28 “(a) Clerical mistakes in judgments, orders or other parts of the record
29 and errors in the order or judgment arising from oversight or omission.
30 These mistakes and errors may be corrected by the court at any time on its

1 own motion or on the motion of a party and after notice as the court orders
2 to all parties who have appeared. During the pendency of an appeal, an order
3 or judgment may be corrected as provided in subsection (7) of this section.

4 “(b) Excusable neglect.

5 “(c) Newly discovered evidence that by due diligence could not have been
6 discovered in time to present it at the hearing from which the order or
7 judgment issued.

8 “(2) A motion to modify or set aside an order or judgment or request a
9 new hearing must be accompanied by an affidavit that states with reasonable
10 particularity the facts and legal basis for the motion.

11 “(3) A motion to modify or set aside an order or judgment must be made
12 within a reasonable time except no order or judgment pursuant to ORS
13 419B.527 may be set aside or modified during the pendency of a proceeding
14 for the adoption of the ward, nor after a petition for adoption has been
15 granted.

16 “(4) Except as provided in subsection (6) of this section, notice and a
17 hearing as provided in ORS 419B.195, 419B.198, 419B.201, 419B.205, 419B.208,
18 419B.310, 419B.325 and 419B.893 must be provided in any case when the effect
19 of modifying or setting aside the order or judgment will or may be to deprive
20 a parent of the legal custody of the child or ward, to place the child or ward
21 in an institution or agency or to transfer the child or ward from one insti-
22 tution or agency to another. The provisions of this subsection do not apply
23 to a parent whose rights have been terminated under ORS 419B.500 to
24 419B.524 or whose child has been permanently committed by order or judg-
25 ment of the court unless an appeal from the order or judgment is pending.

26 “(5) When *[there is]* **the person giving notice has** reason to know, as
27 described in section 15, chapter 14, Oregon Laws 2020 (first special session),
28 that an Indian child is involved, notice must be provided as required under
29 section 16, chapter 14, Oregon Laws 2020 (first special session).

30 “(6) Except when the child or ward is an Indian child, notice and a

1 hearing are not required when the effect of modifying or setting aside the
2 order or judgment will be to transfer the child or ward from one foster home
3 to another.

4 “(7) A motion under subsection (1) of this section may be filed with and
5 decided by the trial court during the time an appeal from a judgment is
6 pending before an appellate court. The moving party shall serve a copy of
7 the motion on the appellate court. The moving party shall file a copy of the
8 trial court’s order or judgment in the appellate court within seven days of
9 the date of the trial court order or judgment. Any necessary modification of
10 the appeal required by the court order or judgment must be pursuant to rule
11 of the appellate court.

12 “(8) This section does not limit the inherent power of a court to modify

14 set aside an order or judgment for fraud upon the court.

22 Indian **child in a** child custody proceeding, **as defined in section 2, chap-**
23 **ter 14, Oregon Laws 2020 (first special session).**

27 “**SECTION 80.** Section 64, chapter 14, Oregon Laws 2020 (first special
28 session), is amended to read:

29 “**Sec. 64. (1)** If any provision of **section 7, 19, 32, 33 or 39 of this 2021**
30 **Act,** sections 1 to 23, **chapter 14, Oregon Laws 2020 (first special ses-**

1 **sion)**, [*of this 2020 special session Act*] or the amendments to statutes [*by*
2 *sections 24 to 60 of this 2020 special session Act*] **and session law by**
3 **sections 1 to 5, 8 to 17, 20 to 30, 34 to 37 and 40 to 80 of this 2021 Act**
4 is found to [*contravene*] **provide a lower standard of protection to the**
5 **rights of an Indian child or the Indian child’s parent, Indian custodian**
6 **or tribe than** the Indian Child Welfare Act [(25 U.S.C. 1901 et seq.)]:

7 **“(a) The higher standard of protection in the Indian Child Welfare**
8 **Act shall control; and**

9 **“(b) It shall not serve to render inoperative any remaining provisions of**

4 of or of which they were eligible for membership.

5 “(5) The number of Indian children in foster care who are in each of the
6 placement preference categories described in section 23, **chapter 14, Oregon**
7 **Laws 2020 (first special session)**, [*of this 2020 special session Act*] and the
8 number of those placements that have Indian parents in the home.

9 “(6) The number of Indian children placed in adoptive homes in each of
10 the placement preference categories described in section 23, **chapter 14,**
11 **Oregon Laws 2020 (first special session)**, [*of this 2020 special session Act*]
12 and the number of those placements that have Indian parents in the home.

13 “(7) The number of available placements and common barriers to recruit-
14 ment and retention of appropriate placements.

15 “(8) The number of times the court determined that good cause existed to
16 deviate from the statutory placement preferences under section 23, **chapter**
17 **14, Oregon Laws 2020 (first special session)**, **when making a determi-**
18 **nation regarding the placement of a child in a dependency proceeding**
19 [*of this 2020 special session Act*].

20 “(9) The number of cases that were transferred to tribal court under sec-
