**PROPOSED AMENDMENTS TO
HOUSE BILL 3013**

1 In line 2 of the printed bill, after the semicolon delete the rest of the line
2 and insert “creating new provisions; amending ORS 90.396, 323.505, 475B.063,
3 475B.167, 475B.206, 475B.286, 475B.301, 475B.496, 475B.555, 475B.605, 475B.610,
4 475B.615, 475B.620, 475B.625, 475B.635, 475B.766, 475B.778, 475B.791, 475B.810,
5 475B.816, 475B.876, 475B.879, 475B.885, 475B.888, 475B.895, 475B.907, 475B.922,
6 475B.928, 475B.940, 475B.965 and 475B.968; repealing ORS 475B.640, 475B.650,
7 475B.772, 475B.840, 475B.843, 475B.846, 475B.849, 475B.852, 475B.855, 475B.858,
8 475B.861, 475B.864, 475B.867, 475B.870, 475B.873, 475B.898, 475B.901 and
9 475B.904 and section 174, chapter 614, Oregon Laws 2015; and prescribing an
10 effective date.”.

11 Delete lines 4 through 11 and insert:

12 **“SECTION 1. Sections 2 to 6 of this 2021 Act are added to and made**
13 **a part of ORS 475B.010 to 475B.545.**

14 **“SECTION 2. As used in sections 2 to 6 of this 2021 Act:**

15 **“(1) ‘Medical marijuana processing site’ means a location at which**
16 **marijuana is processed for medical use.**

17 **“(2) ‘Medical marijuana dispensary’ means a premises at which**
18 **marijuana for medical use is transferred to registry identification**
19 **cardholders and designated primary caregivers.**

20 **“(3) ‘Process’ means the compounding or conversion of marijuana**
21 **into medical cannabinoid products, cannabinoid concentrates or**

1 cannabinoid extracts.

2 **“SECTION 3. (1) The Oregon Liquor Control Commission shall es-**
3 **tablish by rule a process to register medical marijuana processing**
4 **sites. To hold a registration under this section, an applicant shall:**

5 **“(a) Apply for a registration in the manner prescribed by the com-**
6 **mission by rule;**

7 **“(b) Provide to the commission proof that the applicant is 21 years**
8 **of age or older; and**

9 **“(c) Meet any other requirements established by the commission**
10 **by rule.**

11 **“(2) A person may not process marijuana for medical use without**
12 **a registration issued under this section.**

13 **“(3) A registration issued under this section is valid for one year**
14 **and may be renewed pursuant to rules adopted by the commission.**

15 **“(4)(a) An applicant for registration under this section must be an**
16 **individual.**

17 **“(b) A registration issued under this section may not be transferred:**

18 **“(A) From the individual to whom the registration is issued to an-**
19 **other individual; or**

20 **“(B) To any location other than the original location at which the**
21 **applicant processes marijuana.**

22 **“(5) A medical marijuana processing site may transfer medical**
23 **cannabinoid products, cannabinoid concentrates or cannabinoid ex-**
24 **tracts to:**

25 **“(a) Another medical marijuana processing site or a medical**
26 **marijuana dispensary;**

27 **“(b) A registry identification cardholder, or the designated primary**
28 **caregiver of a registry identification cardholder, if the registry iden-**
29 **tification cardholder or designated primary caregiver provides the**
30 **medical marijuana processing site with the marijuana to be processed**

1 into the medical cannabinoid product, cannabinoid concentrate or
2 cannabinoid extract and the medical marijuana processing site does
3 not receive compensation for the transfer, other than reimbursement
4 for costs associated with the processing; or

5 “(c) Other persons as specified by the commission by rule.

6 “(6) A medical marijuana processing site may receive:

7 “(a) Medical cannabinoid products, cannabinoid concentrates and
8 cannabinoid extracts from another medical marijuana processing site;

9 “(b) Marijuana from a registry identification cardholder or desig-
10 nated primary caregiver of a registry identification cardholder for the
11 purposes described in subsection (5) of this section; and

12 “(c) Medical cannabinoid products, cannabinoid concentrates and
13 cannabinoid extracts from other persons as specified by the commis-
14 sion by rule.

15 “(7)(a) The commission shall establish application, registration and
16 renewal fees under this section.

17 “(b) Fees adopted under this section may not exceed, together with
18 other fees collected under ORS 475B.010 to 475B.545, the cost of ad-
19 ministering ORS 475B.010 to 475B.545.

20 “(c) Moneys from fees collected under this section shall be deposited
21 in the Marijuana Control and Regulation Fund established under ORS
22 475B.296.

23 “(8) The commission may adopt rules as necessary to carry out this
24 section.

25 **“SECTION 4. (1) The Oregon Liquor Control Commission shall es-
26 tablish by rule a process to register medical marijuana dispensaries.
27 To hold a registration under this section, an applicant shall:**

28 “(a) Apply for a registration in the manner prescribed by the com-
29 mission by rule;

30 “(b) Provide to the commission proof that the applicant is 21 years

1 of age or older; and

2 “(c) Meet any other requirements established by the commission
3 by rule.

4 “(2) A person may not provide the services described in subsections
5 (6) and (7) of this section without a registration issued under this
6 section.

7 “(3) A registration issued under this section is valid for one year
8 and may be renewed pursuant to rules adopted by the commission.

9 “(4)(a) An applicant for registration under this section must be an
10 individual.

11 “(b) A registration issued under this section may not be transferred:

12 “(A) From the individual to whom the registration is issued to an-
13 other individual; or

14 “(B) To any location other than the original location at which the
15 applicant transfers usable marijuana, immature marijuana plants,
16 seeds, medical cannabinoid products, cannabinoid concentrates and
17 cannabinoid extracts.

18 “(5)(a) Except as provided in paragraph (b) of this subsection, a
19 medical marijuana dispensary may not be located within 1,000 feet of:

20 “(A) A public elementary or secondary school for which attendance
21 is compulsory under ORS 339.020; or

22 “(B) A private or parochial elementary or secondary school, teach-
23 ing children as described in ORS 339.030 (1)(a).

24 “(b) A medical marijuana dispensary may be located within 1,000
25 feet of a school if:

26 “(A) The medical marijuana dispensary is not located within 500 feet
27 of a public elementary or secondary school or a private or parochial
28 elementary or secondary school described in paragraph (a) of this
29 subsection; and

30 “(B) The commission determines that there is a physical or ge-

1 **ographic barrier capable of preventing children from traversing to the**
2 **premises of the medical marijuana dispensary.**

3 **“(6) A medical marijuana dispensary may transfer usable**
4 **marijuana, immature marijuana plants, seeds, medical cannabinoid**
5 **products, cannabinoid concentrates and cannabinoid extracts to:**

6 **“(a) Another medical marijuana dispensary;**

7 **“(b) A registry identification cardholder or the designated primary**
8 **caregiver of a registry identification cardholder; or**

9 **“(c) Other persons as specified by the commission by rule.**

10 **“(7) A medical marijuana dispensary may receive:**

11 **“(a) Usable marijuana, immature marijuana plants and seeds from**
12 **registry identification cardholders and persons responsible for**
13 **marijuana grow sites, as defined in ORS 475B.791;**

14 **“(b) Medical cannabinoid products, cannabinoid concentrates and**
15 **cannabinoid extracts from medical marijuana processing sites regis-**
16 **tered under section 3 of this 2021 Act; and**

17 **“(c) Usable marijuana, immature marijuana plants, seeds, medical**
18 **cannabinoid products, cannabinoid concentrates and cannabinoid ex-**
19 **tracts from other persons as specified by the commission by rule.**

20 **“(8)(a) The commission shall establish application, registration and**
21 **renewal fees under this section.**

22 **“(b) Fees adopted under this section may not exceed, together with**
23 **other fees collected under ORS 475B.010 to 475B.545, the cost of ad-**
24 **ministering ORS 475B.010 to 475B.545.**

25 **“(c) Moneys from fees collected under this section shall be deposited**
26 **in the Marijuana Control and Regulation Fund established under ORS**
27 **475B.296.**

28 **“(9) The commission may adopt rules as necessary to carry out this**
29 **section.**

30 **“SECTION 5. (1) The Oregon Liquor Control Commission shall:**

1 “(a) Ensure that the system developed and maintained under ORS
2 475B.177 is capable of tracking the transfer of marijuana items pro-
3 cessed at a medical marijuana processing site registered under section
4 3 of this 2021 Act and marijuana items transferred from a medical
5 marijuana dispensary registered under section 4 of this 2021 Act.

6 “(b) Treat information related to medical marijuana processing
7 sites registered under section 3 of this 2021 Act and medical marijuana
8 dispensaries registered under section 4 of this 2021 Act in the same
9 manner as the information described in ORS 475B.541.

10 “(2) The commission may suspend, revoke or refuse to issue a reg-
11 istration under section 3 or 4 of this 2021 Act or require a registrant
12 or representative of a registrant to complete training specified by the
13 commission if the commission finds, or has reasonable grounds to be-
14 lieve, that the registrant or representative of the registrant:

15 “(a) Has violated a provision of ORS 475B.010 to 475B.545 or a rule
16 adopted under ORS 475B.010 to 475B.545;

17 “(b) Has made any false representation or statement to the com-
18 mission in order to induce or prevent action by the commission;

19 “(c) Is insolvent or incompetent or physically unable to carry on the
20 management of the medical marijuana processing site or medical
21 marijuana dispensary;

22 “(d) Is in the habit of using alcoholic liquor, habit-forming drugs,
23 marijuana or controlled substances to excess;

24 “(e) Has misrepresented to a registry identification cardholder, a
25 consumer or the public any marijuana items transferred by the regis-
26 trant or representative of the registrant; or

27 “(f) Since the issuance of a registration under section 3 or 4 of this
28 2021 Act, has been convicted of a felony, a violation of any marijuana
29 laws of this state or ordinances of a local government in this state or
30 a misdemeanor if the felony, violation or misdemeanor was committed

1 on the premises for which the registration was issued.

2 “(3) The commission may adopt rules as necessary to carry out this
3 section.

4 **“SECTION 6. (1) In addition to any other penalty provided by law,**
5 **the Oregon Liquor Control Commission may impose, for each violation**
6 **of ORS 475B.010 to 475B.545 or of a rule adopted under ORS 475B.010**
7 **to 475B.545, by a medical marijuana processing site or medical**
8 **marijuana dispensary, a civil penalty that does not exceed \$500 for**
9 **each day that the violation occurs.**

10 “(2) The commission shall impose civil penalties under this section
11 in the manner provided in ORS 183.745.

12 “(3) All moneys collected pursuant to this section shall be deposited
13 into the Marijuana Control and Regulation Fund established under
14 ORS 475B.296.

15 **“SECTION 7. ORS 90.396 is amended to read:**

16 “90.396. (1) Except as provided in subsection (2) of this section, after at
17 least 24 hours’ written notice specifying the acts and omissions constituting
18 the cause and specifying the date and time of the termination, the landlord
19 may terminate the rental agreement and take possession as provided in ORS
20 105.105 to 105.168, if:

21 “(a) The tenant, someone in the tenant’s control or the tenant’s pet seri-
22 ously threatens to inflict substantial personal injury, or inflicts any sub-
23 stantial personal injury, upon a person on the premises other than the
24 tenant;

25 “(b) The tenant or someone in the tenant’s control recklessly endangers
26 a person on the premises other than the tenant by creating a serious risk
27 of substantial personal injury;

28 “(c) The tenant, someone in the tenant’s control or the tenant’s pet in-
29 flicts any substantial personal injury upon a neighbor living in the immedi-
30 ate vicinity of the premises;

1 “(d) The tenant or someone in the tenant’s control intentionally inflicts
2 any substantial damage to the premises or the tenant’s pet inflicts substan-
3 tial damage to the premises on more than one occasion;

4 “(e)(A) The tenant intentionally provided substantial false information on
5 the application for the tenancy within the past year;

6 “(B) The false information was with regard to a criminal conviction of
7 the tenant that would have been material to the landlord’s acceptance of the
8 application; and

9 “(C) The landlord terminates the rental agreement within 30 days after
10 discovering the falsity of the information; or

11 “(f) The tenant, someone in the tenant’s control or the tenant’s pet com-
12 mits any act that is outrageous in the extreme, on the premises or in the
13 immediate vicinity of the premises. For purposes of this paragraph, an act
14 is outrageous in the extreme if the act is not described in paragraphs (a) to
15 (e) of this subsection, but is similar in degree and is one that a reasonable
16 person in that community would consider to be so offensive as to warrant
17 termination of the tenancy within 24 hours, considering the seriousness of
18 the act or the risk to others. An act that is outrageous in the extreme is
19 more extreme or serious than an act that warrants a 30-day termination un-
20 der ORS 90.392. Acts that are ‘outrageous in the extreme’ include, but are
21 not limited to, the following acts by a person:

22 “(A) Prostitution, commercial sexual solicitation or promoting
23 prostitution, as described in ORS 167.007, 167.008 and 167.012;

24 “(B) Unlawful manufacture, delivery or possession of a controlled sub-
25 stance, as defined in ORS 475.005;

26 “(C) Manufacture of a cannabinoid extract, as defined in ORS 475B.015,
27 unless the person manufacturing the cannabinoid extract holds a license is-
28 sued under ORS 475B.090 or is registered under [*ORS 475B.840*] **section 3**
29 **of this 2021 Act**;

30 “(D) A bias crime, as described in ORS 166.155 and 166.165; or

1 “(E) Burglary as described in ORS 164.215 and 164.225.

2 “(2) If the cause for a termination notice given pursuant to subsection (1)
3 of this section is based upon the acts of the tenant’s pet, the tenant may cure
4 the cause and avoid termination of the tenancy by removing the pet from the
5 premises prior to the end of the notice period. The notice must describe the
6 right of the tenant to cure the cause. If the tenant returns the pet to the
7 premises at any time after having cured the violation, the landlord, after at
8 least 24 hours’ written notice specifying the subsequent presence of the of-
9 fending pet, may terminate the rental agreement and take possession as
10 provided in ORS 105.105 to 105.168. The tenant does not have a right to cure
11 this subsequent violation.

12 “(3) For purposes of subsection (1) of this section, someone is in the
13 tenant’s control if that person enters or remains on the premises with the
14 tenant’s permission or consent after the tenant reasonably knows or should
15 know of that person’s act or likelihood to commit any act of the type de-
16 scribed in subsection (1) of this section.

17 “(4) An act can be proven to be outrageous in the extreme even if the act
18 is one that does not violate a criminal statute. Notwithstanding the refer-
19 ences to criminal statutes in subsection (1)(f) of this section, the landlord’s
20 burden of proof in an action for possession under subsection (1) of this sec-
21 tion is the civil standard of proof by a preponderance of the evidence.

22 “(5) If a good faith effort by a landlord to terminate the tenancy under
23 subsection (1)(f) of this section and to recover possession of the rental unit
24 under ORS 105.105 to 105.168 fails by decision of the court, the landlord may
25 not be found in violation of any state statute or local ordinance requiring
26 the landlord to remove that tenant upon threat of fine, abatement or forfei-
27 ture as long as the landlord continues to make a good faith effort to termi-
28 nate the tenancy.

29 **“SECTION 8.** ORS 323.505, as amended by section 12, chapter 525, Oregon
30 Laws 2019, is amended to read:

1 “323.505. (1) A tax is hereby imposed upon the distribution of all tobacco
2 products in this state. The tax imposed by this section is intended to be a
3 direct tax on the consumer, for which payment upon distribution is required
4 to achieve convenience and facility in the collection and administration of
5 the tax. The tax shall be imposed on a distributor at the time the distributor
6 distributes tobacco products.

7 “(2) The tax imposed under this section shall be imposed at the rate of:

8 “(a) Sixty-five percent of the wholesale sales price of cigars, but not to
9 exceed one dollar per cigar;

10 “(b) One dollar and seventy-eight cents per ounce based on the net weight
11 determined by the manufacturer, in the case of moist snuff, except that the
12 minimum tax under this paragraph is \$2.14 per retail container; or

13 “(c) Sixty-five percent of the wholesale sales price of all tobacco products
14 that are not cigars or moist snuff.

15 “(3) For reporting periods beginning on or after July 1, 2022, the rates
16 of tax applicable to moist snuff under subsection (2)(b) of this section shall
17 be adjusted for each biennium according to the cost-of-living adjustment for
18 the calendar year. The Department of Revenue shall recompute the rates for
19 each biennium by adding to the rates in subsection (2)(b) of this section the
20 product obtained by multiplying the rates in subsection (2)(b) of this section
21 by a factor that is equal to 0.25 multiplied by the percentage (if any) by
22 which the monthly averaged U.S. City Average Consumer Price Index for the
23 12 consecutive months ending August 31 of the prior calendar year exceeds
24 the monthly averaged U.S. City Average Consumer Price Index for the 12
25 consecutive months ending August 31, 2020.

26 “(4) If the tax imposed under this section does not equal an amount cal-
27 culable to a whole cent, the tax shall be equal to the next higher whole cent.
28 However, the amount remitted to the Department of Revenue by the taxpayer
29 for each quarter shall be equal only to 98.5 percent of the total taxes due
30 and payable by the taxpayer for the quarter.

1 “(5) A tax under this section is not imposed on inhalant delivery systems
2 that are:

3 “(a) Marketed and sold solely for the purpose of vaporizing or
4 aerosolizing marijuana items as defined in ORS 475B.015; or

5 “(b) Purchased in a medical marijuana dispensary that is registered under
6 [ORS 475B.858] **section 4 of this 2021 Act** by a person to whom a registry
7 identification card has been issued under ORS 475B.797.

8 “(6) No tobacco product shall be subject to the tax if the base product
9 or other intermediate form thereof has previously been taxed under this
10 section.

11 **“SECTION 9.** ORS 475B.063 is amended to read:

12 “475B.063. (1) Prior to receiving a license under ORS 475B.070, 475B.090,
13 475B.100 or 475B.105, an applicant shall request a land use compatibility
14 statement from the city or county that authorizes the land use. The land use
15 compatibility statement must demonstrate that the requested license is for
16 a land use that is allowable as a permitted or conditional use within the
17 given zoning designation where the land is located. The Oregon Liquor
18 Control Commission may not issue a license if the land use compatibility
19 statement shows that the proposed land use is prohibited in the applicable
20 zone.

21 “(2) Except as provided in subsection (3) of this section, a city or county
22 that receives a request for a land use compatibility statement under this
23 section must act on that request within 21 days of:

24 “(a) Receipt of the request, if the land use is allowable as an outright
25 permitted use; or

26 “(b) Final local permit approval, if the land use is allowable as a condi-
27 tional use.

28 “(3) A city or county that receives a request for a land use compatibility
29 statement under this section is not required to act on that request during
30 the period that the commission discontinues licensing those premises pursu-

1 ant to ORS 475B.968 (4)(b)].

2 “(4) A city or county action concerning a land use compatibility state-
3 ment under this section is not a land use decision for purposes of ORS
4 chapter 195, 196, 197, 215 or 227.

5 **“SECTION 10.** ORS 475B.167 is amended to read:

6 “475B.167. (1) The Oregon Liquor Control Commission shall adopt by rule
7 procedures by which[:]

8 “[a)] a person responsible for a marijuana grow site registered under ORS
9 475B.810, or, if multiple persons responsible for a marijuana grow site reg-
10 istered under ORS 475B.810 are located at the same address, each person
11 responsible for a marijuana grow site located at the address, may apply for
12 a license under ORS 475B.070 to transition from being registered by the
13 Oregon Health Authority to being licensed by the commission[;]

14 “[b) *A marijuana processing site registered under ORS 475B.840 may ap-
15 ply for a license under ORS 475B.090 to transition from being registered by
16 the authority to being licensed by the commission; and]*

17 “[c) *A medical marijuana dispensary registered under ORS 475B.858 may
18 apply for a license under ORS 475B.105 to transition from being registered by
19 the authority to being licensed by the commission].*

20 “(2)(a) In adopting rules under this section, the commission shall adopt,
21 at a minimum, procedures by which the inventory possessed by a person re-
22 sponsible for a marijuana grow site[, *a marijuana processing site or a medical
23 marijuana dispensary]* on the date on which the person responsible for a
24 marijuana grow site[, *the marijuana processing site or the medical marijuana
25 dispensary]* is first subject to tracking by the commission under ORS
26 475B.177:

27 “(A) May be delivered to a premises for which a license has been issued
28 under ORS 475B.090, 475B.100 or 475B.105; or

29 “(B) May be sold to consumers by marijuana retailers that hold a license
30 under ORS 475B.105.

1 “(b) Procedures adopted under this subsection must require a person re-
2 sponsible for a marijuana grow site registered under ORS 475B.810, or, if
3 multiple persons responsible for a marijuana grow site registered under ORS
4 475B.810 are located at the same address, each person responsible for a
5 marijuana grow site located at the address, to return to an individual to
6 whom a registry identification card has been issued under ORS 475B.797, and
7 for whom the person or persons are producing marijuana, all the marijuana
8 and usable marijuana owned by the individual, except as otherwise allowed
9 under a personal agreement entered into under ORS 475B.822, at the time
10 that the person or the persons receive a license under ORS 475B.070.

11 **“SECTION 11.** ORS 475B.206 is amended to read:

12 “475B.206. (1) Except as provided in ORS 475B.136 [*and 475B.873*], a
13 marijuana producer that holds a license issued under ORS 475B.070,
14 marijuana processor that holds a license issued under ORS 475B.090 or
15 marijuana wholesaler that holds a license issued under ORS 475B.100 may
16 deliver marijuana items only to or on a premises for which a license has been
17 issued under ORS 475B.070, 475B.090, 475B.100 or 475B.105, or to a registry
18 identification cardholder or designated primary caregiver as allowed under
19 ORS 475B.010 to 475B.545.

20 “(2) A licensee to which marijuana items may be delivered under sub-
21 section (1) of this section may receive marijuana items only from:

22 “(a) A marijuana producer that holds a license issued under ORS
23 475B.070, marijuana processor that holds a license issued under ORS
24 475B.090, marijuana wholesaler that holds a license issued under ORS
25 475B.100, marijuana retailer that holds a license issued under ORS 475B.105
26 or a laboratory licensed under ORS 475B.560;

27 “(b) A researcher of cannabis that holds a certificate issued under ORS
28 475B.286 and that transfers limited amounts of marijuana, usable marijuana,
29 cannabinoid products, cannabinoid concentrates and cannabinoid extracts in
30 accordance with procedures adopted under ORS 475B.286 (3)(d) and (e);

1 “(c) A marijuana grow site registered under ORS 475B.810, [*marijuana*
2 *processing site registered under ORS 475B.840, or a medical marijuana*
3 *dispensary registered under ORS 475B.858,*] acting in accordance with pro-
4 cedures adopted by the Oregon Liquor Control Commission under ORS
5 475B.167; [*or*]

6 “(d) A marijuana grow site registered under ORS 475B.810, acting in ac-
7 cordance with ORS 475B.825 and any procedures adopted by rule by the
8 commission; **or**

9 “**(e) A medical marijuana processing site registered under section 3**
10 **of this 2021 Act or a medical marijuana dispensary registered under**
11 **section 4 of this 2021 Act.**

12 “(3) The sale of marijuana items by a marijuana retailer that holds a li-
13 cense issued under ORS 475B.105 must be restricted to the premises for
14 which the license has been issued, but deliveries may be made by a
15 marijuana retailer to consumers pursuant to a bona fide order received at
16 the premises prior to delivery.

17 “(4) The commission may by order waive the requirements of subsections
18 (1) and (2) of this section to ensure compliance with ORS 475B.010 to
19 475B.545 or a rule adopted under ORS 475B.010 to 475B.545. An order issued
20 under this subsection does not constitute a waiver of any other requirement
21 of ORS 475B.010 to 475B.545 or any other rule adopted under ORS 475B.010
22 to 475B.545.

23 “**SECTION 12.** ORS 475B.286 is amended to read:

24 “475B.286. (1) The Oregon Liquor Control Commission, in consultation
25 with the Oregon Health Authority and the State Department of Agriculture,
26 shall establish a program for the purpose of identifying and certifying pri-
27 vate and public researchers of cannabis.

28 “(2)(a) The authority shall assist the commission in identifying candidates
29 for certification under this section with respect to potential medical re-
30 search.

1 “(b) The department shall assist the commission in identifying candidates
2 for certification under this section with respect to potential agricultural re-
3 search.

4 “(3) Subject to subsection (4) of this section, the commission shall adopt
5 by rule or order:

6 “(a) Qualifications for certification under this section;

7 “(b) The term of a certificate issued under this section;

8 “(c) Processes for applying for, receiving and renewing a certificate under
9 this section;

10 “(d) Procedures for tracking marijuana, usable marijuana, cannabinoid
11 products, cannabinoid concentrates and cannabinoid extracts received by and
12 disposed or otherwise made use of by a person that holds a certificate issued
13 under this section; and
