**PROPOSED AMENDMENTS TO
SENATE BILL 732**

1 On page 1 of the printed bill, delete lines 6 through 31.

2 On page 2, delete lines 1 through 15 and insert:

3 **“SECTION 2. (1) Nothing in this section shall interfere with the**
4 **duties, responsibilities and rights of duly elected school district boards.**
5 **There shall be established at each school district an educational equity**
6 **advisory committee.**

7 **“(2) The duties of an educational equity advisory committee shall**
8 **include:**

9 **“(a) Advising the school district board about the educational equity**
10 **impacts of policy decisions;**

11 **“(b) Advising the school district superintendent about the educa-**
12 **tional equity impacts of policy decisions; and**

13 **“(c) Informing the school district board and school district super-**
14 **intendent when a situation arises in a school of the school district that**
15 **negatively impacts underrepresented students and advising the board**
16 **and superintendent on how best to handle that situation.**

17 **“(3) The educational equity advisory committee may prepare an**
18 **annual report that:**

19 **“(a) Contains the following information:**

20 **“(A) The successes and challenges the school district has experi-**
21 **enced in meeting the educational equity needs of students in the**

1 school district;

2 “(B) Recommendations the committee made to the school district
3 board and school district superintendent, and the actions that were
4 taken in response to those recommendations; and

5 “(C) Any other information required by the State Board of Educa-
6 tion by rule.

7 “(b) Is made available by being:

8 “(A) Distributed to the parents of the students of the school dis-
9 trict;

10 “(B) Posted on the school district’s website;

11 “(C) Presented to the school district board in an open meeting with
12 adequate opportunity for public comment; and

13 “(D) Sent to the State Board of Education.

14 “(4)(a) An educational equity advisory committee shall be selected
15 by the school district superintendent and must be composed of par-
16 ents, employees, students and community members from the school
17 district.

18 “(b) For the purpose of selecting members, the school district su-
19 perintendent:

20 “(A) Shall solicit names of possible members from the community;

21 “(B) Must ensure that membership is primarily representative of
22 underserved student groups;

23 “(C) May not exclude members based on immigration status; and

24 “(D) Must comply with any other requirements established by the
25 State Board of Education by rule.

26 “(5) The State Board of Education shall adopt any rules necessary
27 for the administration of this section.”.

28 On page 3, delete lines 41 through 43 and insert:

29 “(2) In addition to the requirements prescribed by ORS 294.305 to 294.565,
30 a school district must include at least one member of the educational equity

1 advisory committee of the school district on the budget committee.”.

2 After line 43, insert:

3 **“SECTION 6. Notwithstanding ORS 328.542, as amended by section**
4 **5 of this 2021 Act, a budget committee is not required to include a**
5 **member of the educational equity advisory committee of the school**
6 **district until a vacancy on the budget committee occurs by a member**
7 **who is not also a member of the school district board.”.**

8 In line 44, delete “6” and insert “7”.
