**PROPOSED AMENDMENTS TO
SENATE BILL 232**

1 In line 2 of the printed bill, after the semicolon insert “amending ORS
2 342.448;”.

3 Delete lines 4 through 12 and insert:

4 **“SECTION 1.** ORS 342.448 is amended to read:

5 “342.448. (1) Representatives of the [*Education and Workforce Policy Ad-*
6 *visor*] **Educator Advancement Council**, the Higher Education Coordinating
7 Commission, the Department of Education and the Teacher Standards and
8 Practices Commission shall jointly create a report on the Educators Equity
9 Act. The report shall **be created in consultation with educator prepara-**
10 **tion providers and shall** include:

11 “(a) A summary of the most recent data collected as provided by ORS
12 342.443 (1)(d) to (h).

13 “(b) A summary of the plans currently implemented as provided by ORS
14 342.447.

15 “(c) [*Recommendations for meeting*] **A review of** the goal described in
16 ORS 342.437, including:

17 **“(A) Determination of the need for additional related state goals.**

18 **“(B) Progress made by the state** toward meeting the goal described in
19 ORS 342.437 **and any other additional related state goals.**

20 **“(C) Recommendations and a long-term plan for meeting the goal**
21 **described in ORS 342.437 and any other additional related state goals.**

1 “(d) A description of best practices within this state and other states for
2 recruiting, hiring and retaining diverse educators.

3 “(e) **Recommendations for legislation to help the state meet the**
4 **goal described in ORS 342.437 and any other additional related state**
5 **goals.**

6 “(2)(a) The report created as provided by subsection (1) of this section
7 shall be submitted:

8 “(A) To the interim legislative committees on education [*in each even-*
9 *numbered*] **by September 1 of each even-numbered** year; and

10 “(B) To the Legislative Assembly in the manner provided by ORS 192.245
11 [*in each odd-numbered*] **by September 1 of each even-numbered** year.

12 “(b) The report submitted as required by paragraph (a)(B) of this sub-
13 section shall be submitted with the data reported as required by ORS 342.443
14 **(1)(d) to (h).**

15 “(3) The [*Education and Workforce Policy Advisor*] **Educator Advance-**
16 **ment Council**, the Higher Education Coordinating Commission, the De-
17 partment of Education and the Teacher Standards and Practices Commission
18 shall make the report submitted as provided under subsection (2) of this
19 section available on the website of each agency.

20 “**SECTION 2. This 2021 Act being necessary for the immediate**
21 **preservation of the public peace, health and safety, an emergency is**
22 **declared to exist, and this 2021 Act takes effect on its passage.”.**
