**PROPOSED AMENDMENTS TO  
SENATE BILL 731**

1 On page 1 of the printed bill, delete lines 4 through 31 and delete pages  
2 2 and 3 and insert:

3 **“SECTION 1.** ORS 181A.685 is amended to read:

4 “181A.685. (1) A tribal police officer is eligible to act as an authorized  
5 tribal police officer if the officer:

6 “[1] (a) Is acting within the scope of employment as a tribal police of-  
7 ficer;

8 “[2] (b) Is certified as a police officer under the provisions of ORS  
9 181A.355 to 181A.670[.];

10 “[3] (c) Is in compliance with any rules adopted by the Department of  
11 Public Safety Standards and Training under ORS 181A.680 to 181A.692; and

12 “[4] (d) Is employed by a tribal government that:

13 “[a] *Is in compliance with the requirements of ORS 181A.355 to 181A.670*  
14 *applicable to a law enforcement unit as defined in ORS 181A.355;*]

15 “[b] (A) Is in compliance with ORS 181A.680 to 181A.692 and any rules  
16 adopted by the department under ORS 181A.680 to 181A.692;

17 “[c] (B) Has submitted to the department the resolution and documents  
18 described in ORS 181A.690;

19 “[d] (C) Has adopted a provision of tribal law:

20 “[A] (i) That requires the tribal government to participate in, and be  
21 bound by, a deadly physical force plan approved under ORS 181A.775 to

1 181A.805, to the same extent that the county sheriff is required to participate  
2 in, and be bound by, the plan;

3 “[*B*] (ii) That requires the tribal government to retain records related  
4 to the exercise of the authority granted to authorized tribal police officers  
5 under ORS 181A.680 to 181A.692 in a manner substantially similar to the  
6 manner in which the provisions of ORS 192.005 to 192.170 require the De-  
7 partment of State Police to retain public records;

8 “[*C*] (iii) That provides members of the public with the right to inspect  
9 records of the tribal government related to the exercise of the authority  
10 granted to authorized tribal police officers under ORS 181A.680 to 181A.692  
11 in a manner substantially similar to the manner in which the provisions of  
12 ORS 192.311 to 192.478 provide members of the public with the right to in-  
13 spect public records of the Department of State Police;

14 “[*D*] (iv) That requires the tribal government to preserve biological ev-  
15 idence in a manner substantially similar to ORS 133.705 to 133.717 when the  
16 biological evidence:

17 “[*i*] (I) Is collected as part of a criminal investigation, conducted by an  
18 authorized tribal police officer, into a covered offense as defined in ORS  
19 133.705; or

20 “[*ii*] (II) Is otherwise in the possession of the tribal government and  
21 reasonably may be used to incriminate or exculpate any person for a covered  
22 offense as defined in ORS 133.705; and

23 “[*E*] (v) That waives sovereign immunity, in a manner similar to the  
24 waiver expressed in ORS 30.260 to 30.300, as to tort claims asserted in the  
25 tribal government’s court that arise from the conduct of an authorized tribal  
26 police officer. The waiver described in this [*subparagraph*] **sub-**  
27 **subparagraph**:

28 “[*i*] (I) Must apply to the conduct of an authorized tribal police officer  
29 that occurs while the provision of tribal law is in effect;

30 “[*ii*] (II) Must allow for recovery against the tribal government in an

1 amount equal to or greater than the amounts described in ORS 30.260 to  
2 30.300 that are applicable to a local public body;

3 “[*iii*] **(III)** May require that the claim be asserted in accordance with  
4 any applicable tort claims procedures of the tribal government; and

5 “[*iv*] **(IV)** May exclude claims that could be brought in federal court  
6 under the Federal Tort Claims Act; [*and*]

7 **“(D) When an authorized tribal officer separates from employment**  
8 **with the tribal government, provides the department with notification**  
9 **of the dates of hire and separation and the reason for separation from**  
10 **employment;**

11 **“(E) Follows the rules and regulations of the department related to**  
12 **age, background checks, psychological examinations and physical, in-**  
13 **tellectual, emotional and moral fitness requirements adopted under**  
14 **ORS 181A.410 for all authorized tribal officers;**

15 “[*e*] **(F)** Has adopted or is exempt from adopting, in accordance with this  
16 paragraph, a written pretrial discovery policy that describes how a tribal  
17 government and its authorized tribal police officers will assist the district  
18 attorney, in criminal prosecutions conducted in state court in which an au-  
19 thorized tribal police officer arrested or cited the defendant, in meeting the  
20 pretrial discovery obligations imposed on the state by ORS 135.805 to 135.873.  
21 The process for adopting, and determining whether a tribal government is  
22 exempt from adopting, a written pretrial discovery policy is as follows:

23 “[*A*] **(i)** A tribal government may request in writing that the sheriff of  
24 a county with land that is contiguous to the land of the tribal government  
25 provide the tribal government with a copy of any written pretrial discovery  
26 policy adopted by the sheriff that describes how the sheriff’s office assists  
27 the district attorney in meeting the pretrial discovery obligations imposed  
28 by ORS 135.805 to 135.873. Not later than 30 days after receiving the request,  
29 the sheriff shall provide the tribal government with a copy of the policy or  
30 notify the tribal government that the sheriff has not adopted the policy.

1 “[B] (ii) If a tribal government fails to submit a written request to each  
2 sheriff of a county that is contiguous to the land of the tribal government  
3 or if each sheriff has adopted a written pretrial discovery policy described  
4 in [subparagraph (A) of this paragraph] **sub-subparagraph (i) of this sub-**  
5 **paragraph**, the tribal government shall, not later than 90 days after July  
6 22, 2011, adopt a written pretrial discovery policy.

7 “[C] (iii) A tribal government may create and adopt a written pretrial  
8 discovery policy or may adopt the written pretrial discovery policy adopted  
9 by the sheriff of a county with land that is contiguous to the land of the  
10 tribal government.

11 “[D] (iv) If the sheriff of any county with land that is contiguous to the  
12 land of the tribal government has not, on the date the sheriff receives a re-  
13 quest described in [subparagraph (A) of this paragraph] **sub-subparagraph**  
14 **(i) of this subparagraph**, adopted a written pretrial discovery policy, the  
15 tribal government is exempt from adopting a written pretrial discovery pol-  
16 icy.

17 **“(2) This section does not regulate the conduct or activities of tribal**  
18 **police officers or tribal governments occurring in Indian country or**  
19 **on the land of a tribal government or outside of Indian country or the**  
20 **land of a tribal government but within a tribe’s civil or criminal ju-**  
21 **risdiction.**

22 **“SECTION 2.** ORS 181A.775 is amended to read:

23 “181A.775. As used in ORS 181A.775 to 181A.805:

24 “(1) ‘Employ,’ when used in the context of the relationship between a law  
25 enforcement agency and a police officer, includes the assignment of law  
26 enforcement duties on a volunteer basis to a reserve officer.

27 “(2) ‘Law enforcement agency’ means the Department of State Police, the  
28 Department of Justice, a district attorney, a political subdivision of the State  
29 of Oregon, a municipal corporation of the State of Oregon, a tribal govern-  
30 ment and a university, that maintains a law enforcement unit as defined in

1 ORS 181A.355 (12)(a)(A).

2 “(3) ‘Police officer’ means a person who is:

3 “(a) A police officer or reserve officer as defined in ORS 181A.355; and

4 “(b) Employed by a law enforcement agency to enforce the criminal laws  
5 of this state.

6 “(4) ‘Tribal government’ means a tribal government as defined in ORS  
7 181A.680:

8 “(a) With land that is contiguous to the county in which the deadly  
9 physical force planning authority is created; and

10 “(b) That has adopted the provision of tribal law described in ORS  
11 181A.685 [~~(4)(d)(A)~~] **(1)(d)(C)(i)**.”.
