## PROPOSED AMENDMENTS TO HOUSE BILL 3352

1 On page 1 of the printed bill, line 2, delete "and".

2 In line 3, after "414.578" insert "; and prescribing an effective date".

3 Delete lines 5 through 30 and delete pages 2 through 8 and insert:

4 **"SECTION 1.** ORS 414.231 is amended to read:

5 "414.231. (1) As used in this section[,]:

6 "(a) 'Adult' means a person 19 years of age or older.

7 "(b) 'Child' means a person under 19 years of age.

8 "(2) The [*Health Care for All Oregon Children*] **Cover All People** program 9 is established to make affordable, accessible health care available to all [*of* 10 *Oregon's children*] **residents in this state**. The program provides medical 11 assistance [*to children*], funded in whole or in part by Title XIX of the Social 12 Security Act, by the State Children's Health Insurance Program under Title 13 XXI of the Social Security Act [*and*] **or** by moneys appropriated or allocated 14 for that purpose by the Legislative Assembly.

"(3) A child is eligible for medical assistance under subsection (2) of this
section if the child resides in this state and the income of the child's family
is at or below 300 percent of the federal poverty guidelines.

"(4) An adult is eligible for medical assistance under subsection (2)
 of this section if the adult resides in this state and would be eligible
 for medical assistance but for the adult's immigration status.

[(4)] (5) There is no asset limit to qualify for the program.

"(5)(a)] (6)(a) A child receiving medical assistance through the [Health 1 Care for All Oregon Children] Cover All People program is continuously  $\mathbf{2}$ eligible for a minimum period of 12 months or until the child reaches 19 3 years of age, whichever comes first. 4

"(b) The Department of Human Services or the Oregon Health Authority  $\mathbf{5}$ shall reenroll a child for successive 12-month periods of enrollment as long 6 as the child is eligible for medical assistance on the date of reenrollment and 7 the child has not yet reached 19 years of age. 8

"(c) A child may not be required to submit a new application as a condi-9 tion of reenrollment under paragraph (b) of this subsection. 10

"(6)] (7) The department or the authority must determine [the child's] 11 eligibility for or reenrollment in medical assistance **under this section** us-12 ing information and sources available to the department or the authority. If 13information and sources available to the department or the authority are not 14 adequate to verify [the child's] eligibility, the department or the authority 15may require the [child] adult or [the] a child's caretaker to provide addi-16 tional documentation in accordance with ORS 411.400 and 411.402. Informa-17 tion requested or obtained by the department or the authority under this 18 subsection is subject to the requirements of ORS 410.150 and 413.175. 19

"SECTION 2. ORS 413.201 is amended to read:

"413.201. (1) The Oregon Health Authority is responsible for statewide 21outreach, [and marketing of] education and engagement for the [Health 22Care for All Oregon Children] Cover All People program established in ORS 23414.231 and administered by the authority with the goal of enrolling in the 24program all eligible [children] individuals residing in this state. The au-25thority, in collaboration with the work group described in subsection (3) of 26this section, shall evaluate and implement the outreach, [and marketing] 27education and engagement strategies designed to most effectively encour-28age [the] enrollment [of children] in the program. 29

"(2) To maximize the enrollment and retention of eligible [children] in-30

**dividuals** in the [*Health Care for All Oregon Children*] **Cover All People** program, the authority shall develop and administer a grant program to provide funding to organizations and community based groups to deliver culturally specific and targeted outreach, [*and direct*] application assistance **and navigation** to:

6 "(a) Members of racial, ethnic and language minority communities;

7 "(b) Children and families living in geographic isolation; and

5 of this 2021 Act on and after March 31, 2022.
