(1) Section 1 of this 2021 Act and the amendments to ORS 137.635, 137.690, 137.700, 137.707, 137.717, 138.105, 138.115, 144.110, 161.620, 163.107, 163.115, 163.155, 420.240, 421.121, 421.168 and 475.930 by sections 2 to 10 and 12 to 18 of this 2021 Act apply to sentences imposed on or after the effective date of this 2021 Act, including resentencings under section 11 of this 2021 Act or any other law.

"(2) Section 11 of this 2021 Act applies to persons serving sentences imposed before, on or after the effective date of this 2021 Act.

"SECTION 20. The unit captions used in this 2021 Act are provided only for the convenience of the reader and do not become part of the statutory law of this state or express any legislative intent in the enactment of this 2021 Act.

#### **"EFFECTIVE DATE"**

"SECTION 21. This 2021 Act takes effect on the 91st day after the date on which the 2021 regular session of the Eighty-first Legislative Assembly adjourns sine die.".
