**PROPOSED AMENDMENTS TO  
SENATE BILL 5514**

1 On page 1 of the printed bill, delete lines 4 through 25 and delete page  
2 2 and insert:

3 **SECTION 1. In addition to and not in lieu of any other appropri-**  
4 **ation, there is appropriated to the Department of Education, for the**  
5 **biennium beginning July 1, 2021, out of the General Fund, the amount**  
6 **of \$8,016,044,524 for the State School Fund.**

7 **SECTION 2. Notwithstanding any other law limiting expenditures,**  
8 **the amount of \$370,466,870 is established for the biennium beginning**  
9 **July 1, 2021, as the maximum limit for payment of expenses from lot-**  
10 **tery moneys allocated from the Administrative Services Economic**  
11 **Development Fund to the Department of Education for the State**  
12 **School Fund.**

13 **SECTION 3. Notwithstanding any other law limiting expenditures,**  
14 **the amount of \$36,599,736 is established for the biennium beginning**  
15 **July 1, 2021, as the maximum limit for payment of expenses by the**  
16 **Department of Education from fees, moneys or other revenues, in-**  
17 **cluding Miscellaneous Receipts, but excluding lottery funds, federal**  
18 **funds and funds described in section 4 of this 2021 Act, collected or**  
19 **received by the department for the State School Fund.**

20 **SECTION 4. Notwithstanding any other law limiting expenditures,**  
21 **the amount of \$676,888,870 is established for the biennium beginning**

1 July 1, 2021, as the maximum limit for payment of expenses by the  
2 Department of Education from fees, moneys or other revenues, in-  
3 cluding Miscellaneous Receipts, but excluding lottery funds and federal  
4 funds, collected or received by the department for the State School  
5 Fund from the Fund for Student Success established under ORS  
6 327.001.

7 **“SECTION 5.** Notwithstanding any other law limiting expenditures,  
8 the amount of \$200,000,000 is established for the biennium beginning  
9 July 1, 2021, as the maximum limit for payment of expenses by the  
10 Department of Education from lottery moneys transferred from the  
11 Education Stability Fund to the State School Fund.

12 **“SECTION 6.** Notwithstanding ORS 327.008 and 327.013, for the  
13 biennium beginning July 1, 2021, the Department of Education:

14 **“(1)** May spend up to \$968,000 from the State School Fund for the  
15 contract described in ORS 329.488.

16 **“(2)** May spend up to \$1,600,000 from the State School Fund for  
17 purposes related to the Oregon Virtual School District.

18 **“(3)** May spend up to \$2,850,375 from the State School Fund to pro-  
19 vide lunches, at no charge to the student, to students who are eligible  
20 for reduced price lunches under the United States Department of  
21 Agriculture’s current Income Eligibility Guidelines.

22 **“SECTION 7.** The amount of \$4,000,000 is transferred from the State  
23 School Fund to the Local Option Equalization Grants Account created  
24 in ORS 327.339.

25 **“SECTION 8.** This 2021 Act being necessary for the immediate  
26 preservation of the public peace, health and safety, an emergency is  
27 declared to exist, and this 2021 Act takes effect July 1, 2021.”.
