**PROPOSED AMENDMENTS TO
HOUSE BILL 2499**

1 On page 1 of the printed bill, line 22, after “possession” insert “from a
2 previous voter registration”.

3 In line 24, delete “or county clerk”.

4 On page 2, line 8, delete “or county clerk”.

5 In line 15, delete “or county clerk”.

6 In line 18, after “Governor” insert “, in collaboration with the Secretary
7 of State,”.

8 In line 33, after “possession” insert “from a previous voter registration”.

9 In line 35, delete “or county clerk”.

10 In line 44, delete “or county clerk”.

11 On page 3, line 7, delete “or county clerk”.

12 Delete lines 10 through 43 and insert:

13 **“SECTION 4. (1) Notwithstanding ORS 314.835 and 314.840, and to**
14 **the degree permitted under federal law, the Department of Revenue**
15 **may disclose taxpayer address information to the Secretary of State**
16 **for the purpose of verifying the accuracy of the addresses of electors**
17 **contained in the centralized voter registration system. In order to**
18 **identify taxpayers whose address information the department may**
19 **disclose under this section, the secretary may provide information**
20 **from the centralized voter registration system to the department. The**
21 **department may not use information provided by the secretary for any**

1 **other purpose except for identifying taxpayer address information for**
2 **electors contained in the centralized voter registration system.**

3 **“(2) If the Secretary of State determines that an address for an**
4 **elector obtained from the Department of Revenue under subsection (1)**
5 **of this section is more current than the address for the elector con-**
6 **tained in the centralized voter registration system, the secretary shall**
7 **provide the information obtained under subsection (1) of this section**
8 **to the county clerk of each affected county.**

9 **“(3) The Secretary of State may adopt rules necessary to implement**
10 **this section.”.**

11 In line 44, delete “7” and insert “5”.

12 On page 4, line 12, delete “to” and insert “by”.

13 In line 15, delete “8” and insert “6”.

14 On page 5, after line 33, insert:

15 **“(10) The Secretary of State shall adopt rules for the treatment of voter**
16 **registrations that do not contain a signature. A ballot may not be counted**
17 **for a registrant in the absence of a signature for voter registration**
18 **purposes.”.**

19 In line 34, delete “9” and insert “7”.

20 On page 6, line 4, delete “10” and insert “8”.

21 In line 21, delete “voting system shall” and insert “voter registration
22 system may”.

23 In line 26, delete “11” and insert “9”.

24 In line 31, delete “12” and insert “10”.

25 On page 7, delete lines 18 through 26 and insert:

26 **“SECTION 11. (1) Sections 2 and 4 of this 2021 Act apply to records**
27 **and signatures in the possession of the Oregon Health Authority and**
28 **the Department of Revenue on or after the effective date of this 2021**
29 **Act.**

30 **“(2) The Secretary of State, Oregon Health Authority and Depart-**

1 **ment of Revenue shall implement sections 2 to 4 of this 2021 Act and**
2 **the amendments to ORS 247.002, 247.012, 247.014, 247.019, 247.171 and**
3 **247.292 by sections 5 to 10 of this 2021 Act no later than January 1, 2023.**

4 **“SECTION 12. This 2021 Act takes effect on the 91st day after the**
5 **date on which the 2021 regular session of the Eighty-first Legislative**
6 **Assembly adjourns sine die.”**
