**PROPOSED AMENDMENTS TO
A-ENGROSSED SENATE BILL 710**

1 On page 19 of the printed A-engrossed bill, delete lines 14 through 38 and
2 insert:

3 **“SECTION 16. Reports first due. The reports under section 7 of this**
4 **2021 Act are due on February 1, 2022, and quarterly thereafter. The**
5 **reports due on February 1, 2022, must include data regarding the**
6 **program’s use of restraint and involuntary seclusion from September**
7 **1, 2021, through December 31, 2021.**

8 **“SECTION 17. Appropriations. (1) Notwithstanding any other law**
9 **limiting expenditures, the limitation on expenditures established by**
10 **section 2 (8), chapter __, Oregon Laws 2021 (Enrolled Senate Bill 5529),**
11 **for the biennium beginning July 1, 2021, as the maximum limit for**
12 **payment of expenses from fees, moneys or other revenues, including**
13 **Miscellaneous Receipts and Medicare receipts and including federal**
14 **funds for indirect cost recovery, Social Security Supplemental Security**
15 **Income recoveries and the Child Care and Development Fund, but ex-**
16 **cluding lottery funds and federal funds not described in section 2,**
17 **chapter __, Oregon Laws 2021 (Enrolled Senate Bill 5529), collected or**
18 **received by the Department of Human Services, for shared services,**
19 **is increased by \$591,746 for the purpose of carrying out the provisions**
20 **of this 2021 Act.**

21 **“(2) Notwithstanding any other law limiting expenditures, the limi-**

1 tation on expenditures established by section 3 (2), chapter __, Oregon
2 Laws 2021 (Enrolled Senate Bill 5529), for the biennium beginning July
3 1, 2021, as the maximum limit for payment of expenses from federal
4 funds, excluding federal funds described in section 2, chapter __,
5 Oregon Laws 2021 (Enrolled Senate Bill 5529), collected or received by
6 the Department of Human Services, for state assessments and
7 enterprise-wide costs, is increased by \$231,981 for the purpose of car-
8 rying out the provisions of this 2021 Act.

9 “(3) Notwithstanding any other law limiting expenditures, the limi-
10 tation on expenditures established by section 2 (2), chapter __, Oregon
11 Laws 2021 (Enrolled Senate Bill 5529), for the biennium beginning July
12 1, 2021, as the maximum limit for payment of expenses from fees,
13 moneys or other revenues, including Miscellaneous Receipts and Med-
14 icare receipts and including federal funds for indirect cost recovery,
15 Social Security Supplemental Security Income recoveries and the
16 Child Care and Development Fund, but excluding lottery funds and
17 federal funds not described in section 2, chapter __, Oregon Laws 2021
18 (Enrolled Senate Bill 5529), collected or received by the Department
19 of Human Services, for state assessments and enterprise-wide costs,
20 is increased by \$1,483 for the purpose of carrying out the provisions
21 of this 2021 Act.

22 “(4) Notwithstanding any other provision of law, the General Fund
23 appropriation made to the Department of Human Services by section
24 1 (2), chapter __, Oregon Laws 2021 (Enrolled Senate Bill 5529), for the
25 biennium beginning July 1, 2021, for state assessments and
26 enterprise-wide costs, is increased by \$440,116, for the purpose of car-
27 rying out the provisions of this 2021 Act.

28 “(5) Notwithstanding any other law limiting expenditures, the limi-
29 tation on expenditures established by section 3 (7), chapter __, Oregon
30 Laws 2021 (Enrolled Senate Bill 5529), for the biennium beginning July

1 1, 2021, as the maximum limit for payment of expenses from federal
2 funds, excluding federal funds described in section 2, chapter __,
3 Oregon Laws 2021 (Enrolled Senate Bill 5529), collected or received by
4 the Department of Human Services, for intellectual/developmental
5 disabilities programs, is increased by \$2,042,807 for the purpose of car-
6 rying out the provisions of this 2021 Act.

7 “(6) Notwithstanding any other provision of law, the General Fund
8 appropriation made to the Department of Human Services by section
9 1 (7), chapter __, Oregon Laws 2021 (Enrolled Senate Bill 5529), for the
10 biennium beginning July 1, 2021, for intellectual/developmental disa-
11 bilities programs, is increased by \$1,047,717, for the purpose of carrying
12 out the provisions of this 2021 Act.

13 **“SECTION 18. Operative dates. (1)(a) The amendments to sections**
14 **3, 5, 7 and 9 of this 2021 Act by sections 4, 6, 8 and 10 of this 2021 Act**
15 **become operative on July 1, 2022.**

16 “(b) The Department of Human Services may adopt rules and take
17 any other action before the operative date specified in paragraph (a)
18 of this subsection that is necessary to enable the department, on or
19 after the operative date specified in paragraph (a) of this subsection,
20 to undertake and exercise all of the duties, functions and powers
21 conferred on the department by the amendments to sections 3, 5, 7 and
22 9 of this 2021 Act by sections 4, 6, 8 and 10 of this 2021 Act.

23 “(2)(a) Section 14 of this 2021 Act and the amendments to ORS
24 418.205 by section 15 of this 2021 Act become operative on January 2,
25 2022.

26 “(b) The department may adopt rules and take any other action
27 before the operative date specified in paragraph (a) of this subsection
28 that is necessary to enable the department, on or after the operative
29 date specified in paragraph (a) of this subsection, to undertake and
30 exercise all of the duties, functions and powers conferred on the de-

1 partment by section 14 of this 2021 Act and the amendments to ORS
2 418.205 by section 15 of this 2021 Act.

3 **“SECTION 19. Captions. The unit and section captions used in this
4 2021 Act are provided only for the convenience of the reader and do
5 not become part of the statutory law of this state or express any leg-
6 islative intent in the enactment of this 2021 Act.**

7 **“SECTION 20. Effective date. This 2021 Act being necessary for the
8 immediate preservation of the public peace, health and safety, an
9 emergency is declared to exist, and this 2021 Act takes effect on Sep-
10 tember 1, 2021.”.**
