**PROPOSED AMENDMENTS TO  
A-ENGROSSED HOUSE BILL 2927**

1 On page 84 of the printed A-engrossed bill, after line 42, insert:

3 **“FISCAL PROVISIONS**

4  
5 **“SECTION 156. Notwithstanding any other provision of law, the**  
6 **General Fund appropriation made to the Oregon Military Department**  
7 **by section 1 (3), chapter \_\_, Oregon Laws 2021 (Enrolled Senate Bill**  
8 **5535), for the biennium beginning July 1, 2021, for emergency man-**  
9 **agement, is increased by \$3,431,834 for preparing the Office of Emer-**  
10 **gency Management as a separate state agency.**

11 **“SECTION 157. Notwithstanding any other provision of law, the**  
12 **General Fund appropriation made to the Oregon Military Department**  
13 **by section 1 (1), chapter \_\_, Oregon Laws 2021 (Enrolled Senate Bill**  
14 **5535), for the biennium beginning July 1, 2021, for administration, is**  
15 **increased by \$1,006,057 for preparing the Office of Emergency Man-**  
16 **agement as a separate state agency.**

17 **“SECTION 158. Notwithstanding any other law limiting expendi-**  
18 **tures, the limitation on expenditures established by section 2 (4),**  
19 **chapter \_\_, Oregon Laws 2021 (Enrolled Senate Bill 5535), for the**  
20 **biennium beginning July 1, 2021, as the maximum limit for payment**  
21 **of expenses from fees, moneys or other revenues, including Miscella-**

1 neous Receipts and reimbursements from federal service agreements,  
2 but excluding lottery funds and federal funds not described in section  
3 2 (4), chapter \_\_, Oregon Laws 2021 (Enrolled Senate Bill 5535), col-  
4 lected or received by the Oregon Military Department, for community  
5 support, is increased by \$5,000,000 for state active duty costs.

6 **“SECTION 159.** In addition to and not in lieu of any other appro-  
7 priation, there is appropriated to the Emergency Board, for the  
8 biennium beginning July 1, 2021, out of the General Fund, the amount  
9 of \$1,807,561, to be allocated to the Department of State Police for  
10 preparing the office of the State Fire Marshal as a separate state  
11 agency.

12 **“SECTION 160.** In addition to and not in lieu of any other appro-  
13 priation, there is appropriated to the Office of the Governor, for the  
14 biennium beginning July 1, 2021, out of the General Fund, the amount  
15 of \$237,161 to support the work of the Oregon Homeland Security  
16 Council.”.
