4 **partment, for the biennium beginning July 1, 2021, out of the General**
5 **Fund, the following amounts, for the following purposes:**

16 **funds and federal funds not described in this section, collected or re-**
17 **ceived by the Oregon Military Department, for the following purposes:**

7 **lected or received by the Oregon Military Department, for the follow-**

15 **General Fund appropriation made to the Oregon Military Department**
16 **by section 1 (4), chapter 534, Oregon Laws 2019, for the biennium end-**
17 **ing June 30, 2021, for community support, is increased by \$358,378 for**
18 **state active duty expenses.**

19 **“SECTION 5. Notwithstanding any other law limiting expenditures,**
20 **the limitation on expenditures established by section 2 (4), chapter 534,**
21 **Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-**
22 **imum limit for payment of expenses from fees, moneys or other reve-**
23 **nues, including Miscellaneous Receipts and reimbursements from**
24 **federal service agreements, but excluding lottery funds and federal**
25 **funds not described in section 2, chapter 534, Oregon Laws 2019, col-**
26 **lected or received by the Oregon Military Department, for community**
27 **support, is increased by \$386,797 for state active duty expenses.**

28 **“SECTION 6. This 2021 Act being necessary for the immediate**
29 **preservation of the public peace, health and safety, an emergency is**
30 **declared to exist, and this 2021 Act takes effect July 1, 2021.”.**
