**PROPOSED AMENDMENTS TO RESOLVE CONFLICTS TO
HOUSE BILL 3398**

1 On page 3 of the printed bill, after line 20, insert:

2 **“SECTION 6a. Section 6 of this 2021 Act (amending section 63,**
3 **chapter 700, Oregon Laws 2019) is repealed and section 63, chapter 700,**
4 **Oregon Laws 2019, as amended by section 1, chapter 30, Oregon Laws**
5 **2021 (Enrolled House Bill 3178), is amended to read:**

6 **“Sec. 63. (1)(a) ORS 657B.070, 657B.080, 657B.110, 657B.130, 657B.150,**
7 **657B.175, 657B.180, 657B.190, 657B.210, 657B.220, 657B.230, 657B.240, 657B.250,**
8 **657B.260, 657B.280, 657B.290, 657B.300, 657B.310, 657B.320, 657B.330, 657B.370,**
9 **657B.390, 657B.410, 657B.440, 657B.460, 657B.470, 657B.900, 657B.910 and**
10 **657B.920 and section 50, chapter 700, Oregon Laws 2019, become operative**
11 **on [January 1, 2022] January 1, 2023.**

12 **“(b) ORS 657B.015, 657B.020, 657B.025, 657B.030, [657B.040,] 657B.050,**
13 **657B.060, 657B.090, 657B.100, 657B.120 and 657B.200 [and section 50, chapter**
14 **700, Oregon Laws 2019,] become operative on [January 1, 2023] September**
15 **3, 2023.**

16 **“[(c) The amendments to ORS 410.619 by sections 52 and 53, chapter 700,**
17 **Oregon Laws 2019, become operative on January 1, 2022.]**

18 **“(c) ORS 657B.040 becomes operative on August 3, 2023.**

19 **“(d) The amendments to ORS 410.619 by sections 52 and 53, chapter**
20 **700, Oregon Laws 2019, and the amendments to ORS 657.471 [and**
21 **659A.162] by [sections 55 and 56] section 55, chapter 700, Oregon Laws 2019,**

1 become operative on January 1, 2023.

2 “(e) **The amendments to ORS 659A.162 by section 56, chapter 700,**
3 **Oregon Laws 2019, become operative on September 3, 2023.**

4 “[e] (f) The amendments to ORS 659A.885 by sections 57 and 58, chapter
5 700, Oregon Laws 2019, become operative January 1, 2025.

6 “(2) The Employment Department and the Department of Revenue may
7 take any action before the operative dates specified in subsection (1) of this
8 section that is necessary to enable the departments to exercise, on and after
9 the operative dates specified in subsection (1) of this section, the duties,
10 functions and powers conferred on the departments by ORS chapter 657B.”
