Re: Support of SB 199 with -2 Amendments

Dear Members of the Committee on Judicial and Ballot Measure 110 Implementation:

As the nation's oldest and largest nonprofit organization working to improve and expand the quality and equity of end-of-life care, Compassion & Choices is committed to empowering individuals to obtain the care they want during a serious illness or at the end of life. One way we achieve that goal is to promote the preparation, completion, and use of advance directives, which provide clinicians information on a patient's treatment decisions. We applaud your leadership in furthering and promoting patient-directed care at the end of life with the introduction of SB 199.

Advance care planning helps ensure future medical treatment conforms with an individual's beliefs and values, mitigates bias to ensure people get the full breadth of care they want, and protects against excessive, unwanted treatment. Unfortunately, we live in a highly fragmented healthcare system, where clinicians providing medical care often have no knowledge or ability to access a patient's advance directive. As a result, clinicians are put into the unfathomable position of having to make life-altering end-of-life care decisions without knowing the patient's preference. SB 199 begins to address these challenges by calling for a standardized form and additional information to provide individuals to assist in their decision making at the end of life.

<u>COVID-19</u>¹ has shined a spotlight on an unfortunate reality that too few people have completed an advance directive. This problem is even more pervasive among communities of color, who face barriers to accessing information about end-of-life care and therefore, are far less likely than their white counterparts to have the necessary tools to talk about end-of-life care and planning, have documented their end-of-life

wishes or enroll in hospice care. By incorporating the advanced directive form with instructions for specific scenarios into code, more Oregonians will have information about what an advanced directive entails and what to consider when drafting an advanced directive, including addressing what to do if they are diagnosed with COVID-19².
