RE: Written comments for HB 2560 (Letter of Support)

Chair Smith Warner, Vice Chair Drazan, Vice Chair Holvey and House Rules Committee members,

AllCare Health would like to express our support for HB 2560.

As a provider owned and led company, AllCare Health has always understood that the majority of an individual's health is made up of non-medical things like one's genetics, social circumstances, environmental exposer, etc. During COVID this became even more evident as we saw underserved members of our communities be disproportionately impacted by the disease and/or the isolation that it brought.

But, as AllCare was working with our communities to address the problems the pandemic created, we started to see more voices in public places interacting because now these meetings were happening online. When our community had public meetings about using the schools as food distribution areas, health equity advocates were there to ensure information was available in multiple languages. As our cities and counties were planning vaccine distributions, people with mobility issues were able to speak during the meetings to ensure that their unique issues were factored into those plans. Even now, during the 2021 session, I am seeing more rural providers lending their voices to the discussion of bills than I can remember in my 15+ years working in the building.

The changes of how these meetings have been conducted during COVID have increased the accessibility of these meetings to many different people. And many of these people are from underserved priority populations. This bill would allow Oregonians with mobility issues, the deaf or hard of hearing community, those who don't speak English as their first language, rural Oregonians, or Oregonians that don't have substantial job or life flexibility, to now can attend these meetings in a more meaningful way. This improves the democratic process and strengthens both the process and the outcomes of law making.

Equally important, this bill ensures that more people's perspectives are included in the policies that impact their lives which, by extension, is their overall health.

To AllCare Health, HB 2560 is really another way to help address health equity in our communities. We hope this committee would move forward HB 2560.
