Chair Williams, Vice Chair Leif, Vice Chair Ruiz, and Members of the Committee,

I am writing to you on behalf of NeighborImpact and the communities in which we work to request your support for HB 2551 related to tax renewal for Individual Development Account (IDA) program.

Since 1985, NeighborImpact has served Central Oregon -Crook, Deschutes and Jefferson counties and the Confederated Tribes of Warm Springs. Our organization is the largest nonprofit in our region on a clients-served basis. NeighborImpact programs support people with chronic needs as well as people who need short-term, temporary help to get back on their feet. Services we provide include assistance to the homeless, homeless prevention, energy assistance, emergency food, childcare provider support and early childhood education through Head Start and Early Head Start. We also provide programming around improving personal financial capability (budgeting and money management) and home ownership counseling and an IDA program that supports personal asset building. The IDA program is without doubt our most popular asset development program and is usually oversubscribed with the equivalent to a five-year waiting list. We distribute funding using a weighted lottery system that considers racial and geographic diversity parameters. The IDA program currently supports opening or expanding a business, purchasing a home or pursuing higher education (as well as other asset-building activities.)

IDAs also supports families and communities facing the financial impacts of COVID. IDAs can both help keep people from falling behind, and position people to stabilize and move forward as recovery begins. IDAs are one of the few existing tools we have to help meet urgent needs and support an equitable recovery from COVID-19 impacts. IDAs are already in place and ready to continue to make a difference in our community.
