I oppose Senate Bill 3, as it will increase the overall cost of health insurance policies for individuals and employers offering health insurance as a benefit to attract employees to their business. Employers will take one of two routes due to health insurance affordability aspect for their employees for small or less than 100 employee companies, either stop offering or make the employees share of health insurance coverage and again may not be affordable for employee individual.
