Many families are in crisis, trying to make difficult decisions, to remain fair to all families, RDAS cannot "hold" mediators for any particular family UNTIL we have a credit card / signed documents in our office.

3.) Positive Love, Encouragement & Support

Please do not include any information regarding timelines or futures plans. We are want your child to be focused on 'today' and the task at hand, rather than what will happen down the road.

- What and how to pack? Most programs will provide you with a list of items your child will need upon arrival. We request that you put these necessary items into a backpack or shoulder bag. Your child will carry this bag. We try to avoid the need to check luggage at the airport. The following items should be placed into a large zip-lock bag: all medications, important documents, and your letter. Please hand this zip-lock bag to our staff. RDAS will carry these items.
- How should I start the intervention process with my child? After you have met our staff and have asked any new questions, we ask that you walk us into the room (usually the bedroom). You will turn on the lights and introduce our staff by name, describe them as "our friends who will take good care of you." Tell your child that you have invited them here to explain the difficult decisions you've made. Briefly express love and concern for your child and leave the room. Please do not react or respond to accusatory remarks. You must remain calm and confident. You may respond to information gathering questions as long as your child remains calm. It is important to convey that these people are not strangers, that you have invited them into your house and most importantly that you are doing this out of love. At any point during this intervention, if your child begins to get angry or upset, our Transition Mediators may say something like 'thanks mom & dad we will explain the rest from here' that is your cue to leave the room. We suggest you leave the house entirely, perhaps going for a short car ride, or remove yourself to an unseen, unheard portion of the house. It is of utmost importance that once you leave the room, you are not seen or heard. This will help stabilize what may be a tense situation. Simply put, if a child does not have an audience, especially with his/her parents, they will be less likely to act out verbally or physically. However, if you have other children in the house, we suggest you go into their bedrooms in case they wake and become concerned or try to intervene.
- What if I have other children or dogs in the house? If you have other children in the house, we recommend that after you introduce our staff and leave the room, you go into your other child's room and sit with them. We do not want them to wake, hearing voices and become scared. We also do not want them to get involved. If possible, we ask that you put any dogs in a secure room where they will not interrupt the process and so they will not prematurely wake your child before the formal introduction.
- What if my child is not home when RDAS staff arrives? We will work with you and create a safe plan for the pick-up of your child. However, at times things may not go according to this plan. We will always have a plan "B" that will go into effect at that time. That plan is usually to obtain a list of friends and/or places where they may be. We

Please understand these documents are based on present prices of airline tickets. If any factors change so will the price of the estimate. If you secure the transport immediately with your credit card we can lock in airline prices and available mediators. Otherwise, the estimate price can vary. It is also important to understand that the total amount invoiced can be different than the estimate if there are additional costs not realized. Some increases in cost are due to weather delays, flight delays, changes in itinerary, etc.

Please note that in situations where there is joint custody we will need the signature of BOTH parents.

Please understand that 70% of the estimate will be charged on your credit card as the retainer fee. After the transport the retainer fee will be applied to your balance and you will be invoiced for the remaining balance unless you choose to charge the entire balance. You must pay the total invoice within 30 days of the invoice date or you will be charged a 12% interest charge and the remaining balance will be charged to your credit card.

The anticipation of the transport and second-guessing your decision is usually the worst part of this process. Most parents are amazed and relieved with how smoothly the pick-up goes. Please feel free to contact our parents on our reference list.

~ May I write a letter to my child?

We strongly recommend that you write a letter to your child. The morning introduction / intervention may be very emotional and you may not get the opportunity to say everything you want to. This letter gives you the opportunity to express your love and your concerns to your child. If you wish to send a couple photographs, we ask that you place the photos in a separate envelope. Please give the letter to our staff upon arrival. The Transition Mediator will present the letter to your child at an opportune time during transition, but we cannot guarantee that the letter will be read.

We recommend the letter contain the following 3 components:

1.) Introduce your concerns about your child's behavior/choices.

How will I know when my child arrives at their program? We will stay in contact with you throughout the trip and after we have arrived. As our primary attention is on your child we ask that in-depth questions be saved until after your child has arrived. At anytime you can call the following numbers if you have questions or if you want to check on the progress of the transport.

Secure Funds Transfer

We, Bend, Oregon, 94702 have agreed to pay Right Direction Adolescent Services an estimated fee in the amount of \$2,382.50, plus the additional amount of \$516.00 for airfare costs, for intervention with and/or transport of Bend, Oregon to Second Nature in Duchesne, Utah on June 06,2006. We Understand that this is an estimate based on reasonable circumstances and that unexpected delays may occur. These delays may affect the final total cost of the transport. We are also aware that Right Direction Adolescent Services will charge 70% of that total amount on the credit card listed below as a retainer fee at this time. We do agree to pay for all airline tickets separately.

We are aware that Right Direction Adolescent Services' fees are based on an hourly rate of \$65 per hour for the primary Transition Mediator and \$55 per hour for the secondary Transition Mediator, beginning at the time the Transition Mediators depart the Right Direction Adolescent Services office and ending upon their return. The fees may also include mileage at \$0.50 per mile as well as any customary business expenses. Right Direction Adolescent Services' fees do not include airline costs, which are charged directly to the credit card listed below. We declare that We have given Right Direction Adolescent Services a total authorization amount of \$3,107.50, for services rendered in the intervention with and/or transport of to Second Nature. The authorization is for any unforescent expenses, flight delays, weather delays or circumstances beyond Right Direction Adolescent Services control. Right Direction Adolescent Services will not exceed the authorized amount unless approved by us. All reasonable fees and costs incurred by Right Direction Adolescent Services shall be paid by the undersigned, and that any and all legal matters in regards to our dealings with Right Direction Adolescent Services will be handled in the jurisdiction of Salt Lake County, Utah.

We are aware that in the event of cancellation We will be charged a fee for administrative time at \$100.00, plus any non-refundable purchases such as airline tickets, hotels, rental cars. We authorize Right Direction Adolescent Services management to utilize the credit card listed below (Visa and Mastercard only):

We understand that We will receive an invoice approximately one week after the transport is completed. Upon arrival of the invoice, We agree to provide payment for services rendered by Right Direction Adolescent Services in the following marked method:

Authorization to utilize the credit card (Visa or Mastercard only) listed below for the total balance due.

If no method of payment is selected Right Direction Adolescent Services will use the credit card listed below to charge 100% of the invoice due.

An additional 2.5% processing fee will be assessed for all credit card payments.

In order for services to be rendered, Right Direction Adolescent Services requires that a Visa/ Mastercard be provided below. This credit card will be used to purchase any and all airline tickets, process any cancellation fees, and charge 70% of the estimate at the time of hire. If full payment is not received within 30 days from the invoice date and prior arrangements have not been made, We authorize Right Direction Adolescent Services to use the listed credit card for payment for services rendered under this agreement. Bend, Oregon, 97702, declare we are the parents, with full legal custody over a minor, 13 years and 0 months old, whose date of birth is we declare that we have authorized Transition Mediators of Right Direction Adolescent Services to exercise all control over and that we, as her parents would exercise to safely transport her, as we believe she may be a danger to herself or others.

In the event medical treatment is necessary, we authorize the Transition Mediators of Right Direction Adolescent Services to act on our behalf.

This Declaration of Authority also gives authority to Right Direction Adolescent Services to locate and safely in the event she attempts to run away.

This Declaration of Authority is granted for a period of one month and shall become effective on June 05, 2006, and shall terminate on July 05, 2006.

We, the parents, shall hold Right Direction Adolescent Services and its Transition Mediators harmless and shall indemnify Right Direction Adolescent Services and its Transition Mediators for any liability, loss, actions, costs, expenses or damages incurred by virtue of the minor's actions while in their care and custody.

In exercising our rights as parent(s) under the First Amendment of the Constitution, and under, the ruling and subsequent interpretations of the Parham v. J.R. (1977) 442 U.S. 584 case. We believe our actions and those we employ to achieve this goal are in the best interest of our daughter. The Parham court held that: "Simply because the decision of a parent is not agreeable to a child or because it involves risks does not automatically transfer the power to make decisions from the parents to some agency or officer of the state...Most children, even in adolescence, simply are not able to make sound judgments concerning many decisions, including their need for medical care or treatment. Parents can and must make those judgments.
