My name is Pete Lee and I have been a volunteer EMT in Oregon for almost 20 years. I have also served on non-profit boards whose mission included serving those who struggle with managing drug addiction. **I support SB 755.**

I have taken time to read some testimony already submitted by a broad and cross-sectional coalition of truly wonderful organizations: out of respect for your time, I will endeavor to avoid duplicative commentary.

I would like to concisely highlight two areas of special concern to me:

- 1. As a volunteer EMT, I have personally witnessed the desperate need for bold and compassionate solutions to support those struggling with drug addiction: fellow human beings. Not a single group of people exists that has been left unscathed: it is an issue that crosscuts social, cultural, economic, and political differences. Frontier, rural, and urban Oregonians deserve effective systems of care and support to give them every chance to participate in our shared social, cultural, economic and civic life.
- 2. Veterans who struggle with drug addiction as an attempt to find respite from physical, behavioral, and/or mental illnesses deserve real care and support. It is a moral and patriotic imperative—as Oregonians and Americans—that We Serve Those Who Serve Us. This is self-evident.

I continue to hope and pray for the safety of every elected official in our Oregon Legislature and the constituencies you serve. Thank you for the opportunity to provide this testimony, as well as the gift of your time for consideration.
