If Governor Kate Brown has issued emergency order

#20-04 that now has potentially given full authority to The Board of Forestry under ORS 526.016, for implementation of establishing a forest and climate change carbon plan, under the Forest Practice Act, I urge the committee to completely reject -3 amendment. Appointments to this board from any governing body are a gross conflict of interest. This is not a balanced approach.

As stated, Goal One of planning in Oregon is citizen involvement. There is no citizen involvement, accountability or transparency with appointments to this land/forest board, which essentially will affect every facet of our lives, including the livelihoods of all working families and all Oregon forest statewide.

Furthermore, there is bipartisan support stating catastrophic wildfires are due to poor forest mismanagement. Even Governor Brown herself said the same. I have sited and included, quotes from Senator Ron Wyden and Senator Fred Girod as well.

I am also including an article or two from Nature magazine about harvesting timber. One states the following. Oregon Sen. Fred Girod, R-Stayton, told the Oregon Board of Forestry to remember the value of the timber industry and the communities surrounding state forests as they're finalizing post-wildfire logging plans. "Timber money is extremely important to these communities," he said. "I can't stress that enough."

Girod said he blames poor forest management for the wildfire that burned down his house and believes more logging is needed to guard against future wildfires.

"To say I'm a little bit upset about it is an understatement," he said. "And the board is considering all these different small factors. But the one you're leaving out is the people that had their homes destroyed and what they think. They want to make it so it's safe from fire"
