**Re: I Oppose [HB 2778] ...[HB 2655]...[HB 2705]...Strike one, Strike two, Strike three...you're out!**

Unfortunately, it is getting harder to say kind words to legislators that create legislation, if entered into law, will destroy rural Oregon for all time.

**[HB 2778]:** How did you arrive at a house built before 1974 is "Historic?" Why not 1975 or 1976-our Nation's Bicentennial Birthday? This accursed piece of legislation will open up thousands of these properties for renters and or vacationers.

The "New Home" will take up more precious, irreplaceable farm land.

Any "House" requires periodic maintenance. A "Historic House" is subject to a myriad of regulations as to repair and functionality. "Historic Houses" are very costly to maintain with reference to the "Historic" permitting requirements and ancillary costs.
