sentence.

That would make my daughter 16 when I got out instead of 18. I would be able to be out to be with her for her last 2 years of school. I would do anything to be able to help my children with school. My son would be 10 instead of 11. I just want to break this cycle and come home to my children and be a father as soon as possible. Please, please, will you vote for VS to get retro-active good time on Measure 11. My mom has cancer right now and that is my best friend. She is raising my children. Being out as soon as possible would benefit my whole family. Please vote for SB 191. I appreciate you for your time.
