Re: I OPPOSE [SB 778-1]...Oregon is going to have a budget shortfall and you want to spend more money you do not have. The Legislature are losers all the way 'round. [SB 778-1] is triple-distilled, Bull-Manure politics.

The construct of [SB 778-1] has flawed conditions. Each flawed condition is a "Kiss-of-Death (KOD)" issue.

Are the necessary budgetary re-apportionments governed by [HB 2102] going to be satisfactorily on time?

4th KOD issue: "SECTION 2. There is appropriated to the Office of Immigrant and Refugee Advancement for the biennium employees and carrying out the provisions of section 1 of this 2021 Act."

Anv "fill in the bloods" are plenning to the provisions of section 2 of this 2021 Act."

The (-1 Amendment) of, "...out of the General Fund... the amount of \$1,000,000..." to initiate the Office of Immigration and Refugee Advancement-Wow, a double KOD.

5th KOD issue: "...(e) Ensure that any racial and ethnic impact statements for legislation accurately include the impact to immigrants and refugees in this state who are individuals who are Black, indigenous or other people of color;..."
