I have one thing to add, as a citizen, speaking for myself. I have never understood how large contribution limits bears any resemblance to our democratic ideal of equality.

I, as an individual am limited, by circumstances alone, as just one example in my ability to contribute but – no 2nd option for me. 1 person = 1 contribution ... seems balanced, makes sense.

One citizen = 1 vote Balance

We would not be discussing this if no one thought contributions were an essential element of the election process, which is why I am so concerned about maintaining a healthy balance. Equal representation is a fair representation, whether it be dollars or votes. Yes, it is more complicated than that, but nonetheless true.

Whatever limits you set will likely be out of reach for many Oregonians, perhaps even most, so the balance already has shifted in a direction that strays from the concept of equality, if it is held to a standard of 1 person = 1 donation. The shift does not end there.

It is not enough for people of means to be able to donate more than their less fortunate, counterparts, but they can also create a non-human entity, whether it be a corporation or a pac or whatever is allowed. This provides the person's who control that entity an entitlement of a 2nd ability to contribute, thus widening the equality gap.
